The regular meeting of the Saline County Board of Equalization opened with the Pledge of Allegiance. The meeting was called to order at 9:16 a.m. on Tuesday, February 16, 2021, by Chairperson Russ Karpisek. Present were Karpisek, Philip Hardenburger, Marvin A. Kohout, Janet J. Henning and Stephanie A. Krivohlavek Commissioners, County Clerk Anita K. Bartels, and Administrative Assistant Tim McDermott.

Notice of said meeting was posted in the County Clerk's office, on the Saline County Website, and published in all three county newspapers prior to the meeting, in compliance with State Statutes.

Let the record show that all proceedings are electronically recorded.

Karpisek advised those present of the open meetings act posted at the back of the room.

Henning moved to approve the agenda as presented, seconded by Hardenburger. Voting aye were Karpisek, Kohout, Krivohlavek, Hardenburger and Henning, nays none, motion carried.

County Assessor Brandi Kelley presented an overview of the 2021-2022 Assessment Project to identify CRP acres in the County. Letters were sent in November notifying landowners of this project.

Henning moved to open the public hearing for a vehicle tax exemption, seconded by Hardenburger. Voting aye were Krivohlavek, Hardenburger, Henning, Karpisek and Kohout, nays none, motion carried.

County Treasurer Deb Spanyers presented a vehicle tax exemption application from Crete Area Medical Center, for a 2013 Ford Explorer, stating this was a renewal application and this vehicle is used by paramedics for emergency medical response and care.

Henning moved to close the public hearing for a vehicle tax exemption, seconded by Hardenburger. Voting aye were Krivohlavek, Hardenburger, Henning, Karpisek, nays none, Kohout was absent from voting, motion carried.

Krivohlavek moved to approve the vehicle tax exemption application from Crete Area Medical Center for a 2013 Ford Explorer, seconded by Hardenburger. Voting aye were Kohout, Hardenburger, Krivohlavek, Karpisek and Henning, nays none, motion carried.
