PK-5 traditional learners will attend Monday - Friday. No change to their schedule.


Monday - Thursday- traditional/in-person learning for 6-12 students.. Friday - remote learning for all 6-12 students only.

How does this help with virus??

This is a good idea. It allows the teachers the time they need to do their job well. It gives traditional students a better recharge each weekend, meaning that instead of two days, they have three days to regroup and the surfaces at school have time to either be disinfected well or for the bacteria to die before Monday.

This would be really hard for working parents.

The problem is the 10-14 day incubation period of this novel corona virus, which means those that receive a positive test today have already went almost two weeks spreading the virus. And even though you're doing tracing in schools it doesn't account for the fact that small schools in our district are made up of siblings, families and friends who all attend functions outside of school together. If you're waiting on money from the state over the health of our children let us know so that we can make a better informed decision on how to take of our children. Students that have chosen to attend in person should be allowed to continue a five day schedule due to it cuts back on their learning opportunity (vocational, etc). We don't have access to the internet because I cannot afford it on my limited income so it would be difficult for him to do the remote day. If our only local internet provider would offer free internet during this pandemic, other children would have the same opportunities as others to access their classes online.

They would still be in close contact with other children Monday through Thursday, this would make no difference in trace contact

Maybe take a couple extra days off ("snow days") to do a deep cleaning of the school around the Labor Day Holiday.

If this is being done in an effort to continue allowing the students TO GO TO SCHOOL, I am in support of a hybrid schedule. They need to be IN school. They need socialization, in person instruction and the ability to participate in their extra curricular activities. It seems honestly as if the decision has already been made for us to transition to virtual learning.

I feel we should modify schedule to slow the spread of Covid 19. It is spreading even more rapidly since start of school. Please put our children and staffs concerns first.

I think all grades should be modified

I believe this will be helpful in providing alternative type of education.

I think this will give the remote learners a better opportunity to get assistance. I chose not to do remote learning with my child as I was afraid he would not have opportunity for assistance as needed.

My suggestion would be rotate days of the week. Less kids at school at one time.

How much work and how are they going to receive it on Friday?

Like many other school districts in the east Tn area and nation, all students and teachers should be required to wear masks in school until an effective vaccine is widely disseminated.

IF this is an option I think it should be K-12. Do you know how hard it will be for parents that have multiple children in different grade levels? OR there should be an option to remote learn 1 day a week (Friday) for K-5. I do not think it is fair for the board to propose I remote teach my child when I have chosen traditional class for my 8th grader but not allow me to choose that option for my 4th grader. For my decision, it was all remote or nothing, now I may be "forced" to remote teach but just one day a week. I understand that teachers have a difficult time and I appreciate them but I will not be happy with this decision.

In person school

I would be ok with them at home on a Friday. However, I have concerns that my children would not do their task without parental supervision. Me and my husband both work and would not be able to modify our schedule to be home on Fridays. Would ouch be provided for the kids on Friday's by bus route?

If your gonna go 4 days one more want hurt. Kids should have to wear masks. Teachers and security should be wearing masks and getting their temperature taken before entering. That's not always happening. People and parents are walking up to the front without masks and some walking in. There is also a lot of residence me included don't have access to high speed or internet service. One teacher made the comment the students could sit out in the parking lot and use the schools WiFi. In 90 deg weather that wouldn't work. I think taking a two week would be better than 4 at school and 1 distance learning. No internet service in a lot of this Rural area it's asking too much.

If you are going modified then break it down 2 or 3 days remote or 2 - 3 days in school Friday remote is just like saying you got a 3 day weekend every week. If you choose one day choose Wednesday.

One day a week off only hinders the children's education. It wouldn't protect anyone. We are trying to create successful members of society and typically adults have to work 5 days out of the week, even during the Covid 19 Pandemic. They are already having to miss school for covid 19 tests for cold and missing school. Perhaps modify the attendance policy to accommodate sick children to have time to recover at home for things such as cold, sinus infections and stomach bugs- things that don't necessarily need a doctor diagnosis but don't always have symptoms of a cold. Thank you for serving our kids and whatever is chosen we will work with without negativity but please remember a lot of parents are working outside of the home. Sometimes leaving unattended teens can lead to more issues such as mental health concerns because they need social interaction.

As a teacher I know the remote learning is a lot extra added to the teachers plate and since K-5 now will all have some relief, I think this would be a good solution to help 6-12 teachers. We all know there isn't funding or resources to have a remote learning teacher for every grade but we appreciate all the help we can get!

My only concern with this is for parents of both k-5 and 6-12 children it may be hard for my third grader to understand why she has to go to school when her sister doesn't

I think its a horrible idea not everyone can stay home, and not everyone has internet services at their homes. The kids should be in school all week, there is no need to do remote learning for 2 schools.

I think this is a good idea. It gives the custodians a larger time frame to deep clean the schools.

As a parent, my child values her education and thus decided to return to school in person. She wants to be in school and learning face to face. By shuffling busy work in front of her on Friday's, no real learning will be accomplished on those days. Is her decision to return to school and participate in class less important than the visual learners? I fully understand the stress that teachers are under to do the best that they can for all learners. I realize the demands and time constraints that exist for these teachers but I fail to see how this will solve the current situation. This will put even more on the plate for the teachers, not less.

From a teacher's standpoint, I am deftly opposed to doing this as it takes my students out of my class for some 30 hours of instructional time. That time will be lost. It is already a struggle to adequately prepare them for their End of Course Tests which they typically take a month before the end of the course.

Students need to be in school and teachers need to be in front of them providing instruction. This will simply add further requirements to already stressed and overworked teachers for the following reasons: Additional lesson prep for Friday for all learners being virtual, with some being at different levels of instruction, extra grading that will be expected for the Friday assignments, potential for addition flash drive learners. Just to name a few.

Things that could aid teachers in handling the additional responsibilities that come with remote learning would be: 1. Separate remote learners in Power School (I spend a lot of time clicking and un-clicking button for which student which assignments apply), 2. Provide better technology to help make recording lessons easier (i.e. microphones, webcams, etc) 3 Training- some teachers are not very tech-savvy; give them in-depth training on technology available not just a rushed 3 hour slide presentation but true in person one on one training. 4 Guidance- Explain to teachers what the expectations are, not a list of you could do this or you could do that now go find something you like and figure out how to make it work.

I think if you want to modify schedule

They could go Monday Wednesday and Friday and do online Tuesday/Thursday

Over all I feel that the students would be losing instructional time. However, if the teachers need that time to accommodate to the online learners, I would rather my child work from home than be at school while teachers are working with online students

My three children are in the 8th grade at Oakdale. They are full time remote learners. The problem we are having is the work is sent to them most of the time without any teacher instruction. I would like to see the teacher do at least a short instructional video that accompanies the assigned work so they can have a better understanding of how to do the lesson. If the teacher could stream part of the class or do a video of the class, it would be helpful. Also the school issued chromebook knocks them off the internet (we have Highland internet) within a few minutes of logging on to their work or before they can get their work done. They are having to use the chromebooks I purchased for them.

If your going to give kids homework on Thursday on a USB drive due to them not having internet then all classroom work should be on it. They should not put stuff on Google classroom that's different then what's on the drive. Because what if the kid can not get on Google classroom.

WHEREAS, Coronavirus Disease 2019 (COVID-19) is a global pandemic that can lead to serious illness or death and spreads through close contact among individuals; and

WHEREAS, beginning on March 12, 2020, Governor Bill Lee declared Tennessee to be in a state of emergency until June 30, 2020, pursuant to Executive Orders 14 and 36, due to COVID-19; and

WHEREAS, beginning on March 16, 2020, Tennessee schools were closed for the remainder of the 2019-2020 school year, in response to requests made by Governor Bill Lee that they close to combat the spread of COVID-19; and

WHEREAS, on March 18, 2020, the Tennessee General Assembly approved the cancellation of state standardized testing for the 2019-2020 school year, due to the statewide closure of schools and subsequent lack of standardized instruction being delivered to students; and

WHEREAS, on June 22, 2020, the Tennessee State Board of Education approved Emergency Rule 0520-01-17-.01, which requires Tennessee school districts to provide students in grades one (1) through twelve (12) access to six and one half (6 1/2) hours of instructional time each school day during the 2020-2021 school year, even if there are school closures or disruptions related to outbreaks of COVID-19; and

WHEREAS, by Executive Order 50 signed by Governor Bill Lee on June 29, 2020, the state of Tennessee is to remain in a state of emergency until at least August 29, 2020 and COVID-19 continues to spread at a rapid rate in Tennessee; and

WHEREAS, Tennessee schools, in order to comply with State Board requirements, will likely have to engage in remote learning, in whole or in part, during the 2020-2021 academic school year due to the continued spread of COVID-19; and

WHEREAS, pursuant to State Board Emergency Rule 0520-01-17-.01, Tennessee school districts are required to each create and implement their own plans to facilitate continuous learning in light of the continued spread of COVID-19; and

WHEREAS, Tennessee school districts will be implementing different plans for learning from county to county across the state for the 2020-2021, based upon the needs of their students and COVID-19 outbreaks in each county; and

WHEREAS, Tennessee students will likely face significant academic and behavioral regression upon returning to school, having lost approximately two (2) months of standard instruction and attendance due to the extended closure; and

WHEREAS, when schools resume in August 2020, students will have spent approximately five (5) consecutive months out of school; and

WHEREAS, Tennessee school districts will be focused not only on student growth and safety, but also on recoument of academic and social and emotional skills lost during the extended closure.

NOW, THEREFORE, be it resolved unanimously by all of the Board Members on the 1st day of September 2020 that the Morgan County Schools District:

Supports and respectfully requests a moratorium on state standardized testing and accountability associated with such testing for the 2020-2021 school year, to include end-of-year examinations and formative assessments throughout the year. 24 who is incapable of self-care because of a mental or physical disability; or
- 25
- 26 6. is experiencing any other substantially similar condition specified by the Secretary of Health
27 and Human Services, in consultation with the Secretaries of Labor and Treasury.

28 This paid leave may be taken if there is work available for the employee to complete and the employee
29 is unable to work or telework for one of the above reasons. Such leave is in addition to any paid leave
30 that an employee may already be entitled to (e.g. existing sick leave). Employees are not required to
31 exhaust any other paid leave benefit in order to utilize this new category of paid sick leave.

32 **EXPANDED FMLA LEAVE**

1 Full-time or part-time employees who have been on the payroll for thirty (30) calendar days prior to the
 2 beginning of the leave are eligible for expanded FMLA leave (EFMLEA). This includes employees who
 3 were laid off or terminated after March 1, 2020, who had worked for the district for at least thirty (30)
 4 of the prior sixty (60) calendar days and were subsequently rehired or otherwise employed by the
 5 district.³

6 Under the FFCRA, an employee qualifies for EFMLEA leave if the employee is unable to work or
 7 telework due to the need to care for his/her son or daughter because of a school or child care facility
 8 closure or because the person who regularly provides child care (i.e. this could include a family member
 9 or a neighbor) is unavailable for reasons related to COVID-19.⁴ In these circumstances, a son or daughter
 10 is defined as a biological, adopted, or foster child, a stepchild, a legal ward, or a child of a person standing
 11 *in loco parentis*, who is under 18 years of age; or 18 years of age or older who is incapable of self-care
 12 because of a mental or physical disability.

13 Qualifying employees may take twelve (12) weeks of EFMLEA leave.⁵ The amount of leave available
 14 may be impacted by any prior use of FMLA.⁶

15 The first ten (10) days of EFMLEA leave shall be unpaid, however, an employee may choose to take
 16 any existing leave benefit during this time. After ten (10) days, EFMLEA leave is paid at two-thirds
 17 (2/3) the rate of the employee's regular rate of pay, unless he/she chooses to utilize accrued sick leave
 18 or annual leave to cover those days or the amount is capped per federal law.⁷
