1 If a student repeatedly or substantially interferes with the
2 learning environment, the teacher may submit a written request to
3 the principal/designee to remove the student from the teacher's
4 classroom. The written request shall include the following
5 documentation to demonstrate that the teacher has previously:

- 6 1. Taken action to address the student's disruptive behavior;
- 7
- 8 2. Provided consequences for the student's disruptive behavior;
- 9
- 10 3. Conducted an oral conference, either by a documented telephone conversation or an in-person
11 discussion, with the student's parent/guardian regarding the student's disruptive behavior;
- 12
- 13 4. Provided an opportunity for school counseling or other support services deemed appropriate to
14 address the student's disruptive behavior;
- 15
- 16 5. Developed and implemented a plan to improve the student's behavior in a conference with the
17 student; and
- 18
- 19 6. Issued a disciplinary referral to the principal to address the student's disruptive behavior.

1 *General*

2 The Board shall provide for a system-wide testing program which shall be periodically reviewed and
3 evaluated. The purposes of the program shall be to:

- 4 1. Assist in promoting accountability;
- 5
- 6 2. Determine the progress of students;
- 7
- 8 3. Assess the effectiveness of the instructional program and student learning;
- 9
- 10 4. Aid in counseling and guiding students in planning future education and other endeavors;
- 11
- 12 5. Analyze the improvements needed in each instructional area;
- 13
- 14 6. Assist in the screening of students with learning difficulties;¹
- 15
- 16 7. Assist in placing students in remedial programs;
- 17
- 18 8. Provide information for college entrance and placement; and
- 19
- 20 9. Assist in educational research by providing data.²

21 The Director of Schools shall be responsible for planning and implementing the program which includes:

- 22 1. Determining specific purposes for each test;
- 23
- 24 2. Selecting the appropriate test to be given;
- 25
- 26 3. Establishing procedures for administering the tests;
- 27
- 28 4. Making provisions for interpreting and disseminating the results;
- 29
- 30 5. Maintaining testing information in a consistent and confidential manner; and
- 31
- 32 6. Ensuring that results are obtained as quickly as possible, especially when placement in a special
33 learning program might be necessary.

1 State-mandated student testing programs shall be undertaken in accordance with guidelines published
2 by the State Department of Education.³

3 **WEIGHTING TCAP SCORES**

4 TNReady⁴ and EOC⁵ scores shall be included in students' final grades as follows:

- 5 1. Grades 3-5 – 10%
- 6 2. Grades 6-8 – 10 %
- 7 3. Grades 9-12 – 15%

8 The MORGAN COUNTY School System shall use the following methodology: [**cube**
9 **root methodology.**]

10 The Director of Schools may exclude these scores from students' final grades if results are not received
11 by the district at least five (5) instructional days before the end of the course.^{4,5}

12 **INTEREST INVENTORIES AND CAREER ASSESSMENTS⁶**

13 Interest inventories shall be made available to middle schoolers. These will include assessments such as
14 the Kuder assessment, Myers-Briggs Type Indicator, the ASVAB, or the College Board Career Finder.

15 Career aptitude assessments shall be administered to 8th graders in order to inform the student's high
16 school plan of study. Upon receiving the results from these assessments, the school shall provide students
17 with information on any available career and technical education opportunities in which the student is
18 eligible to participate in.

19 **TESTING INFORMATION AND PARENTAL CONSENT**

20 Any test directly concerned with measuring student ability or achievement through individual or group
21 psychological or socio-metric tests shall not be administered by or with the knowledge of any employee
22 of the district without first obtaining written consent of the parent(s)/guardian(s).²

23 Results of all group tests shall be recorded on students' permanent records and shall be made available
24 to appropriate personnel in accordance with established board policies.⁷

25 No later than July 31st of each year, the Board shall publish on its website information related to state
26 and board mandated tests that will be administered during the school year. The information shall
27 include:⁸

- 28 1. The name of the test;
- 29
- 30 2. The purpose and use of the test;
- 31
- 32 3. The grade or class in which the test will be administered;
- 33

- 1 4. The tentative date or dates that the test will be administered;
2
3 5. The time and manner in which parent(s)/guardian(s) and students will be notified of the results
4 of the test;
5
6 6. How parent(s)/guardian(s) can access the questions and answers on their student’s state-
7 required tests; and
8
9 7. If a board mandated test, how the test complements and enhances student instruction and
10 learning and how it serves a purpose distinct from state-required tests.
- 11 Testing information shall also be placed in student handbooks or other school publications that are
12 provided to parent(s)/guardian(s) on an annual basis.

1 *General*

2 A student shall not engage in conduct which causes the disruption or interference with the operation of
 3 the school while on school property, in school vehicles or buses, or at school-sponsored events,
 4 whether on or off campus. The student shall not urge other students to engage in such conduct.

5 Employees are authorized to take reasonable measures to establish appropriate school behavior and
 6 have the authority to control the conduct of any student while under the supervision of the school
 7 district.¹

8 A student may receive disciplinary action ranging from verbal reprimand to suspension and/or expulsion
 9 depending on the severity of the offense and the student’s prior record.²

10 **REMOVAL OF STUDENT³**

11 If a student repeatedly or substantially interferes with the learning environment, the teacher may
 12 submit a written request along with the required documentation to the principal/designee to remove the
 13 student from the teacher’s classroom. The student will be given notice of the rationale for the request
 14 as well as the opportunity to offer an explanation.

15 The principal/designee will investigate the request and make a decision regarding the student’s
 16 placement. The principal will notify the teacher as to his/her decision.

17 If a teacher abuses or overuses the student removal process, the principal/designee shall address the
 18 abuse or overuse with the teacher and may require the teacher to complete additional professional
 19 development to improve the teacher’s classroom management skills.

20 *Appeal Process*

21 If the teacher’s request for removal is denied, he/she may file an appeal with the Director of
 22 Schools/designee. He/she will review the teacher’s request for removal as well as the decision of the
 23 principal/designee and make a determination as to the student’s placement.

1 All full time personnel (30 hours or more per week) shall receive longevity pay as specified below:

- 2 • Longevity pay is based on the full time experience accumulated as per the previous year.
- 3
- 4 • A full time employee is considered any support employee that works more than 30 hours
- 5 per week or is considered a full time bus driver.
- 6
- 7 • All full time personnel shall receive one hundred (\$100) per year of service up to (20)
- 8 years.
- 9
- 10 • Support personnel must have been employed six (6) months, full time in a school year or
- 11 fiscal year to accumulate one (1) year of service for longevity pay purposes.
- 12
- 13 • If the employees work status changes from full time to part time (working less than 30
- 14 hours per week regularly), the employee will not be eligible for longevity the next year.
- 15
- 16 • A school year is defined as the time period beginning with the opening of school to the last
- 17 day of school as approved in Morgan County School Calendar for that year.
- 18
- 19 • A fiscal year is defined as the period beginning July 1st through June 30th of each year.
- 20
- 21 • Longevity pay or a year of experience pay is paid for one (1) support personnel position
- 22 only.
- 23
- 24 • If an employee transfers from one position to another position, longevity experience
- 25 transfer.
- 26
- 27 • All support personnel shall receive a check for the full amount due once each year in
- 28 November.
- 29
- 30 • If any support personnel quits or resigns their position, they have one year (365 days) to
- 31 return to employment and retain their accumulated longevity experience. After, one year
- 32 (365 days) they shall lose all longevity experience.
- 33
- If any support personnel is terminated from employment, they shall immediately lose all accumulated longevity experience.

1 *General*

2 The following guidelines shall be followed:¹

- 3 1. Fundraising activities shall be authorized by the Board and shall be for the purpose of
4 supplementing funds for established school programs and not for replacing funds which are the
5 responsibility of the Board.
- 6 2. Fundraising companies and other salespersons shall obtain permission in writing from the
7 Director of Schools' office in order to visit the schools.
- 8 3. Any commission payable by companies shall be paid in the form of reduced prices to the students
9 or paid into the activity fund of the school for use by the school. No school employee shall
10 personally benefit from any fundraising activity.
- 11 4. The principal shall obtain written approval from the Director of Schools/designee for all
12 fundraising activities, including online fundraising activities, that involve the participation of the
13 general student population in the marketing process of the fundraising effort. All other
14 fundraising activities, including online fundraising activities, shall have written approval from
15 the principal and comply with all administrative procedures issued by the Director of Schools.
16 The authorization request shall contain the following information:²
- 17 a. A list of the proposed fundraising activities;
- 18 b. Purpose of the fundraising activity;
- 19 c. Proposed uses of funds raised;
- 20 d. Expected student involvement in fundraising activity (school-wide, individual class, or
21 club); and
- 22 e. Margin of profit and how it is to be paid to the school.
- 23 5. The Director of Schools shall determine whether or not the activity will benefit the school,
24 contribute to the welfare of the student body, and supplement, not replace, funds necessary to
25 fulfill the Board's required contributions.
- 26 6. Students shall not be excused from a regular class to participate in a fundraising activity. No
27 grade in a subject or course shall be affected by a student's participation in a fundraising activity.

1 7. No quotas shall be imposed on students involved, and their efforts shall be voluntary. Students
2 who do not participate in fundraising activities shall not be punished or discriminated against in
3 any way.

4 This policy shall not be construed as preventing a teacher from using instructional or informational
5 materials even though the materials might include reference to a brand, a product, or a service.

6 **LOTTERIES**

7 No fundraising activity shall be conducted which distributes prizes or makes awards to winners from
8 among purchasers of chances by means of tickets through a random selection process.³

9 **ONLINE FUNDRAISING**

10 Individual schools may establish school-wide online fundraising accounts. The accounts shall meet all
11 fundraising requirements established by the Board and the *Tennessee Internal School Uniform*
12 *Accounting Policy Manual*. The principal/designee of each school shall have access to the established
13 fundraising account to ensure all funds are properly accounted for, and the information is recorded in
14 the school's accounting records by the designated personnel. Online fundraising shall not be used on
15 behalf and for the benefit of an outside party.

16 An employee shall not engage in online fundraising for educational purposes in his/her official
17 capacity as a district employee or make any reference to non-school sponsored fundraisers, online or
18 otherwise, that would lead another to believe such activity is an approved school fundraiser.

19 **FUNDRAISING FOR NONEDUCATIONAL PURPOSES⁴**

20 On approval of the principal, an employee may be authorized to raise and use funds for the following
21 noneducational purposes:

- 22 1. Bereavement support;
- 23
- 24 2. Award recognition;
- 25
- 26 3. Employee morale;
- 27
- 28 4. Banquets; or
- 29
- 30 5. Other situations at the principal's discretion.

31 These funds shall be derived from vending machine revenue, donations, or **[insert additional sources**
32 **that an employee could use to raise funds]**.

33 The Director of Schools shall develop administrative procedures regarding the receipt, disbursement,
34 accounting, and auditing of these noneducational funds. The Director of Schools shall ensure that the
35 procedures are consistent with board policy and state law and disseminate them to all employees.

1 Students who have met graduation requirements are expected to participate in graduation activities. If
 2 extenuating circumstances exist at any school, the matter shall be presented to the Board prior to
 3 graduation activities.

4 Students who do not wish to participate in graduation activities shall notify the school principal in writing
 5 at least five (5) days prior to the day of graduation. Non-participating students shall receive their
 6 diplomas or certificates from the principal’s office within one (1) week of the day of graduation.

7 Graduation apparel shall be determined by the administration of each school and shall be the personal
 8 expense of each student. Any fees required for graduation shall be waived for students who are eligible
 9 to receive free or reduced-price lunches, and in such cases, the school shall assume responsibility for
 10 payment of fees.²

11 Graduation shall be physically accessible to all students, their parent(s)/guardian(s), and other interested
 12 citizens.³

13 Graduation activities organized by district employees shall not be religious in nature.⁴ The content of
 14 any students' speeches shall not reflect the endorsement, sponsorship, position, or expression of the
 15 school, employees, or Board.

16 The Director of Schools shall develop procedures to ensure that students are recognized at graduation
 17 for the following achievements:⁵

- 18 • Honors;
- 19 • State Honors;
- 20 • State Distinction;
- 21 • District Distinction;
- 22 • Tri-Star Scholar;
- 23 • Students receiving a TN Seal of Biliteracy;
- 24 • Students voluntarily completing at least ten (10) hours of community service each semester the
 25 student is in attendance at a public high school;
- 26 • Students receiving a gold or platinum medal on National Career Readiness Certificate; and
- 27 • Students graduating with a district-developed work ethic distinction.

1 Educational content which consists of religious themes shall be presented in a factual, objective, and
 2 respectful manner in accordance with the following guidelines:

- 3 1. Religious themes may be a part of the curriculum for school-sponsored activities and programs,
 4 provided it is essential to the learning experience in the various fields of study and is presented
 5 objectively;
- 6 2. The inclusion of religion shall be for educational purposes only;¹
- 7 3. The emphasis on religious themes shall be only as extensive as necessary for a balanced and
 8 comprehensive study of the curriculum. Such studies shall never be used to proselytize, establish,
 9 foster, or demean any particular religion, religious tenets, or beliefs;¹ and
- 10 4. Student-initiated expressions to questions or assignments which reflect their beliefs or non-
 11 beliefs about a religious theme shall be accommodated.

1 Other than the routine transmission of administrative and personnel files, district employees are
2 prohibited from assisting a school employee, contractor, or agent in obtaining a new job if the individual
3 knows, or has probable cause to believe, that the person seeking a job change engaged in sexual
4 misconduct regarding a minor or student in violation of the law.¹

5 These requirements shall not apply if:

- 6 1. The information giving rise to probable cause has been properly reported to the appropriate law
7 enforcement agency; and
- 8
9 2. The matter has been officially closed in one of the following ways:
 - 10
11 a. The prosecutor or police have investigated the allegations and notified school officials
12 that there is insufficient information to establish probable cause;
 - 13
14 b. The employee, contractor, or agent has been charged and either acquitted or exonerated;
15 or
 - 16
17 c. The case remains open, and there have been no charges or indictment filed within four
18 (4) years of the date the information was reported to the law enforcement agency.

19 Neither the district nor the Board shall enter into, or require a current or former employee to enter into,
20 a non-disclosure agreement during a settlement for any act of sexual misconduct.¹

21 The Director of Schools shall develop administrative procedures to enforce this policy and comply
22 with federal and state law.

1 **PROFESSIONAL PERSONNEL**

2 Professional personnel shall earn one (1) day of sick leave for each month employed during the school
3 year, and these days shall accumulate for an unlimited number of days.¹

4 Sick leave shall be defined as: illness of a teacher from natural causes or accident, quarantine, or illness
5 or death of a member of the immediate family of a teacher, including the teacher's wife or husband,
6 parents, grandparents, children, grandchildren, brothers, sisters, mother-in-law, father-in-law,
7 daughter-in-law, son-in-law, brother-in-law, and sister-in-law.²

8 A signed statement listing the cause of absence shall be provided by the employee on forms furnished
9 by the Director of Schools and shall promptly be given to the immediate supervisor in support of all
10 claims for sick leave pay. A falsified statement shall be grounds for dismissal.

11 Documentation from a physician may be required in support of any claim for sick leave pay.

12 The principal shall notify the Director of Schools' office at once if an employee is sick beyond the limit
13 of his/her sick leave accumulation.

14 Permanent, cumulative sick leave records for each active professional employee shall be kept in the
15 Director of Schools' office.

16 A teacher, upon employment, may transfer his/her accumulated sick leave from another Tennessee
17 school district, provided that the Director of Schools of the district in which the accumulated leave was
18 held provides notarized verification.³

19 **SUPPORT PERSONNEL**

20 Support personnel shall earn one (1) day of sick leave for each month an employee is employed.

21 At the termination of the employment of any employee, all unused sick leave accumulated by the
22 employee shall be forfeited.

23 The immediate supervisor may require documentation from a physician stating the reason for absence.

24 **SICK LEAVE BANK (if applicable)**

25 The purpose of the sick leave bank is to provide sick leave to all employees⁴ who have suffered an
26 unplanned personal illness, injury, or disability, and whose personal sick leave is exhausted.

- 1 To form a sick leave bank, a minimum of twenty (20) employees from the school district shall petition
2 the Board for permission to establish a sick leave bank.⁵ Upon approval, sick leave bank trustees shall
3 be appointed and shall operate as the governing body of the sick leave bank and shall enact rules and
4 regulations consistent with state law.⁶ Employees wishing to participate shall initially give two (2) days
5 of sick leave. These days are to be deducted from the employee's personal accumulation and donated to
6 the sick leave bank. Donations of sick leave to the bank are nonrefundable and nontransferable.⁷
- 7 At any time the number of days in the sick leave bank is less than twenty (20), or one (1) per employee
8 if there are more than twenty (20) members, or at any time deemed advisable, the trustees shall assess
9 each member one (1) or more days of accumulated sick leave. If an employee has no accumulated sick
10 leave at the time of assessment, the first earned days shall be donated as they are accrued by the
11 employee.⁷
- 12 An employee who is a member of the sick leave bank may request an allotment of days (for the
13 employee's personal illness only) in the manner designated by the trustees. The need for these days shall
14 be verified by a statement from a physician.
- 15 By written notice to the trustees, an employee may withdraw from bank participation on June 30th of any
16 year.⁸ Membership withdrawal results in forfeiture of all days contributed.
- 17 The sick leave bank shall be operated in accordance with state law.⁹

1 Professional employees shall earn personal and professional leave at the rate of one (1) day for each half-
2 year employed for a total of two (2) days per year. Any personal and professional leave remaining unused
3 at the end of a year shall be credited to sick leave.¹

4 If, at the termination of services, any employee has been absent for more days than leave has been earned,
5 an amount sufficient to cover the excess days used shall be deducted from the employee's final salary
6 payment.²

7 **PERSONAL LEAVE**

8 Subject to the following conditions, personal leave may be taken at the discretion of the employee:

- 9 1. Except in an emergency, each employee shall give the principal at least five (5) days' notice in
10 writing of intent to take leave;
- 11 2. The approval of the principal of the school shall be required:³
- 12 a. If more than ten percent (10%) of the teachers in any given school request its use on the
13 same day;
 - 14 b. If requested during any prior established student examination period;
 - 15 c. If requested on the day immediately preceding or following a holiday or vacation period;
 - 16 d. If personal leave is requested for days scheduled for professional development or in-
17 service training, according to a school calendar adopted by the Board prior to the
18 commencement of the school year; or
 - 19 e. If personal leave is requested for days scheduled for parent-teacher conferences,
20 according to a school calendar adopted by the Board prior to the commencement of the
21 school year.

22 **PROFESSIONAL LEAVE**

23 Professional leave is a short, temporary absence for the purpose of attending workshops and other
24 meetings relating to school business or serving on boards and commissions which meet during daytime
25 hours when appointed by a mayor, city council, county executive, or county commission.⁴

1 All purchases of supplies, materials, equipment, and contractual services in excess of twenty five
2 thousand dollars (\$25,000), including those of individual schools, shall be based on competitive bids.¹
3 These bids shall be solicited by advertisement in a newspaper of general circulation in the district.
4 However, said newspaper advertisement may be waived by the purchasing agent in an emergency.² The
5 purchasing agent shall advertise for bids and receive quotations. The principal shall serve as purchasing
6 agent in each school.¹

7 RFP documentation, board approval, and the finance office will review prior to any purchase(s)
8 exceeding twenty five thousand dollars (\$25,000). This policy will pertain to both federal and general
9 purpose program purchases that exceed twenty five thousand dollars (\$25,000).

10 All purchases of twenty five thousand dollars (\$25,000) or less, including those of individual schools,
11 may be made in the open market without newspaper notice, but shall, whenever possible, be based on at
12 least three (3) competitive bids or obtaining a sole source statement.²

13 The lowest and best bid shall be accepted, provided the Board reserves the right to eject any or all bids
14 or any part of any bid and, if applicable, to accept that bid which is best as evidenced by reasons relative
15 to the purpose of the purchase.³ Any bid may be withdrawn prior to the scheduled time for the opening
16 of bids. Any bid received after the time and date specified shall not be considered.

17 The bidder to whom the award is made may be required to enter into a written contract.

18 The practice of splitting an order or dividing items to be purchased in order to avoid the use of bidding
19 or other purchasing procedures is prohibited.

20 **Contracted Services**

21 In some situations, certain jobs or specific work tasks may require outsourcing. Any additional work
22 required by various school departments will require a written contract and must be approved in advance
23 by the Director of Schools or his/her designee.

24 **Exemptions from Competitive Bidding**

25 Contracts for legal services, educational consultants, and similar services by professional persons or
26 groups of high ethical standards shall not be based upon competitive bids but shall be awarded on the
27 basis of recognized competence and integrity.⁴

1 Substitute teachers are those teachers used to replace teachers on leave or to fill temporary vacancies
2 until a licensed teacher is available.^{1,2} Substitute teachers may be employed and paid directly by the
3 Board or by a third-party employer through an agreement between such third-party employer and the
4 Board.

5 Substitute teachers employed by third party entities shall be subject to the same unemployment benefit
6 eligibility conditions as substitute teachers employed directly by the Board.²

7 APPLICATION/QUALIFICATIONS

8 Criminal history record checks and fingerprinting of applicants for substitute teaching are required.³

9 Applicants with revoked licenses or certificates according to the Department of Education shall not be
10 hired.⁴

11 Qualifications for substitute teachers shall be determined by the Director of Schools in compliance with
12 board policy, state laws, and State Board of Education rules and regulations.

13 A list of substitute teacher(s) will be prepared by the personnel secretary who will maintain file(s) which
14 may include transcripts, credentials, recommendations, and other pertinent information.

15 COMPENSATION

16 If employed directly by the district, the compensation of substitute teachers shall be determined annually
17 by the Board.

18 Retired teachers serving as substitutes who do not have an active teaching license shall be paid the same
19 as a retired substitute teacher with an active teaching license. This only applies to teachers who retired
20 after July 1, 2011 through July 1, 2016.⁵

21 CERTIFICATION

22 When substituting for a regular teacher who has been absent for twenty (20) consecutive days, a
23 substitute teacher shall possess a teaching certificate with endorsement in the discipline(s) to be taught
24 or shall be a retired teacher that held the appropriate endorsement.⁶ When substituting for a teacher
25 without sick leave, the substitute shall be certified and paid according to the state salary schedule.¹

26 Retired teachers may substitute one-hundred twenty (120) days per year without loss of retirement
27 benefits¹ and may substitute for additional days if the Director of Schools certifies in writing to the
28 Division of Retirement that no other qualified personnel are available to substitute teach.⁷

1 EMERGENCY NEEDS

2 All teacher aides, secretaries, and clerks are approved substitute teachers for use in emergency situations.
3 Emergency use shall be defined as less than a full day due to the regular or substitute teacher being
4 unable to arrive on time or remain for the full day.

5 Said substitutes shall receive the proportionate equivalent salary regular substitute teachers would
6 receive under similar circumstances or their regular salary, if higher; however, they shall not receive pay
7 for both positions at the same time.

8 TRAINING AND ORIENTATION

9 The Director of Schools shall be responsible for ensuring that there are appropriate training and
10 development programs for substitute teachers.

11 RESPONSIBILITIES

12 Substitute teachers shall assume the same responsibilities as the regular teacher, including but not limited
13 to, bus duty and playground supervision.

14 RE-EMPLOYMENT/TERMINATION

15 On an annual basis, the Director of Schools, with input from the principals, shall determine which
16 substitute teachers performed at an acceptable level. Substitute teachers who performed below an
17 acceptable level shall not be re-employed.

18 All substitutes shall be responsible for providing correct addresses and phone numbers and for notifying
19 the principal and/or third-party employer if they wish to terminate their service as substitutes.
