BEDFORD COUNTY BOARD OF EDUCATION

Minutes from February 18, 2020 Regular Monthly Meeting

The Bedford County Board of Education met in a regular monthly session on Tuesday, February 18, 2020. Board members Forsee, Neeley, Anderson, Cook, Boutwell, Crews, Brown and Reed were present. Mrs. Cashion was absent.

Chairman Forsee called the meeting to order, followed by a moment of silence and the Pledge of Allegiance. He then made a note that Action Items B and C on the agenda will be deferred for further study.

The following consent agenda was approved by acclamation upon the motion and second of Mrs. Neeley and Dr. Anderson.

SPOTLIGHT ON STRATEGIC PLAN

Chairman Forsee noted the strategic plan's Focus on Every Student goal and introduced Assistant Superintendent, Karen Scoggins to talk about scores.

Test Scores – Karen Scoggins, Assistant Superintendent

Mrs. Scoggins gave a presentation - *SCORE Report – 2020 by the Numbers* (see presentation in February 18, 2020 board meeting file). She explained the differences between achievement and growth, noting that achievement is based on a scale score for proficiency and does not compare a student's scores between years, whereas growth is relative to how a student performed the previous year or across all tests a student has taken, if using the predictive model.

She used an illustration of runners on a track to describe yearly growth expectations and showing how they begin at the same position and should maintain their relative position among fellow runners or peers as they run the track. The group's average performance will determine the growth expectation.

The SCORE report is based completely on achievement scores and are reported on a 1-4 category. The district and grade levels are reported on the percent proficient. She discussed a slide on 3rd Grade Reading Proficiency which illustrated that Bedford County Schools had a larger than average growth in its third grade reading proficiency rate for black students and another that showed 7th grade math proficiency and a larger than average growth for 7th grade black students.

Bedford County increased its ACT performance gap for economically disadvantaged students relative to the overall rate in students scoring 21 or better.

In third grade reading proficiency rate, Bedford County was at 31%; Thomas Magnet was 68%, Cascade Elementary was 47% and Community Elementary was 31%. In seventh grade math proficiency Bedford County was at 31%; Cascade Middle was 45%, Community Middle – 34% and Harris Middle – 28%.

On the ACT the Bedford County Composite was 18.9. Cascade High scored 20.8 and were in the top 3 schools for ACT results in the South Central district. SCHS had an 18.3 and Community High a 17.9. In the percent scoring 21 or higher on ACT, Bedford County was at 36.4%; Cascade High at 46.8%, SCHS 34.8% and Community High at 27.8%.

Mr. Boutwell asked what would be some of the things that impacted scores positively and what resources are needed to continue along this path. Mrs. Scoggins said the administration is looking to continue foundations of literacy instruction. The ELA adoption will be this year. They are doing a lot of work on high quality instructional materials. Teachers have been working tirelessly over the last four years when the state changed standards and we didn't initially have materials available to correlate. They work two weeks in the summer and across the year to help gather and build instructional maps. She mentioned how teachers are pulling materials, looking on Facebook, pulling materials on Sunday. Karen Scoggins – "We want to give them what they need to not do that and help them concentrate on the intellectual instructional piece; not on what they need."

Superintendent Embry mentioned the ELA materials and selection process and that groups are meeting right now. The implementation process has been revamped by the administration. There is a whole body of science around high quality. Don Embry – "We have immersed ourselves as learners and a teacher expert review team from every school and every grade level and a selection team made up of administration, coaches and teachers together, working on science of how we teach children to read and select materials to make the best selection possible."

The administration is also working with Instructional Partners and going to other districts to observe.

Mr. Cook asked how the one to one device initiative was working with test scores this year. Administrators have been able to see results in ELA this year, seeing a very blended approach. Research shows this is the right thing for the system to do. Students have been observed with their novels out and their assignments in OneNote or Microsoft Word and there has been a great focus on that, doing in a blended way the first year out of the gate.

Mr. Cook then asked if the next step would be to go one to one in the middle grades and work down. The administration has already been talking about that and a request will come in the budget. Mr. Embry added that they are looking at a huge expense with the ELA adoption and it may be a year away before going to the middle grades with one to one, but numbers are being crunched.

Mr. Crews asked how effective this data is in determining where you have struggling teachers when the data lags a year and half behind. Mrs. Scoggins said she uses it more to indicate trends. She looks at Foley and Tapping Out with Tiles and mastery data to see if they line up with this. These indicate we are on an upward trend. She looks for trends that correlate. Foley is helping teachers to solidify skills for students to go to third grade.

She looks more at growth data and the TEAM performance rubric to determine if teachers are teaching to the depth of the standard. She looks at a three-year trend to see how we are using materials and if they are impacting students.

Mr. Cook said he felt Mr. Crews made a good point and he asked if the board could see the achievement and growth for each school for a three-year trend. This data is looked at daily in the “war room” and was promised to be produced, per Mr. Cook’s request.

Dr. Anderson moved to grant tenure to the recommended teachers. Mrs. Neeley seconded the motion. Superintendent Embry clarified that a teacher with tenure is afforded due process, if necessary for dismissal. A teacher without tenure is not on a contract and is an at-will employee. Also, tenure is not guaranteed for life. Teachers without tenure are either renewed or not renewed. Tenure offers additional protections for teachers. **Motion to grant tenure to those recommended was approved unanimously.**

Title V Amendment

Superintendent Embry explained the Title V Amendment (see document in February 18, 2020 board meeting file) provides for counseling at BCLA, among other things. **The amendment was approved unanimously upon the motion and second of Mr. Brown and Mr. Cook.**

January Monthly Financial Report

County Financial Director Robert Daniel reviewed the January Monthly Financial Report (see document in February 18, 2020 board meeting file), noting there was nothing unusual to report. **The January financial was accepted by a vote of 8-0, upon the motion and second of Mr. Boutwell and Mrs. Neeley.**

Budget Amendment #3

Robert Daniel reviewed Budget Amendment #3 (see document in February 18, 2020 board meeting file) noting that most was due to department transfers which he reviewed. **Budget Amendment #3 was accepted by unanimous vote upon the motion and second of Mrs. Neeley and Mr. Cook, and recommended for approval to county finance.**

Revision – Policy 4.302 Field Trips/Excursions/Competitions

The recommended revision to Policy 4.302 (see document in February 18, 2020 board meeting file) is to include a provision for Independently Planned Trips. There have been concerns that these types of trips, organized by employees, may be perceived as field trips organized and approved by the school (e.g. a Spanish teacher organizing a trip over the summer to Spain). Parent(s)/guardian(s) or students may think, since these trips are organized by district employees, that extra protections are being provided by the district or that the Board is assuming liability.

TSBA has created a provision that covers independently planned trips. This provision is not required by statute but is recommended as a best practice.

Mr. Embry explained that we are running into more situations where groups are going on trips in the summer or other breaks and it could be interpreted as school-related when they are not. A group turned in a permission form for a trip two years from now to Italy and it is not board sponsored but done by individuals. This revision clarifies what is a school system or an independently planned trip.

Motion to approve the recommended revision was made by Mrs. Neeley and seconded by Mr. Reed. Mr. Cook asked if this had anything to do with athletic trips. Mr. Embry said no, they would be considered school-sponsored unless it is a situation with summer travel due to travel teams. Reward trips for elementary school fall into school-sponsored category.

Mr. Brown asked if this recommendation has to do with liability which to a large extent it does. Board funds are not used, materials are not used, and if a teacher is independently organizing the trip, they must not do so during the instructional day.

Motion to approved passed by a vote of 8-0.

REPORT ITEMS

Monthly Tax Analysis

Robert Daniel reviewed the monthly tax analysis (see document in February 18, 2020 board meeting file), noting that sales tax was ahead by \$22k and that internet sales collections are starting to come in and think some of the increase is due to them.

Update on Learning Way Addition

John Davis of Davis-Stokes Collaborative reported on progress of Learning Way, noting that a break in the rain would be welcome, but progress is still being made and no problems experienced.

Legislative Report & Board Members Share Information from Legal & Legislative Institute

Mrs. Neeley said four board members were just back today from TSBA's Legal & Legislative Institute where they heard about plans to kill voucher bill and that pending lawsuits could take three years. There is a lot of time being spent on social services with schools to increase school nurse ratio to students and increase mental health services for students.

There is potential legislation looking at licensure requirements for teachers moving here from other states, in consideration of the teacher shortages which are at 1200 positions not filled across the state.

Dr. Anderson liked the new format of the meeting, that replaced the traditional Day on the Hill, noting there was more information than in the past. Mr. Brown agreed that it was a much more productive meeting than in the past.

Mr. Cook said it was interesting to hear the legislative update on what is being done at the capital.

Chairman Forsee was interested in the bills that TSBA supports and opposes and how few of them actually deal with academics, and how much is invested in social services and safety. He added he was grateful for what TSBA provides and what the local faculty, administration and staff do to support and create an atmosphere for learning to take place.

Collaborative Conferencing Update

Mrs. Neeley said the board's collaborative team thinks that work is done and they are just waiting on a couple of questions to be answered but should have an MOU ready for ratification by the board in March.

Executive Committee Report

Chairman Forsee reported having received declarations of surplus from Thomas Magnet, Southside and Learning Way. He noted important dates as SCOPE on March 10, the Annual Board Retreat on March 13 & 14, and the next board meeting held in the central office on March 17.

Superintendent's Report

Superintendent Embry attended the Superintendent's Legislative Learning Conference where he had the opportunity to hear Governor Lee talk about the budget, in which he proposes a large chunk go towards social services, counseling, school nurses, etc.

Superintendents also met with the State Board of Education. They talked at length with Gordon Ferguson, our representative, about teacher shortages and certifications and how difficult it is for out of state teachers to start all over again. He noted the number of teacher shortages across the state is astounding.

Local administration is searching for ways to get kids involved and interested in becoming teachers. Mr. Embry noted the "Grow Your Own" program. Locally, we started last year offering *Teaching As a Profession* as a high school course and hope to expand that as we go along.

The governor's budget includes a 4% pay increase for teachers, which after trickling down through non-BEP funded positions, will be more like 2%, which he said was not enough.

Mr. Reed congratulated the Community Vikings for going 27-1 in their district.

Upon the motion of Mr. Boutwell, the meeting was adjourned at approximately 6:20 p.m.
