Recommendation

Pursuant to Texas Election Code Section 67.003(b), the Board of Trustees, as the canvassing authority of Fort Bend Independent School District, must canvass the certified statement of the votes cast in the General Election for Trustee, Positions 3 and 7 held on May 7, 2022.

Fort Bend County conducted the election pursuant to the Joint Election Agreement and Contract for Services with Fort Bend ISD, dated March 28th, 2022. Prior to the May 16, 2022 meeting to Canvass Election Results, Mr. John Oldham, Elections Administrator for Fort Bend County, will deliver the certified statement of the votes cast for Fort Bend ISD trustees in the May 7, 2022 election.

The Board must convene and canvass votes no later than May 18, 2022.
