Student Fees

- The Board of Education acknowledges that the Public Elementary and Secondary Student Fee Authorization Act authorized school districts to charge student fees for certain student activities and requires the district to adopt a policy addressing student fees. Further, the board recognizes the fact that there are expenses relating to educational and extracurricular programs and activities that may require financial participation by students and their parents or guardians. It is the intent of the board to provide equal access for students to all programs while complying with the laws of Nebraska and the rules and regulations of the Nebraska Department of Education.

FEES AUTHORIZED

- Guidelines for non-specialized attire required for specified courses and activities.
- Personal or consumable items & miscellaneous
 - Extracurricular Activities. Students have the responsibility to furnish any personal or consumable items for participation in extracurricular activities.

Student Fees

AUTHORIZED COURSE FEES

- **General Course Materials.** Items necessary for students to benefit from courses will be made available by the District for use during the school day. **Student responsibilities such as: pencils, paper, pens, erasers, notebooks, trappers, protractors and math calculators**
- **Damaged or Lost Items**
- **Materials Required for Course Materials** (such as projects in art and shop classes)
- **Music Course Materials**
- **Parking**

- Extracurricular Activities-Fees for participation
- Postsecondary education costs
- Transportation costs
- Copies of student files or records
- Participation in summer school or night school
- Breakfast and lunch programs
