





The Cypress-Fairbanks Independent School District Board of Trustees convened in Regular Session on Monday, September 8, 2025, in the Boardroom of the Cypress-Fairbanks Independent School District Mark Henry, Ed.D. Administration Building, located at 11440 Matzke Road, Cypress, Texas 77429.

MEETING OPENING

1. Call to Order

Board President Scott Henry called the meeting to order at 6:00 p.m.

The following Trustees were present: Scott Henry, Dr. Natalie Blasingame, Justin Ray, Julie Hinaman, Christine Kalmbach, Todd LeCompte, and Lucas Scanlon.

Mr. Henry acknowledged Olivia Lee with Commissioner Lesley Briones' office, Representative Mike Schofield, and Grace Handley with Representative Dr. Tom Oliverson's office who were in the audience. He also acknowledged Boy Scout Troop 573 from Goodson Middle School.

2. Invocation and Pledge of Allegiance

Jon Glass, Lead Pastor, Copperfield Church, delivered the invocation.

The following Jersey Village High School AFJROTC cadets presented the colors for the evening: Carrying the US Flag was Color Guard Commander Cadet Jason Medina; carrying the Texas Flag was Cadet Dennis O'Brien; the US Guard was Cadet Christopher Banagas; and the Texas Guard was Cadet Aaron Carillo. These cadets presented the colors under the direction of (Retired) Major Jerome Frederick and (Retired) Technical Sergeant Marvin Waterman.

3. District's Vision and Mission Statement

Trustee Lucas Scanlon read the District's Vision and Mission Statement.

4. Recognitions and Awards Announcements

4.A. Superintendent Dr. Douglas Killian made remarks and announcements regarding the honors and achievements earned by staff and students in recent weeks and provide information regarding district and community events or items of interest.

Irene Ruiz, Chief Officer for School Leadership, introduced the following administrative staff: Michele Bickham, new principal for Rennell Elementary School; Stacie Everson, new Assistant Superintendent for Elementary School Administration; and Ana Martin, new Assistant Superintendent for Secondary School Administration.

4.B. The Board recognized CFISD business partners, Laurie & Arnold Rios of Cabo Bob's for their outstanding contribution to the district.

4.C. The Board recognized State Representative Mike Schofield, District 132, for his dedicated service to the Cy-Fair community and his ongoing support of CFISD.

Board President Henry called for a recess at 6:39 p.m.

Mr. Henry called the meeting back to order at 6:45 p.m. The Board proceeded with **Board Comments**.

5. Board Comments

5.A. Board members may make comments during this portion of the agenda regarding student achievement, district progress and data, community input and concerns, observations from school visits, meetings and conferences attended, district and community events and initiatives, or continuing education. The Board may not take action on items discussed.

Trustee Julie Hinaman shared comments regarding the Board Comments portion of the agenda during the September 4, 2025, Board Work Session. Ms. Hinaman stated, "The true highlights of the work session should have been the celebration of the academic success of our students as demonstrated by their achievement on state assessments." She also shared how the Board celebrated the commitment of campus principals to build positive

campus culture and to ensure positive behavior in CFISD. Ms. Hinaman thanked campus staff members for providing exceptional educational opportunities for all students in CFISD.

Trustee Christine Kalmbach honored all those lost in 911, with the families and communities left behind. “Patriot Day is a reminder to serve and help others and to honor the legacy of those lost, and to pay tribute to those who serve in or emergency response and military services.” Ms. Kalmbach shared comments on the newly formed Long-Range Planning Committee, the new cell phone policy, K-9 Diego and his handler’s retirement, and the STAAR test scores. She attended the open house at the Carpenter Center for the remodel reveal. Ms. Kalmbach gave an update on the Academic, Safety and Planning Committee (ASVP).

Trustee Dr. Natalie Blasingame congratulated Dr. Killian, his leadership team and the extended leadership team for a great start to the new school year. Dr. Blasingame shared comments on an article published in the Houston Chronicle regarding the most improved districts in the Houston area and noted that CFISD was on that list with a 5-point gain as one of the higher performing districts on the list. “Great work.” Dr. Blasingame thanked everyone for all their hard work in making this happen.

Trustee Todd LeCompte shared his comments on the Bus Buddy Program this year and thanked everyone for participating. Mr. LeCompte attended the first Cy-Ranch HS game, and he recently visited Metcalf and Lowery Elementary Schools. He highlighted students, parents and staff members for their districtwide increase on STAAR testing results and specifically, thanked parents for their efforts to help their students achieve a higher attendance rate. Mr. LeCompte thanked First Baptist Church-Cypress for donating over 700 backpacks to CFISD, as well as thanking businesses, churches and community members for their support for the district. Mr. LeCompte gave an update on the Policy Review Committee.

Trustee Lucas Scanlon shared that he participated again this year in the Bus Buddy Program. He celebrated Cy-Ranch HS’s homecoming game by attending with his family. Mr. Scanlon shared comments on the ethics and duties of school board members, specifically regarding political candidates, political parties, public officers or measures. He complimented Representative Schofield’s advocacy for CFISD before, during, and after the legislative session, stating that it was “incredible.” Mr. Scanlon shared comments on his time as a Board member for CFISD, stating that what is most important as a Trustee, is the district. Doing the right thing, focusing on fostering the district’s ability, through policy, prioritization, involvement, education of the public, and the encouragement of team members to help students believe in themselves, advance in their ability to learn in confidence so they can face new challenges and be successful in their endeavors in the classroom, and in all of their extracurricular activities and community service. He also shared comments on what is sent to the public from the media, and in closing, Mr. Scanlon asked the media to “please take the positive messages, look at what we’re doing well, and bring that back to our stakeholders.”

Trustee Justin Ray shared what the new school year brings for trustees, i.e. campus visits, sporting events, fine arts, judging Future Business Leaders of America competitions, along with items in the works – the Long-Range Planning Committee meetings, school boundaries, and more. He shared comments and stories on his interactions with staff, students and the community during events such as the Carpenter Center open house and his campus visit to Jersey Village High School. Such interactions with students and teachers caused him to reflect on, “where else can students go and get these kinds of experiences but right here in CFISD.” “CFISD has and always will offer more to students.”

Trustee Scott Henry reflected on one of his visits during the past week ... the newly reopened Carpenter Center. Mr. Henry shared how he left very encouraged and how high the bar is set by the staff at the Carpenter Center for care and instruction. Mr. Henry congratulated Matt Morgan and his team for a very strong addition of “shop space” for the hands-on learning and career skills these students will receive. He shared how the Carpenter Center serves many students and gives support to those that need it most. He went on to say what purposeful work that the staff at the Carpenter Center puts in each and every day and how each classroom feels calm, safe, and focused. Mr. Henry concluded his comments by encouraging parents to engage early and take full advantage of this resourceful and supportive educational campus, the Carpenter Center.

In accordance with law, the definitions of abuse and neglect specifically exclude the refusal of a person responsible for a child's care, custody, or welfare to affirm the child's expressed sexual orientation or perception of the child's gender, including a refusal to use the child's preferred name or pronouns, regardless of whether the child's name has been legally changed.

As defined in state law, child abuse and neglect include both sex and labor trafficking of a child.

The following individuals have an additional legal obligation to submit a written or oral report within ~~48~~²⁴ hours of learning of the facts giving rise to the suspicion of abuse or neglect:

1. Any District employee, agent, or contractor who suspects a child's physical or mental health or welfare has been adversely affected by abuse or neglect.

been a victim of indecency with a child. A professional is anyone licensed or certified by the state who has direct contact with children in the normal course of duties for which the individual is licensed or certified.

A person is required to make a report if the person has reasonable cause to believe that an adult was a victim of abuse or neglect as a child and the person determines in good faith that disclosure of the information is necessary to protect the health and safety of another child or an elderly or disabled person.

Oral Reports

As required by law, an oral report made to the Texas Department of Family and Protective Services (DFPS) is recorded.

Restrictions on Reporting

In accordance with law, an employee is prohibited from using or threatening to use (1) a parent's refusal to consent to administration of a psychotropic drug or to any other psychiatric or psychological testing or treatment of a child or (2) a parent's choice of a recognized alternative health care treatment or therapy for the child that could be considered as new, emerging, or nonstandard as the sole basis for making a report of neglect, unless the employee has cause to believe that the refusal:

1. Presents a substantial risk of death, disfigurement, or bodily injury to the child; or
2. Has resulted in an observable and material impairment to the growth, development, or functioning of the child.

Making a Report

Reports may be made to any of the following:

1. A state or local law enforcement agency as defined by law;

The District received a total of 8 (eight) proposals from interested contractors on September 9th, 2025, for the above referenced project. Attached you will find the proposal tabulation form summarizing the proposals submitted and a recommendation letter from Huckabee Architects dated September 23, 2025.

Our department has carefully evaluated the submitted proposals and hereby recommends to the Board of Trustees award the construction contract to Dunhill Development and Construction, LLC, in the amount of \$6,100,000.00. 

POMA has served as CFISD's financial advisor since 2018, where they have assisted the district in numerous successful diverse transactions as well as bond refunding transactions that reduced debt service payments.

Dr. Killian recommends adding a secondary financial advisor to support CFISD. Although PFM Financial Advisors LLC were ranked second by the financial advisory services committee, it is Dr. Killian's recommendation to select Nickel Hayden Advisors as the secondary financial advisor based on his excellent experience with Rudy Mejia in his prior district, with a prior firm, and Mr. Mejia's work with other Texas districts.

In 2025, your taxing unit has the right to participate in the nominating and voting process to appoint two members to the Board of Directors of the Harris Central Appraisal District (“HCAD”). Eligible conservation and reclamation districts in Harris County will also participate in the election. These directors will serve four-year terms beginning January 1, 2026. This letter serves as formal notice of:

- Your right to nominate a candidate or candidates for a position on the Board, and the process for doing so; and
- Your voting entitlement, as determined by Section 6.03(d) of the Texas Property Tax Code.

We have described the process for nominating a candidate or candidates in **Exhibit “A,”** which is attached. You’ll also find a description of the voting process to elect two new board members in that Exhibit. Completing these steps will require your board to meet two times before the end of the year.

Your board will need to meet and complete this first step for nominating a candidate or candidates so that you can deliver your nomination(s) and resolution to the chief appraiser no later than 5 PM, October 14, 2025.

NOMINATING AND VOTING PROCESS FOR ALL TAXING UNITS OTHER THAN CONSERVATION AND RECLAMATION DISTRICTS

Entitlement to Vote

In general, the voting entitlement of the eligible taxing units is determined by dividing the total dollar amount of property taxes imposed by the taxing unit in the preceding tax year by the sum of the total dollar amount of property taxes imposed in the appraisal district for that year by each taxing unit entitled to vote, multiplying the quotient by 1,000, and by rounding the product to the nearest whole number. Tex. Tax Code Section 6.03(d).

That number is then multiplied by the number of directorships to be filled. Taxing units whose final levy ratio calculates to .49 or under were rounded to the nearest whole number, which is zero. Accordingly, some taxing units have zero votes. To view your taxing unit's entitlement to vote in the appointment process, please see Exhibit "B" attached.

Nomination Procedures

All taxing units, other than conservation and reclamation districts, may nominate up to two candidates to be placed on the ballot that will be sent to, and voted upon by eligible taxing units that are entitled to vote.

The presiding officer of a taxing unit's governing body must submit the name(s) and the corresponding nominating resolution to the chief appraiser **before October 15, 2025**.

Voting Procedures

Before October 30, 2025, the chief appraiser will prepare a final voting ballot alphabetically listing by surname all nominees that were submitted timely and send that ballot to the presiding officer of the governing body of each taxing unit that is entitled to vote.

Prior to **December 15, 2025**, the governing body of each taxing unit entitled to vote shall determine its vote by resolution and submit it to the chief appraiser. Pursuant to Tax Code Section 6.03(c), a governing body of a taxing unit may cast its votes for one candidate or distribute them among the candidates.

The two candidates receiving the most votes will be appointed to the board of directors for a four-year term beginning January 1, 2026.

The chief appraiser will count the votes and will then notify the winners, the nominees, and the presiding officers of each taxing unit before December 31, 2025.

Additional and specific information pertaining to this voting process and the final voting ballot will be sent to you with the list of nominees on the final ballot before **October 30, 2025**.

Eligibility Requirements

The appraisal district appraises all property in the county for ad valorem tax purposes. The board of directors is the governing body for the district. The board employs the chief appraiser, sets general policies for the district, and adopts the budget for the district. By law, board members cannot communicate with the chief appraiser regarding appraisals, except in: (1) an open meeting of the appraisal district board of directors or another public forum; or (2) a closed meeting of the board of directors held to consult with the board's attorney about pending litigation, in accordance with Tax Code Section 6.15.

There is no compensation for service on the appraisal district's board of directors; however, directors are reimbursed for actual and necessary expenses incurred in the performance of their duties as provided by the budget adopted by the board. HCAD's Board of Directors typically meets once a month.

An individual must satisfy certain residency, employment, and conflict-of-interest requirements to be eligible to serve on the appraisal district's board of directors.

Residency. *The individual must be a resident of the district and must have resided in the district for at least two years immediately preceding the date he or she takes office. The appraisal district's boundaries are the same as those for Harris County.*

Employment. An employee of a taxing unit served by the appraisal district may not serve on the board of directors, with one exception: an employee of a taxing unit may serve if the employee is also a member of the governing body or an elected official of a taxing unit that participates in the district. For example, a member of the governing body of a school district who is also a city employee may be *eligible* to serve on the board.

An individual is *ineligible* to serve on an appraisal district's board of directors if the individual has engaged in the business of appraising property for compensation for use in proceedings under the Texas Property Tax Code or of representing property owners for compensation in proceedings under the Tax Code in the appraisal district at any time during the preceding three years.

Conflict of Interest. An individual may not serve on an appraisal district's board of directors if the individual is related, within the second degree by consanguinity (blood) or affinity (marriage), to a person who is in the business of appraising property or representing property owners for a fee in proceedings in the appraisal district; those relatives barred include: the individual's spouse, children, brothers, sisters, parents, grandparents, and grandchildren. The relatives of the individual's spouse in the same degree are also included.

An individual is not eligible to be a candidate for, to be appointed to, or to serve on the board of directors of, an appraisal district if the individual contracts with the appraisal district for any purpose or contracts with a taxing unit served by the district for a property tax-related purpose. The same rule applies to individuals who have a substantial interest in businesses contracting with the appraisal district (for any purpose) or with the taxing unit (for property tax purposes). An individual has a substantial interest if the individual or the individual's spouse has combined ownership of at least ten percent (10%) of the voting stock or shares of the business. An individual also has a substantial interest if the individual or the individual's spouse is a partner, limited partner, or an officer of the business. These prohibitions on contracting continue for the duration of the affected director's term of office.

Additionally, the appraisal district may not employ any person who is related to a member of the board of directors within the second degree by affinity or the third degree of consanguinity. This provision applies to existing employees at the time the director takes office and to employees hired during the director's term.

Delinquent taxes. With limited exceptions, Texas law makes a person ineligible to serve as a member of the board of directors if he or she has delinquent property taxes owed to any taxing unit for more than 60 days after the person knew or should have known of the delinquency.







Grades 6–8

Campuses must offer the following courses for students.

Enrollment in Fine Arts

Students in grade 6 are required to take a minimum of one semester of fine arts.

Assignment to Required Reading Course

Students scoring below the District cut-off score on the state-mandated assessment in reading shall enroll in a reading course during grade 7 and/or grade 8.

Assignment to Additional Academic Courses

Students in grades 6–8 who fail any portion of the state assessment may be required to enroll in specific academic courses designed for acceleration/remediation/intervention.

Required Computer Literacy

Students in grades 7 and 8 are taught the TEKS for the required computer literacy course through integrated instruction in language arts, math, science, and social studies.

Required Physical Education

Students in middle school are required to take two semesters of physical education in grade 6 and at least three semesters of physical education in grades 7 and 8.

Local Elective Courses

Students in grades 6–8 may enroll in only one locally developed course each semester.

Grades 9–12

Campuses must offer the following courses for students.

Assignment to Additional Academic Courses

Students in grades 9–12 who fail any portion of the state assessment may be required to enroll in specific academic courses designed for acceleration/remediation/intervention.

Assignment to Required Reading Courses

Students in grades 9–12 who fail the previous year's state reading assessment may be required to enroll in the appropriate level of reading.

Requirement for Independent Study in English

Ninth-grade students enrolled in a District high school are required to take one-half credit in Independent Study in English.

Olympic-Caliber Training Programs

The District shall allow qualified private or commercially sponsored physical activity classes to substitute both for required physical education units in grades 6-8 and for physical education graduation credits in grades 9–12. [See EIF]

Students involved in one of these programs shall be encouraged to participate in their own school's athletic program during the semester when UIL competitions are held; ~~they would, therefore, drop out temporarily from the private or commercially sponsored program.~~

Program Qualifying
Criteria
(Category 1)

To qualify for substitution, private or commercially sponsored physical activity classes must meet these criteria for Category 1 programs, as stipulated by the Texas Education Agency:

1. Provide training and/or competition opportunities which exceeds the District's physical education curricular requirements and which has the potential to develop Olympic-caliber performers.
2. Provide for student participation for a minimum of 15 clock hours per week of highly intense, professional, supervised training in a program certified by the Superintendent to be of exceptional equality.
- ~~3. Include opportunities for students to participate in competitions leading to the Olympics.~~
- ~~4.3.~~ Receive approval from the off-campus physical education department.

Rules and
Procedures
Governing Student
Participation

Each student must submit an application for approval ~~for the fall semester no later than May 1 or for the spring semester no later than November 1~~ by the established deadlines.

Each student must receive ~~Board~~ approval for participation in a program that meets the Category 1 criteria and that has been approved by the off-campus physical education department.

Each program must be approved by the Board and have appropriate paperwork submitted to the Commissioner of Education prior to the semester ~~the program is an approved program is to be offered. offered for physical education credit.~~

The parent must grant permission for a student to substitute participation in a private or commercially sponsored training program for physical education.

The coach in special training programs: (a) must provide the District with the information required on the approval applications; (b) must assume responsibility for attendance accounting; (c) must assign ~~six weeks' and semester grades~~ grades for each grading period; (d) must notify the school and the OCPE department if a student drops out of the program; ~~and~~ (e) must submit required records/reports on time; ~~and~~ (f) must instruct students in the grade-level appropriate health Texas Essential Knowledge and Skills.

Grades 6–8

Middle school

1. Students shall receive a numerical grade on their report cards. The coach shall send this grade, along with ~~the the six weeks' grading period~~ attendance accounting, to the ~~grade-~~

~~level counselor who shall complete the grade reporting sheet~~OCPE department. Report cards shall read "Off-campus P. E."; the course shall be assigned a special computer number.

2. The grade for this activity shall not affect honor roll standing.
3. Both the coach and the students must assume responsibility for notifying the school (~~grade level counselor~~) and OCPE department if a student drops out of the program.
4. Students who drop out of the program during the semester shall be placed in a physical education class. If students drop out at the semester, they may be placed in physical education or an appropriate elective (eighth-graders).
5. Students may miss only one period during the school day.

~~6. The coach will need to instruct sixth graders in health essential knowledge and skills.~~

Grades 9–12

High School

1. Students shall receive numerical grades on their report cards for participation in the training program. The coach shall send this grade, along with the six weeks' grading period attendance accounting, to the ~~grade level counselor who shall complete the grade reporting sheet~~OCPE department. Report cards shall read "Off-campus P.-E."; the course shall be assigned a special computer number.
2. The grade for this activity shall not affect honor roll standing. The semester grades shall count in students' grade point averages and shall be included in the calculation of the total number of grade points for determining class rank.
3. Olympic-caliber training courses shall be weighted as L-level credit.
4. Both the coach and the students must assume responsibility for notifying the school (~~grade level counselor~~) and OCPE department if a student drops out of the program.
5. Students who drop out of the program during the semester shall be placed in a physical education class. If students drop out at the semester, they may be placed in physical education or in an appropriate elective.
6. Students may earn two to four state-approved credits and/or two local credits if they remain in the program for four years.
7. They may miss only one period during the school day.

Field Trips

Criteria for
Obtaining Approval

The only students allowed to participate in off-campus physical education field trips are students with prior approval for the field trip and current enrollment in off-campus physical education.

Students failing one or more courses shall not be approved to participate in the field trip.

Field trips should not be scheduled during ~~six-weeks'-district~~ or state-mandated testing periods. Under no circumstances shall a field trip be scheduled on the day or evening immediately preceding the day on which the state-mandated test is scheduled.

The District shall not schedule, nor permit students to participate in, an extracurricular activity or a public performance that would require, permit, or allow a student to be absent from class in any course more than ten times during the school year. The District may adopt policies that permit distribution of the ten absences during the school year for the purpose of participation in extracurricular activities.

Procedures for
Obtaining Trip
Approval

Coaches proposing off-campus physical education field trips must complete a field trip request, providing all the necessary details of the proposal, and obtain the signature of the principal.

All field trip requests must be submitted two weeks prior to the date of the proposed trip.
