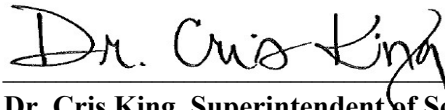

**BACKGROUND INFORMATION**

This purchase intends to provide a method to procure the renewal of the i-Ready Reading site license for the 2026-2027 school year to meet the needs for an Elementary Reading Intervention Program.

This program is a comprehensive K-5 literacy software program that brings together assessment data with targeted instruction to support grade-level proficiency and student growth. The program begins with a diagnostic assessment that diagnoses a student’s strengths and areas for improvement. It then creates a personalized pathway that adapts to the needs of the student. Additionally, the program provides targeted TEKS-aligned lessons that teachers can use in small group settings to help close achievement gaps.

**ADMINISTRATIVE CONSIDERATIONS**

The purchase will be made using an Inter-local Purchasing Co-op. Using an Inter-local Purchasing Co-op complies with the purchase requirements of TEC 44.031(a)(4) and local board policy requiring an approved purchasing method for contracts valued at \$50,000 or greater.

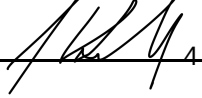

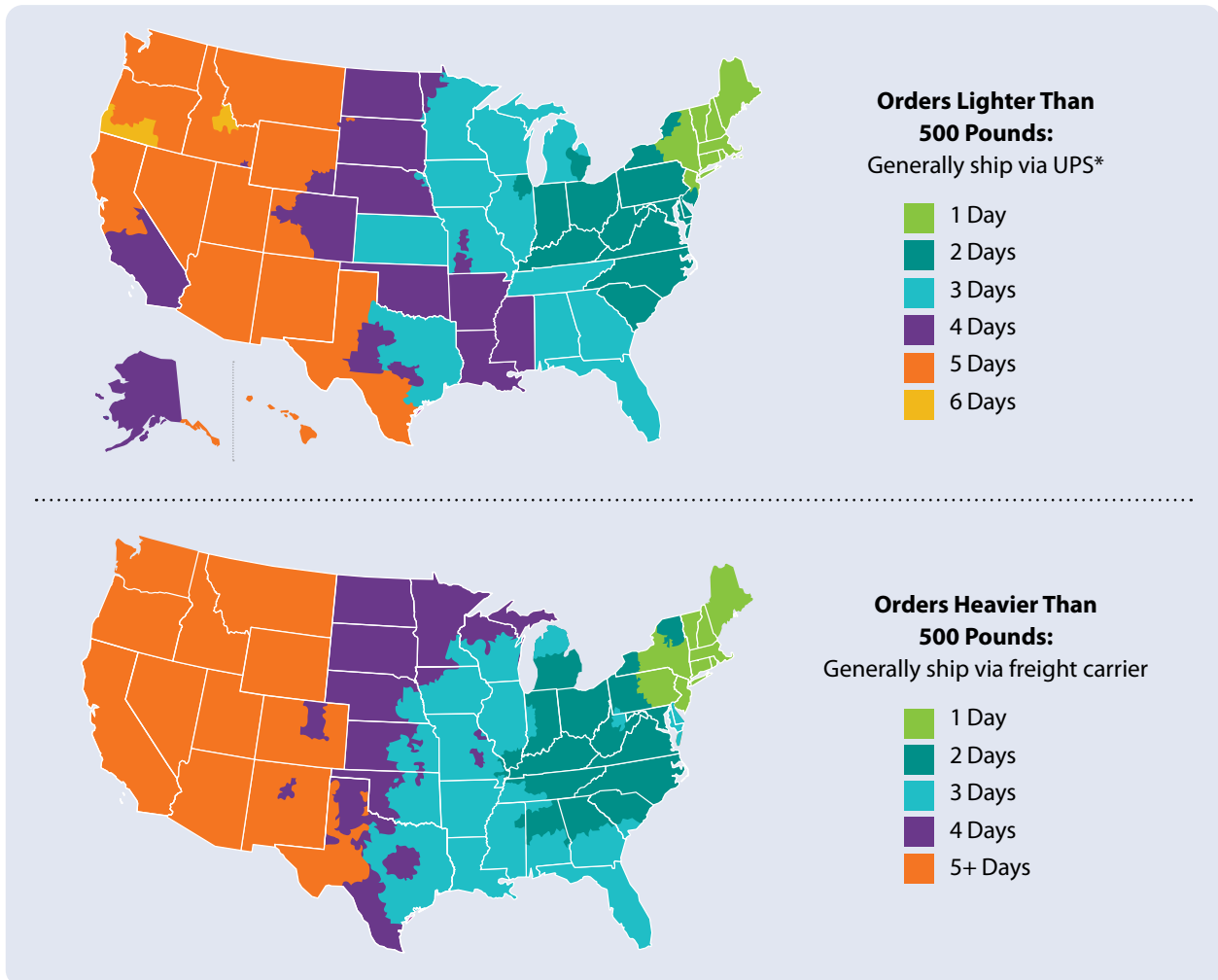
