Background Information:

On November 3, 2020, an election was held to fill Places 3, 4 and 5 on the Leander ISD Board of Trustees. Section 67.003 of the Texas Election Code provides that the canvass of the election returns must take place no earlier than the third day after the election date, and no later than the fourteenth day after the election date, provided the early voting ballot board has verified and counted all provisional ballots and timely received ballots cast from addresses outside of the United States. The window during which the canvass may be conducted for the November 3 election is November 6 through November 17.

The district does not expect to receive final results from Williamson County until November 16, so all documents will be loaded to BoardBook prior to the meeting.

UPDATE: The Travis County summary report and precinct level report have been uploaded to BoardBook. The Williamson County summary report has also been uploaded to BoardBook, see page 14 for the Leander ISD results. The Williamson County precinct level returns are available at:

Consequently, the report contain results for all entities and the precinct level report was too large to attach.

Administrative Recommendation:

Administration recommends the Board certify the election returns and declare the winner for each place.

Sample Motion:

I move that the Board certify the November 3, 2020, Trustee Election returns as presented by Williamson County and Travis County, and declare Christine Mauer the Place 3 winner with 41,646 votes, Anna Smith the Place 4 winner with 45,694 votes, and Jim MacKay the Place 5 winner with 55,314 votes.
