Superintendent's Report

January 2017

As you know, yesterday was Martin Luther King Day. Over the last few days there have been many events throughout the community, the state, and the nation honoring Dr. King and his work. Over 250 people attended the Annual Community Breakfast in Duluth, and through a simulcast provided by Minneapolis, which hosts a similar event, we had an opportunity to hear an address from author and civil rights activist Myrlie Evers-Williams. Ms. Evers-Williams is 83 years old and was the wife of civil rights activist Medgar Evers. She spoke of her experiences and her life working with her husband. She spoke of the passion and the drive it took to have their voices heard and how hard and tiring it can be. Her message to us is to not give up, and to not be discouraged. She believes that there are too many people focused on the negatives--we need to focus on building each up so that we can build up the entire community. She reminded us of Martin Luther King's words, "I have decided to stick with love. Hate is too great a burden to bear." Powerful words. Many thanks to everyone who helped organize and provide these opportunities. Our Annual Steps to the Future Pow Wow at Myers-Wilkins Elementary is coming up on Wednesday, January 25th, from 4:30 p.m. to 7:30 p.m. This is always a wonderful event where many people come together learn about career possibilities, share a feast and dance together. The Career and Higher Education Fair begins at 4:30 p.m., an invocation at 5 p.m., Feast at 5:15 p.m. and the Grand March begins at 6:00 p.m. I also want to remind everyone that next week marks the end of the semester; no school for students on Friday, the 27th, to allow teachers to prepare records for the semester. The second semester begins on Monday, January 30th. A note about winter in Duluth, Minnesota; I am pretty sure everyone is aware that it can get pretty cold and snowy! But as the saying goes, there is no such thing as bad weather, just bad gear! It is important that all of our students have the clothing they need to stay warm; jackets, boots, hats, mittens, scarves, whatever it takes! I want to encourage families who may not have the resources to provide warm clothes to contact someone at school; a teacher, social worker, the principal, the secretary, anyone, and they will be able to help you find whatever it is that a child needs. It's one of the best things about our community; people are very willing to help each other. And finally, I want to welcome and introduce our new Student Representatives to the School Board. Please welcome Ben Emmel from Denfeld and Cabrilla Francis from East. As

our last representatives have, Ben & Cabrilla will provide us with an update from the schools during the Superintendent Report. That being said, let’s hear from our Student Representatives.

Denfeld High School: Student Representative Ben Emmel introduced himself to the School Board and talked about dress up days during Spirit Week at Denfeld before the holiday break and the Jazz band touring of schools in the area. Denfeld’s men’s basketball team beat East for the first time since 1998! However, the East hockey team beat Denfeld. The Key Club held their second annual blood drive and over 250 students took part in an event to study for finals. Students collected over two tons of food for CHUM!
