Superintendent's Report

October 2017

October is Anti-Bullying Month. While bullying is something we work on year-round, this month we have an even greater focus on the importance of creating safe and welcoming environments. Bullying is a personal, emotional topic; one that we all have a connection to. I think most people could share a story either as a victim, a witness, or their own bullying behaviors sometime in their lives. Thanks to staff and community involvement, we have one of the strongest anti-bullying policies in Minnesota. We know that education is of the utmost of importance to making a difference. We need to be sure that staff, students, and families have the knowledge and skills they need to prevent, identify, and respond to bullying. There are resources

listed on our website along with an on-line bullying report form. We encourage anyone experiencing or witnessing bullying to make a report. All of us working together can make a difference. Social media is an important topic with direct links to bullying. Please take time to discuss and monitor online behaviors with your children. Everyone deserves to feel safe and welcome in our classrooms, our schools, and our community.

Another event that happened earlier this month was Walk to School Day to focus on healthy active lifestyles; several of our schools encouraged students and families to walk to school. Some of our schools had remote drop-offs so even students who usually ride the bus got to participate in this event by walking at least part of the way to school.

Last week was also the “Great Apple Crunch”, an event that encouraged healthy eating, specifically apples. Our Food Service Department worked with local partners to arrange for all students to receive apples during lunch last Thursday. I understand all of the apples were from Bayfield, Wisconsin. Many of the schools had conferences over the past two weeks. I know some are in progress as we speak. We want to thank all the staff for their efforts in preparing for conferences. The end of the grading period for middle and high schools is just around the corner on November 3rd.

In addition to our usual site visits, Assistant Superintendent Starzecki and I have been having meetings with staff in all the schools sharing information about some of our big projects this year. It is part of a larger plan to increase communication directly with staff in the buildings and to receive feedback on our plans moving forward. We look forward to continuing these meetings as we make our way through the district over the next few weeks.

I want to remind everyone that this is a short week for students. This Thursday and Friday is the annual Minnesota Education Association conference held in the Twin Cities. I understand we have many teachers traveling down for the conference. It is also a weekend that many colleges host family visits and I am sure there will be many families heading in all directions on college visits. This can be a very exciting time and we wish them safe travels. Finally, on to our student reports:

Denfeld High School: Student Representative Ben Emmel thanked the School Board for their two days off this week due to MEA conferences. The volleyball team is doing well and the football team had their first victory of the season. The girls’ swim team and boys’ soccer team are also doing great. The annual dodge ball contest was successful. Sixty-six juniors and seniors were inducted in the National Honor Society.
