The bid opening for 2010 Site Improvements at Birchview Elementary was held at the Administration Building on Tuesday May 18, 2010, at 2:00 P.M. A total of five (5) contractors submitted bids, as follows:

It is recommended that Midwest Asphalt Corporation, the low bidder, be awarded the base bid in the amount of \$249,800.00 and the alternate in the amount of \$28,700.00 for a combined bid amount of \$278,500.00.

The project includes a student drop off and pick up lane for parents, additional sidewalk and an expansion and reconstruction of the existing northwest parking lot. The Alternate Bid includes adding parking at the front entrance parking area. The Project also includes new parking lot lighting for these areas. The intent of the project is to improve safety during drop off and pick up times and provide additional parking.

The bids came in under budget and will be funded with bond dollars.

RECOMMENDED ACTION: Award the 2010 Site Improvements at Birchview Elementary to Midwest Asphalt Corporation for the base bid amount of \$249,800.00 and the alternate in the amount of \$28,700.00; a total bid award of \$278,900.00.

It is recommended that Commercial Systems, LLC, the low bidder, be awarded the base bid and alternate (included in base bid) in the amount of \$87,000.00.

The project involves work in twelve classrooms in the east corridor and includes the replacement of all light fixtures to a more energy efficient fixture. In addition, the ceiling system will be replaced from a one foot by one foot glued on ceiling tile (original to the building) to a more modern two foot by two foot ceiling system. The third phase of the project will be to add cabinetry for additional storage and to refinish the existing upper cabinetry. The balance of classrooms, primarily in the west corridor, will be completed next year.

The bids came in under budget and will be funded with bond dollars.

RECOMMENDED ACTION: Award the Oakwood Elementary School Ceiling Replacement to Commercial Systems for the base bid and the alternate in the amount of \$87,000.00.

The low bidder, Jan Lasserud Construction, Inc., asked to withdraw their bid due to an error made by a sub-contractor. The district accepted their request to withdraw. It is recommended that Donlar Construction Company, the second low bidder, be awarded the base bid in the amount of \$127,900.00 and the alternate in the amount of \$5,330.00, for a combined bid amount of \$133,230.00.

The primary focus of this project is to improve security at the Athletic Entrance during the school day, with a new visitor check in office. The project also includes a remodel of the Activities Office including a new entrance and new meeting room. A storage room will be added to allow parents easy access for dropping off larger equipment such as skis and golf bags (which are not allowed on the bus). The alternate is to provide a Trojan Logo in the new terrazzo floor similar to the front entrance, but in a smaller scale. The alternate will be funded by the Boosters organization.

The bids came in under budget and will be funded with bond dollars.

RECOMMENDED ACTION: Award the Wayzata High School Athletic Entrance Remodeling to Donlar Construction Company for the base bid amount of \$127,900.00 and the alternate in the amount of \$5,330.00; a total bid award of \$133,230.00.
