We request that the following recommendation be presented to the School Board for the award of the Wayzata East Middle School Locker Room Remodel project.

On April 10, 2012 eight (8) bids were received for the Wayzata East Middle School Deferred Maintenance and Improvements 2012 project. A copy of the bid tabulation is enclosed for your review. The bids received are of an acceptable range and reflect a fair value for the work involved. The apparent low bids received are within the budget established for the project.

The scope of the project includes the deferred maintenance and improvements in the upper level North West wing classrooms, i.e., replacement of the ceilings, lighting, flooring, and doors, repainting and refinishing walls, and addressing the accessibility in eight of the existing building toilet rooms.

Based on our review of the bids submitted, the selection of alternates does affect the determination of the low bidder. Through consultation with yourself, the following is our itemized recommendation for the alternates for your consideration:

Alternate No. 1 – Classroom Casework: **Add** **\$11,953**
Alternate No. 1 provide the cost to replace the existing tall storage cabinets in the classroom in their entirety in lieu of replacing only the doors and shelves as required under the base bid. The cost submitted provides a good value for the scope of the work.

Recommendation: Accept Alternate No. 1

Alternate No. 2 – Cafeteria Ceiling and Lighting: **Add** **\$25,100**
Alternate No. 2 provides for the complete replacement of the deteriorated cafeteria ceiling and lighting fixtures in lieu of no work as required under the base bid. The cost submitted provides a good value for the scope of the work, and will finish off the upper level rooms and provide a finished appearance.

Recommendation: Accept Alternate No. 2

Alternate No. 3 – Lighting Fixtures/ Lamps: **Deduct** **\$500**
Alternate No. 2 provides the costs for changing the light fixture lamp type from the based bid “T5” style lamps, to “T8” style lamps.

Recommendation: Reject Alternate No. 3

Based on these individual recommendations, we recommend that the District award a contract for the Wayzata East Middle School Deferred Maintenance and Improvements 2012 project to KUE Contractors, 130 Central Ave. South, Watkins, Minnesota, 55389, as follows:
