#### **Summary/Background Information:**

Texas Administrative Code (TAC), Section 89.1250, Required Summer School Programs, requires Districts to provide a summer school program for English language learners who will be eligible for admission to kindergarten or first grade at the beginning of the next school year. In accordance with TAC §89.1250(3)(b), Districts operating a two-semester system are required to offer the program for one-half day for eight weeks while school is recessed for the summer or for a total of 120 hours of instruction on a schedule established by the board of trustees. Districts operating year-round schools are required to offer a program during intercessions for a total of 120 hours of instruction.

We will be providing 80 hours of face-to-face instruction and 40 hours of asynchronous instruction, completed through reading logs, workbooks and online activities. There is no cost for students to attend for students who meet eligibility.

Our summer ELL program will operate from June 1 through July 1, for four hours each day, 8:00-12:00. Location to be determined.

The curriculum we are using for ELL summer school is an intentional reading and writing program, called Lit Camp. It is in both English and Spanish and provides small books of reading for each student. The program is specifically designed for a 20-day summer program for English Language Learners.

Eligibility requirements are students entering kindergarten or first grade and be identified as an ELL learner. We currently have 109 eligible students for ELL summer school. Participation is optional for parents. We plan to maintain a ratio of 22:2 for the students that register to attend.
