OF VOTES OF SCHOOL DISTRICT SPECIAL ELECTION
HELD ON NOVEMBER 2, 2021

BE IT RESOLVED by the School Board of Independent School District No. 108 (Central Public Schools), as follows:

1. It is hereby found, determined and declared that the special election of the voters of this district held on November 2, 2021, was in all respects duly and legally called and held.

2. As specified in the attached Abstract and Return of Votes Case, a total of [1380] voters of the district voted at said election on the question of the Approving the Issuance of General Obligation School Building Bonds (District Question 1), of which [1043] voted in favor, [337] voted against the same.

3. Question 1, having received the approval of at least a majority of such votes, is hereby declared to have passed.

4. As specified in the attached Abstract and Return of Votes Case, a total of [1376] voters of the district voted at said election on the question of the Approving the Issuance of General Obligation School Building Bonds (District Question 2), of which [944] voted in favor, [432] voted against the same.

5. Question 2, having received the approval of at least a majority of such votes, is hereby declared to have passed.

6. The school district clerk is hereby directed to certify the results of the special election to the County Auditors of Carver County and Sibley County.

7. The school district clerk is further directed to notify the Commissioner of Education of the results of the special election and to provide the certified vote totals for the ballot question in written form within 15 days after the results of the election have been certified by the school board.
