BE IT RESOLVED by the School Board of Independent School District No. 108 (Central Public Schools), as follows:

1. It is hereby found, determined and declared that the election of the voters of this district held on November 5, 2024, was in all respects duly and legally called and held.

2. As specified in the attached Abstract and Return of Votes Case, a total of [13,160] voters of the district voted at said election to elect four (4) board members to a term of four (4) years each.

3. The results of the election are as follows and the bolded candidates are elected:
