Only those invited by the Board may be present in the executive session. Mrs. Bradway, Mrs. Finch, Mrs. Rummel and Mr. Szymanski voted for the motion, which carried. Mrs. Rummel made a motion, seconded by Mrs. Finch, that based on the evidence and testimony received after a due process hearing, it is the finding of the Stafford Board of Education that between November 30, 2009, and December 23, 2009, Student F committed an expellable offense, namely that Student F threatened and bullied two fellow students; Student F physically harmed two fellow students; Student F sexually harassed two fellow students; Student F held one student down while that student was sexually assaulted by a third student; and Student F violated the Board of Education's Policy 5114 (a)-(l), Board Policy 5131.911 (a)-(c) and Regulation (a)-(h), Board Policy 5145.5 (a)-(c) and Regulation (a)-(c), and the disciplinary guidelines, as outlined in the Stafford High School 2009 – 2010 Student – Parent Handbook. It is the further finding of the Stafford Board of Education that such action constitutes conduct which is detrimental and an endangerment to the health, safety and welfare of other students, that such conduct is seriously disruptive of the educational process and that such conduct also violates a publicized policy of the Stafford Board of Education. Mrs. Bradway, Mrs. Finch, Mrs. Rummel and Mr. Szymanski voted for the motion, which carried.

However, Student F may apply for early readmission to school at the beginning of the second quarter of the 2010 – 2011 school year, by submitting an application to the Superintendent of Schools for consideration by the Board of Education no later than at its scheduled meeting on or about October 25, 2010. The Board will condition Student F's readmission on satisfactory performance in tutoring with no unexcused absences; maintaining a satisfactory academic record; attending counseling sessions previously committed to and scheduled by the parents at their own expense independently of these expulsion proceedings; completion of Student F's commitment to the six month program with the Eastford Baptist Church, as outlined by Pastor Vamosi; completion of a personal reflection essay discussing the seriousness of bullying and its impact on victims; and completion of sixty hours of community service in addition to the community service hours performed with the Eastford Baptist Church.

If Student F is granted early readmission and subsequently commits a violation of the Board of Education's policies and regulations warranting suspension or expulsion, then the original period of this expulsion shall be reinstated without further hearings.

Moved further that the Administration provide Student F with an alternative educational opportunity during the expulsion period.

Mrs. Bradway, Mrs. Finch and Mr. Szymanski voted for the motion. Mrs. Rummel opposed the motion. The motion carried by majority vote.

A. Proposed 2010 – 2011 Budget for the Stafford Public Schools

Dr. Fishman presented the proposed 2010 – 2011 Budget for the Stafford Public Schools. She stated that the proposed 2010 – 2011 budget is a .70% increase over the budget from 2008 – 2009, since last year's budget was a 0% increase.

The district's proposed budget is available on our web site at www.stafford.ctschool.net, under the Board of Education link.

Dr. Fishman said that in order to obtain a 0% increase last year, the district had to make the following adjustments to the budget:

- ✓ Cut 7.5 FTE certified positions, 1.0 FTE in administrative staff, and 4.0 FTE in non-certified staff. She noted that cuts to certified staff could have been much higher if the district did not introduce the retirement incentive.
- ✓ Cuts were made to supplies, textbooks, professional development, technology and repairs and maintenance.
- ✓ Savings were realized in medical insurance, life insurance and long-term disability insurance.
- ✓ The district was able to keep all of the athletic programs by introducing a transportation fee for traveling athletes.

Dr. Fishman highlighted the major reasons that she was able to keep the 2010 – 2011 budget at a .70% increase this year, as follows:

- ✓ During contract negotiations with the teachers, the teachers agreed to a 0% increase in 2010-2011.
- ✓ Administrators did an excellent job budgeting for equipment, textbooks, and supplies. Three of the five schools' budgets came in below last year's budget.
- ✓ Medical insurance bid came in at a 0% increase for next year.
- ✓ Savings in electricity due to a new consortium and projected fuel savings.

She also noted that there are needs that must be met in the 2010-2011 budget season, as follows:

- ✓ Scientific-Based Response to Intervention (SRBI), Connecticut's response to the federal NCLB law, which prescribes levels of intervention to meet student achievement needs in reading and math.
- ✓ The addition of a technician position to keep all of our technology, which has expanded beyond computers to interactive white boards and projectors, in repair. This is the only proposed new position in the 2010-2011 budget.

Dr. Fishman reviewed the district's accomplishments, goals and test scores for 2009-2010. Dr. Fishman then reviewed the entire proposed budget in detail. Mr. Bednarz gave a detailed presentation on the technology budget, Mr. Frassinelli gave a detailed presentation on the athletics budget, and Mrs. Linder outlined the upcoming capital projects. Dr. Fishman said that Dr. Lefebvre will be giving a presentation on the credit re-entry program to the Board in February.

Dr. Fishman summarized by stating that the proposed budget is a \$171,556 increase over the budget that the district had two years ago. She said that she and her staff have been very prudent and have worked very hard to prepare this budget, which is very responsible.

Mrs. Rummel had several questions about the budget. Dr. Fishman and Mrs. Devlin were able to answer most of them. Mrs. Devlin said that she would get back to Mrs. Rummel regarding the current cost of heating oil, and what costs are being offered for next year. There were no other questions from the Board members. Dr. Fishman asked that if Board members had any additional questions, they e-mail them to her as soon as possible so that she can prepare a response for the next Board meeting on Monday, February 8, 2010.

B. Audit Report for Fiscal Year July 1, 2008 – June 30, 2009

Dr. Fishman stated that Board members received an electronic copy of the audit report for the 2008-2009 school year, which is an addendum to the report for the Town of Stafford for the fiscal year ending June 30, 2009, as prepared by O'Connell, Pace, and Company, Certified Public Accountants. The report for the Stafford Board of Education relates to school year grant applications (Forms ED001 and SEDAC-G Data Adjustment Forms).

Dr. Fishman said that the first set of findings relate to the ED001 Educational Grant. The first two findings by O'Connell, Pace are entitled *Changes due to misstated expenditures*. She said that the first relates to adjusted information from school construction reports received from the Treasurer's office and the second relates to the way benefits are reported for the cafeteria. The third finding is entitled *Changes due to misstated tuition income*. She said that income to the Town of Stafford from the Town of Union was misstated by \$1,000. Findings four and five are related and are entitled *Changes due to misstated total appropriated expenditures*. She said that these errors occurred because a transaction was posted as a deposit on the Board side, but mistakenly reported as an appropriation on the Town side.

Dr. Fishman said that the second set of findings relate to SEDAC-G Data. There was an error in the report on two students who are serviced by programs for special education, which affected Excess Cost grant reimbursement.

Dr. Fishman said that these errors were minor and involved very little money.

Item VII. Public Forum

There was a question regarding why the expelled students can't be tutored at the credit re-entry program to save money. Dr. Fishman said that since this is a re-entry program, which is still a part of the high school, the expelled students are not allowed to attend since they are prohibited from all school grounds and school-sponsored activities.

Item VIII. Old Business

There was no Old Business.

Item IX. New Business

There was no New Business.

Item X. Personnel Matters**A. Authorization of Superintendent of Schools to Give Written Notice of Non-Renewal**

Mrs. Rummel made a motion, seconded by Mrs. Bradway, that the Board of Education authorize the Superintendent of Schools to notify in writing before April 1 any non-tenured teachers whose contract will not be renewed for the next school year. Mr. Fontanella, Mrs. Bradway, Mrs. Rummel and Mr. Szymanski voted for the motion, which carried.

There were no Student Matters.

Item XII. Adjournment

Mrs. Rummel made a motion, seconded by Mrs. Bradway, to adjourn the meeting. Mrs. Bradway, Mrs. Rummel and Mr. Szymanski voted for the motion, which carried. The meeting adjourned at 8:37 p.m.
