Public Comment at Board Meetings

All Board meetings, with the exception of executive sessions, will be open to the public. The Board invites the district's community members to attend Board meetings to become acquainted with the program and operation of the district. The public has a right to attend public meetings held in open session, and may be invited to share comments, ideas and opinions with the Board during designated times on the agenda. The Board may conduct a meeting without public comment.

Individuals with hearing, vision or speech impairments will be given an equal opportunity to participate in Board meetings and submit written comments to the Board. Individuals requesting assistance, aids or accommodations are encouraged to notify the district at least 48 hours prior to the Board meeting with the request, consistent with Board policy BD/BDA – Board Meetings.

Procedures for Oral Public Comment

The Board establishes the following procedures for public comment at Board meetings held in open session. The information will be accessible and available to all patrons accessing or attending such a Board meeting.

1. Public comment is limited to its designated place on the agenda and while time allows.
2. A person wishing to provide public comment, if an opportunity is provided by the Board during a meeting open to the public, will submit their request and name electronically prior to the Board meeting.¹ A request to give public comment in-person or electronically does not guarantee time will be available.
3. A person speaking during the public comment portion of the meeting may comment on a topic not on the published agenda.
4. A person speaking during the public comment portion of the meeting should state their name, whether they are a resident of the district, and, if speaking for an organization, the name of the organization. A spokesperson should be designated to represent a group with a common purpose.
5. A person giving public comment is limited to an established time limit of three minutes. Statements should be brief and concise. The Board chair has discretion to waive time limits or extend the overall time allotted for public comment. Additional time will be allocated in a fair and equitable manner. If a person has more comments than time allows or is unable to comment due to time constraints, the

person is encouraged to submit additional written comments to the Board through the district office as directed.

6. Inquiries from the public during the designated portion of the agenda will not generally be responded to immediately by the Board chair, and may be referred to the superintendent for reply at a later date. The Board will not respond to inquiries that are expected to be addressed during another designated portion of the agenda.

The Board will not hear public comment at Board work sessions.

Topics raised during the public comment portion may be considered for inclusion as agenda items at future Board meetings.

Procedures for Written Comment

Members of the public may submit written comments or materials to the Board at any time at the district office, by mail or by email to comments@blachly.k12.or.us . Materials or comments submitted at least 72 hours in advance of a Board meeting will be provided to the Board before the Board meeting. Written materials or comments submitted may not warrant action by the Board.

Comments Regarding Staff Members

A person speaking during the designated portion of the agenda for public comment may offer objective criticism of district operations and programs. The Board will not hear comments regarding any individual district staff member. The Board chair will direct the visitor to the procedures in Board policy KL - Public Complaints for consideration of a legitimate complaint involving a staff member. Any association contract governing the employee's rights will be followed. A commendation involving a staff member should be sent to the superintendent, who will forward it to the employee, a supervisor and the Board.

Board Chair Pennel called the meeting to order at 6:03 pm.

4. PUBLIC FORUM/COMMUNICATIONS

There were no public communications submitted.

5. CONSENT AGENDA

5.1. BOARD MINUTES

Director Drago asked that her attendance on 8/17 be corrected to reflect present. She came in late but was not absent. Also, the same correction for Director Eastburn's attendance on 8/24. He came in late to the meeting. After reviewing the minutes it is seen that the update in attendance was included, it is just further down as it happened at a later time in the meeting. No corrections are needed.

5.2. FINANCIAL REPORT

Business Manager Pat Rufo shares the Audit letter for the board members to sign and return. Ms. Rufo shares the revenues paid, everything seems to be on track with budget. The current budget is based on lower numbers than where we are sitting. Payroll for September was just completed and we are on track with payroll expenses. We have 2 more payments on the modular classrooms and then we will completed on that payment. All funds report and check register was shared with the board. The AP turnover process from LESD was a little slow, but is now transitioned over.

5.3. SECOND READ BOARD POLICY

There were no additional questions in regards to the policies presented. Director Schiesser suggests that instead of having a list of wording for exclusion in our policies, we need to be very clear in all our policies that it includes all our students.

5.4. RESIGNATION

Superintendent Watkins shares that David Parker has resigned his permanent full-time driving position. He does plan to sub for us still. Sheri Baker has filled the bus driving hours vacated. We also have a full-time bus driver position posted currently.

Board Chair Pennel asks if we have any other positions open. Superintendent Watkins shares that we have a part-time playground assistant position open internally at this time.

5.5. NEW HIRES

Superintendent Watkins shares the MS coaching positions hired.

5.6. BOARD APPOINTED COMMITTEES

Superintendent Watkins shares where the board is sitting on committees at this time. There are no additional committees to share or add at this time.

5.7. MOTION

6. REPORTS

6.1. ENROLLMENT

Superintendent Watkins shares that the enrollment has been sitting pretty steady at the start of the year.

6.2. CHARTER BOARD REPORT

Charter Board President Lisa Wagner shares that Sara Walden resigned from the Charter Board. They discussed the continued goal to work with the school board and the desire to join in a joint meeting with the school board to address the charter board contract. The community representative shared that they have had a lot of reports of concern about the new AVID program. Also, the representative shares that they have heard there is a desire for an in-district activity bus route for activities and sports.

Director Eastburn asks what the feedback was about the AVID program. Ms. Wagner shared that there were at least 3 different families publicly who shared negative feedback about AVID.

6.3. FACILITIES REPORT

There were no questions in regards to the maintenance report. The playground is going to be on time, the shipping date is October 19th and installation should be the first week of November.

6.4. TRANSPORTATION/TECHNOLOGY REPORT

Director Eastburn asks about the NFHS streaming system in the gym. Is it currently working? Superintendent Watkins shares that it is currently in use, you can just set up your account and pick our team and you will get all the games. Superintendent Watkins shares that he and Dennis are looking into whether there is a way to move that camera so that we can also record other events such as music concerts and graduation. We would need to look into sound as well to go with it.

6.5. PRINCIPAL'S REPORT

Ms. Bottensek shares that all language arts curriculum has arrived and teachers have started using it. AVID is in full swing at all grade levels. The focus is binders for elementary and focused notes for MS/HS. Each month has a different focus with AVID. Next month we will be starting on a grade level curriculum. There are some families who are not sure about the program. Ms. Tripp, Ms. Severino and Ms. Bottensek has been having conversations with families to educate them on the program. This is about getting common practices across the school.

Board Chair Pennel asks if it is fair to say that right now the AVID program is focused on how to take notes and organization. Ms. Bottensek shares that it is really about getting them to engage with their notes.

There is a fall welcome back night on October 6th from 5-6:30 pm, dinner will be provided and at 6:15 there will be an AVID presentation for parents. On September 28th we have senior parents' night. This will include the class representatives, HS coordinator and Lisa Wagner as the senior project coordinator.

This year Ms. Bottensek sends out a weekly summary on Monday mornings to staff and then shares this on ParentSquare with families. Board Chair Pennel asks if the events calendar is being shared. Ms. Bottensek shares that the events calendar is also on the homepage of our website now. Sports update; MS & HS volleyball and football are all going now. We are running 2 activity buses, 5:50 pm and 7:50 pm.

We are looking at adopting a new health curriculum. Our current health curriculum is very outdated. We started this process before covid, but then it was never followed up on when we returned to on campus learning. Ms. Bottensek hopes to order some sample texts and have them available for review in a month or so.

October 10-14th is homecoming week and that Friday is the homecoming game.

6.6. SUPERINTENDENT'S REPORT

Superintendent Watkins would like to share what an amazing job our admin team and our teachers have done with implementing AVID. Change is hard and our staff have embraced it fully and with excitement. We really feel this is a good direction for our school. We are doing a redesign of the Triangle Lake website. We are working to get an events calendar widget on the homepage of our website and also on the district website. Hope is that this can be rolled out mid winter, and the web address will not change. Board Chair Pennel asks, don't we have 3 different websites? Why can't we combine them? Superintendent Watkins shares that we need people to understand that there is a difference in the things we do. District, campus and online need to be kept differentiated.

Grange update, we have reached out to legal representation but after some conversations we don't feel they can support us. We have gotten some other leads of other representatives and hope to find someone soon. We plan to continue to try to set up a time to work with the grange members and continue collaboration.

We hope to push out one more time to the community in regards to our Portrait of the Graduate. We will have this in front of the board in October.

We are in the beginning stage of our long range facilities assessment. We have recently been getting some data from them and we have been giving them information back. The goal is to get some survey information out to the community, then we hope to have a presentation in November for the community and then a final presentation of the assessment to the board in December.

There is a plan to hold a work session where they can be updated on the organization, procedures, etc. of that program from Ms. Bottensek. There was also concern about the level of communication from the District Board and the Charter Board expressed a desire to make a specific plan with the District to address the potential contract non-compliance issues.

This year's goals were discussed and a plan for election of offices will be held at the next meeting. We currently have one position open and are looking forward to the Elementary Teacher to fill that position.

Board Maintenance Report

October 13, 2022

MODULAR OFFICE

The Modular office building project is no longer “pending”.

Initial Excavation and infrastructure has been completed and the approved plans have been picked up at the county.

Next steps include the foundation connecting utilities and storm drains and placement of the building.

Finishing touches on exterior concrete, lawns and irrigation will be worked on weather permitting.

PIONEER CONNECT

The location has been prepped for the installation of the pioneer connect building. With a gravel pad, driveway and power and low voltage conduit in place.

The electrical service will need to be upgraded to meet the loads of the existing service and the Pioneer building. Plans for this part of the project are scheduled after the last football game to reduce impact on field lighting and scoreboard power.

Modern Structures is working on the final documents for Lane County so a temporary permit can be obtained. Building is set to be operational by the end of December.

ADDITIONAL PARKING

With the excavation for the new modular office we were able to expand parking on the north side of the road. It will be graveled and ready for use by the end of October.

PLAYGROUND

We still waiting for the equipment to arrive and we hope to see it here by the end of October.

Installation is still scheduled for November or first part of December. (Weather Permitting)

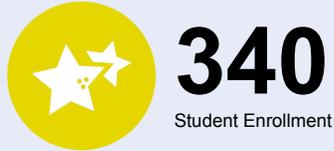

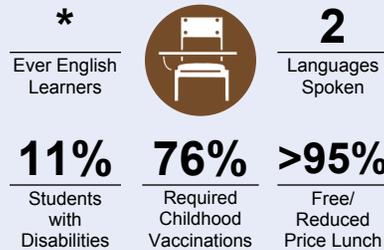
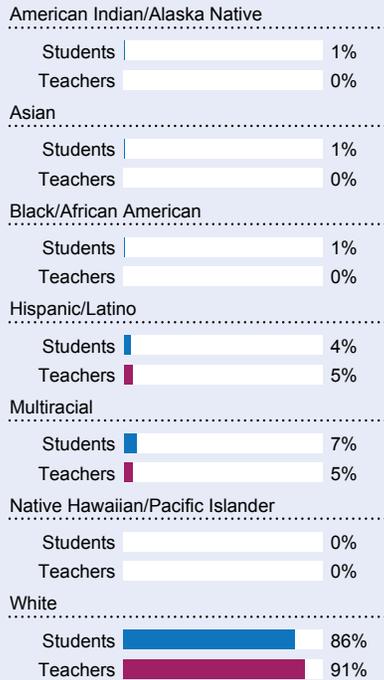

DEMOGRAPHICS

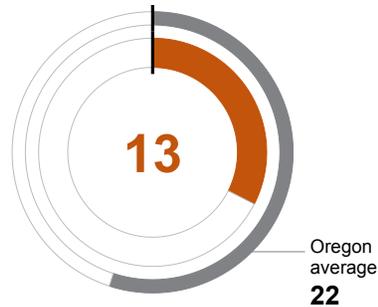

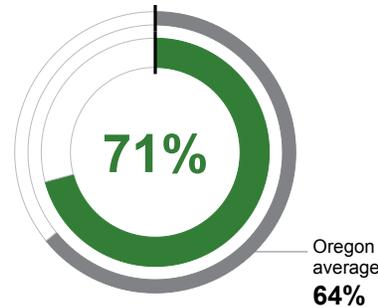
CLASS SIZE

REGULAR ATTENDERS

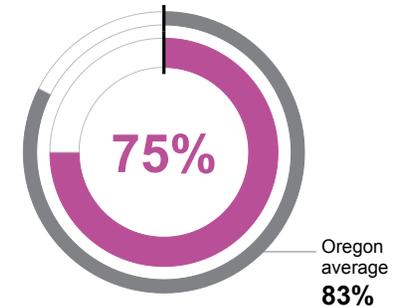

ON-TRACK TO GRADUATE

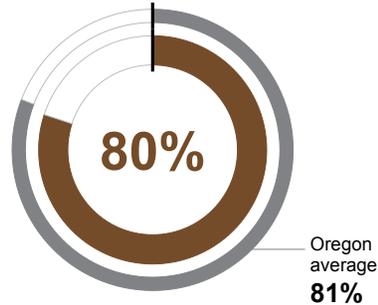
Students earning one-quarter of graduation credits in their 9th grade year.

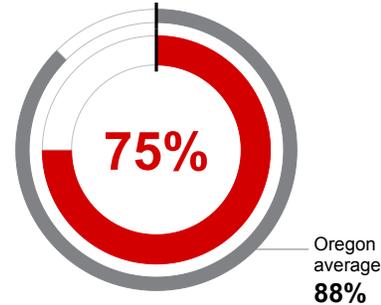
ON-TIME GRADUATION

Students earning a diploma within four years. Cohort includes students who were first-time ninth graders in 2017-18 graduating in 2020-21.



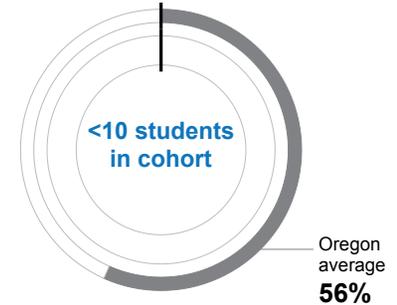
FIVE-YEAR COMPLETION

About Our School

ADVANCED COURSEWORK

Providing students opportunities for individualized education is a mission of TLCS. Students seek advanced studies by various means. In the small school, several mechanisms for obtaining college credit exist, and from year to year students access different opportunities. For those on track and eligible, myriad advanced electives are offered online, including Advanced Placement courses. Some students take college courses online, primarily from Lane Community College and Oregon Universities. Others attend on-campus at Lane Community College. The addition of Measure 98 funding has positively impacted our ability to offer advanced options for students who are not served by our traditional Expanded Options program.

CAREER & TECHNICAL EDUCATION

TLCS career education begins in middle school, and for most students five of the six final years include one career class. TLCS offers college credit in five CTE courses--CAD, Woods 1, Woods 2, Welding 1, and Welding 2. In 2019-20 we added manufacturing. Our career education staff offer students multiple opportunities each year to attend industry visits, college technical programs, career fairs, and explore apprenticeships. The senior project is a career-related capstone. All students are enrolled in VoTech classes beginning in sixth grade.

EXTRACURRICULAR ACTIVITIES

Football, Volleyball, Cross Country, Wrestling, Men's & Women's Basketball, Track & Field, Baseball, Drama, Student Government, Band, Hi-Q (quiz bowl), Battle of the Books, Game Club, Archery, and several other student lead clubs.

PARENT & COMMUNITY ENGAGEMENT

Elementary holds a spring Jog-A-Thon with significant help from parent and family volunteers. Students actively participate in a Mr. Laker Pageant raising funds for Children's Miracle Network and benefitting our local NICU. Booster Club provides significant support for our athletic programs. The Charter Board has a community member seat, and the school seeks to engage out of district parents. Our social media presence is now fully established, and we have seen an increase in our ability to inform our patrons, as well as to promote and publicize school and classroom activities and events. A full redesign of the district website was completed and we are in the process of a redesign of our school website as well.

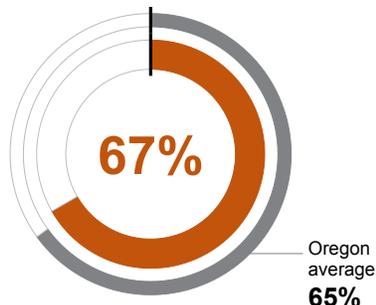

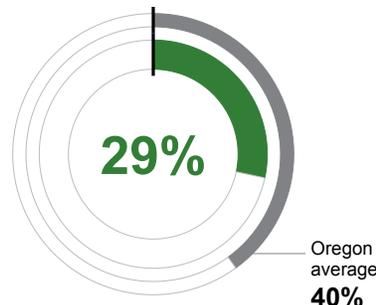
Grades K-2 REGULAR ATTENDERS

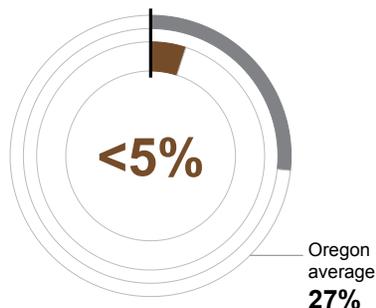

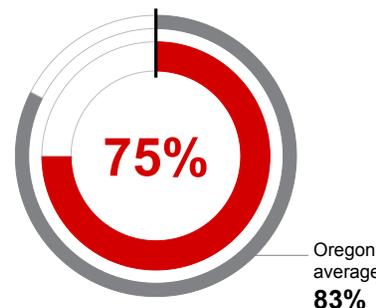
Grade 8 MATHEMATICS

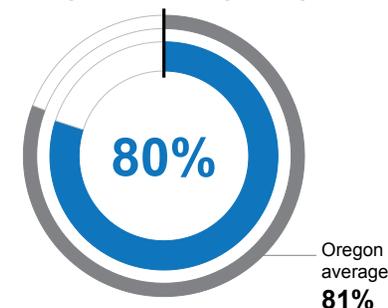
Grade 9 ON-TRACK TO GRADUATE

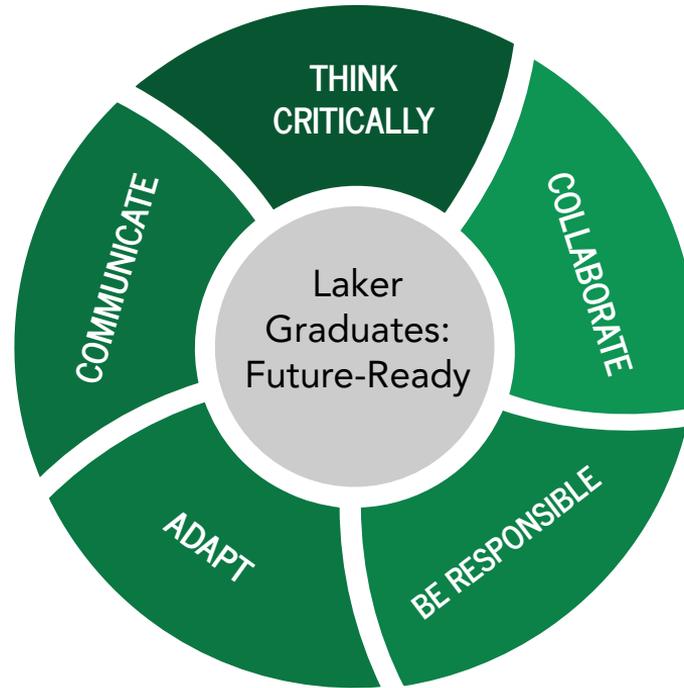
