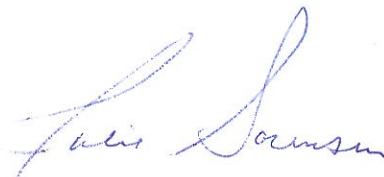

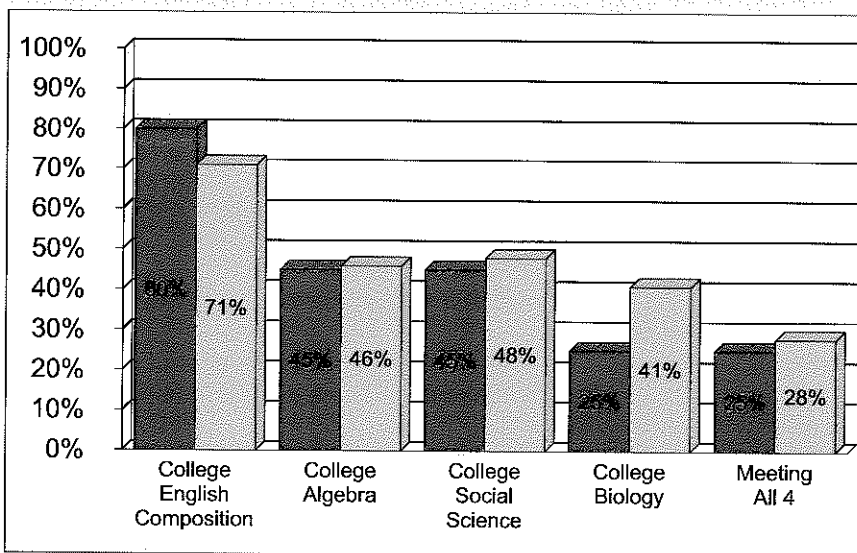

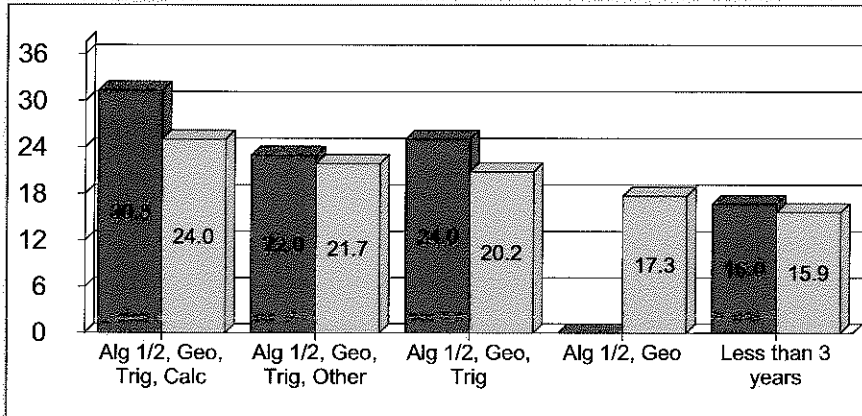

**Figure 2. Average ACT Mathematics Scores by Course Sequence**

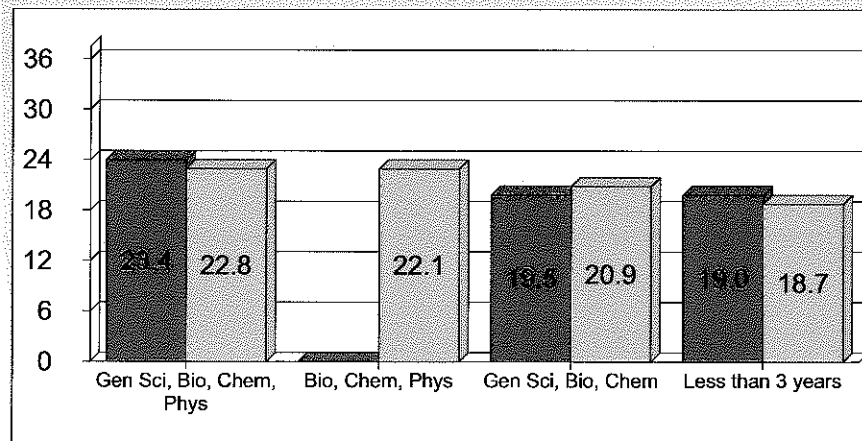


### Value Added by Mathematics Courses
