SECTION 1. Tennessee Code Annotated, Section 49-5-413, is amended by adding the following new subsection:

(d) (1) Any person, corporation or other entity who enters into or renews a contract with a local board of education or childcare program as defined in Section 49-1-1102 on or after the effective date of this act shall be required to comply with the provisions of this subsection if the contract requires:

(A) The person or an employee of the person, corporation or other entity to have direct contact with school children or to children in a childcare program; or

(B) The person or employee access to the grounds of a school or childcare center when children are present.

(2) It is the duty of the person, corporation or other entity who employs a person described in subdivision (1) to require such applicant to supply a fingerprint sample and submit to a criminal history records check to be conducted by the Tennessee Bureau of Investigation and the Federal Bureau of Investigation prior to permitting the person to have contact with such children or enter school grounds.

(3) (A) No employer, or employee of such employer to whom this subsection applies shall come in direct contact with school children or to children in a childcare program or enter the grounds of a school or childcare center when children are present until the criminal history records check has been conducted on such person.

(B) No employer, or employee of such employer, to whom this subsection applies shall come in direct contact with school children or to children in a childcare program or enter the grounds of a school or childcare center when children are present if the criminal history records check indicates that the employer or employee has been convicted of an offense that, if committed on or after July 1, 2007, is classified as a sexual offense in Section 40-39-202(17) or violent sexual offender in Section 40-39-202(25). (B) (i) If an employee is convicted of an offense that, if committed on or after July 1, 2007, is a sexual offense as defined in Section 40-39-202(17) or a violent sexual offense as defined in Section 40-39-202(25), after the employer has conducted a criminal history records check on such employee, the employee shall notify the employer of such conviction within seven (7) days from the date of conviction.

(ii) An employee commits a Class A misdemeanor, punishable by fine only, who knowingly fails to disclose to the employer within the required seven (7) days that the employee has been convicted of an offense specified in subdivision (C) (i).

(4) The provisions of this subsection shall only apply if the employer or employee of such employer comes in direct contact with school children, children in a childcare program or enter the grounds of a school or childcare center when children are present during the ordinary course of performing a function required or permitted by the terms of the contract. Any action involving direct contact or entry by an employee which is outside such ordinary course of performing a function required or permitted by the terms of the contract shall not in any way be deemed to be authorized or approved by the employer and such employer shall not in any way be deemed to be liable for such contact or entry, vicariously or otherwise. However, nothing in this subsection shall authorize such contact or entry by an employer or employee of such employer if contact or entry is prohibited by any other provision of law; provided that with respect to such contact or entry, the person, corporation, or other entity who employs a person described in subdivision (1) shall not in any way be deemed to be liable, vicariously, or otherwise, for any such actions taken by the employee unless such employer has actual knowledge that such other provision of law prohibits contact or entry by an employee.

SECTION 2. This act shall take effect September 1, 2007, the public welfare requiring it and shall apply to all applicable contracts entered into or renewed on or after the effective date of this act.

WHEREAS, the future successful operation of the University School depends on a cooperative relationship between the Washington County Board of Education and the State University and Community College System of Tennessee, East Tennessee State University, the parties recognize and acknowledge those mutual responsibilities and pledge the future operation of the school pursuant to the terms and statutes and the terms and provisions of this contract; and

WHEREAS, by reason of the foregoing, the parties have determined that it is in the general best interests of all parties hereto and the personnel and students at said University School, that the entire matter of operation of said school be reviewed and that the former contract be cancelled and a new contract be entered into between the parties.

The previous contract between the parties, dated and signed for the University System on February 25, 1980, for ETSU on February 15, 1980, and for the County Board on February 15, 1980 (hereinafter called the 1980 Contract) is hereby cancelled and rendered null and void and for nothing further held.

3. That pursuant to the provisions of T.C.A. Section 48-8-105(b) T.C.A., the control of said University School shall be wholly under the direction of the State University and Community System of Tennessee through the president of ETSU, including but not limited to the following specific responsibilities:

a. The furnishing of all buildings, equipment, heating, lights, water, custodial service, maintenance and repair as well as all furnishing of all personnel necessary for the operation of said school.

b. The responsibility for salaries, assignment, supervision, retention, promotion, tenure, discharge and control of all of the professional, administrative, secretarial, and support personnel of the University School shall be wholly under the direction of the State University and Community College System.

The County Board will cooperate in verifying all state and federal curricula requirements and any reports, applications for funds, services or certifications or actions which are required

of the Washington County Board by state or federal law or policy will continue to be done by the school board. The University System will furnish the County Board all data necessary for such verification at no expense to the County Board.

4. That the University System shall be entitled to and shall receive all state and federal funds received by the county as a result of this contract for the operation of said school including per capita and pro rata share of allocations and equalization funds, state capital outlay funds, textbook funds, and enumerated other funds limited to an ADA proportional share of sales tax, property tax, interest and penalty on delinquent tax, business tax and marriage license fees, that may be allocated for the operation of all public schools in Washington County, Tennessee, but the proceeds of local bond issues and local capital outlay notes are specifically exempted from this contract.

5. The County Board will comply with all state and federal statutes relative to the receipt of special grants and fund which are conditioned upon the retention of management or control by the County Board, and in such eventuality, only to the extent as required by law, it being the intent of this contract that the total management, operation and control of said University School shall be in the University System and that the County Board shall retain no responsibility unless required by law so to do, except that the County Board will provide limited bus service, food service, and other similar specific services that have been provided in the past relationship between the parties.

Regardless of anything else herein to the contrary, the County Board acknowledges legal responsibility as the local educational agency under 20 U.S.C.A. Section 1401, et. seq. (Education for All Handicapped Childrens' Act), T.C.A. 49-10-101 etc., and this contract does not in any way alter or change those responsibilities.

6. That each party hereto will be responsible for its own actions insofar as liability to any third party is concerned, and it is further agreed that neither party will be responsible for the actions of the other in any phase of the said University School.

7. The University System acknowledges its legal responsibility for all personnel actions taken by the University to employees hired under the terms of the herein contract. That legal responsibility for personnel actions and any

actions by an employee is defined and limited by the terms of T.C.A. 9-8-301 et. seq. and the individual tenure-track, administrative and secretarial contracts entered into with the employee and the University. The University agrees to include the following language in any new contracts signed subsequent to the effective date of the contract: "I hereby voluntarily and knowingly waive any tenure or tenure rights, if any, previously acquired in the Washington County School System". It is the basic premise of this contract with regard to liability in the operation of said University School that each party hereto will be responsible for its own actions and neither should be held responsible for the actions of the other.

8. This contract contains the complete agreement between the parties and nothing herein shall be construed to include any obligation, custom or practice not specifically included herein, and any amendments or modifications hereof shall be in writing and agreed upon by the parties and signed by the respective parties and attached hereto.







MASTER AGREEMENT

between

EAST TENNESSEE STATE UNIVERSITY

and

_____ **BOARD OF EDUCATION**

East Tennessee State University (“ETSU”), a State of Tennessee public institution of higher education, and the _____ Board of Education (the “Board”) (collectively “Parties”) enter this Agreement, effective the _____ day of _____, 2024, relative to the funding and operation of a training school for practice teachers on ETSU’s campus (the “School”).

Recitals

Whereas, ETSU, under the direction of its Board of Trustees (“Trustees”), maintains a training school pursuant to Tenn. Code Ann. § 49-8-105, as amended effective May 11, 2023 (the “Act”), for the purpose of providing practice teaching experience for teachers in training; and

Whereas, ETSU teaches the students enrolled in the School the same course of study as prescribed by the state board of education for the public school system in grades kindergarten through twelfth grade (K—12) or the grades appropriate for the school; and,

Whereas, the Act authorizes ETSU, acting through its Trustees, to contract with a local board of education to provide for the teaching of public-school age children in the training school, whereby the training school shall receive all state and federal funds received by the local board of education because of this contract for the operation of the training school, including TISA allocations and any other funds that may be allocated for the operation of public schools of this state; and,

Whereas, the School is eligible to receive grants and other funds in the same manner as the public schools in this state; and,

Whereas, the School is wholly under the control of the president of ETSU; and,

Whereas, ETSU desires to contract with the _____ Schools Board of Education to provide the teaching of public-school-age children in the training school, whereby the training school shall receive all state and federal funds received by the local board of education because of this contract for the operation of the training school, including TISA allocations and any other funds that may be allocated for the operation of public schools of this state; and,

Whereas, the Board recognizes the benefit of contracting with ETSU to maintain a training school for the purpose of providing practice teaching experience for teachers in training; and,

Whereas, the Parties desire to codify the terms and conditions of their relationship; and whereas, the Parties intend for this Agreement to govern their relationship and thereby terminate all prior agreements between the Parties;

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein and for other good and valuable consideration, the receipt and sufficiency of which the Parties acknowledge, the Parties agree as follows:

A. Recitals Incorporated

The Parties incorporate the Recitals herein by reference and make them a part of this Agreement.

B. Legal Structure and Authority

1. ETSU operates the School under the authority of and pursuant to Tenn. Code Ann. § 49-8-105, as amended effective May 11, 2023, which authorizes ETSU to maintain a training school for grades pre-K—12 for the purpose of providing practice teaching experience for teachers in training.

2. ETSU has an Education Preparation Program with a mission of preparing highly educated teaching professionals from early childhood, elementary through secondary education and across all areas including special education, physical education, and the next generation of educational leaders and student services professionals. The School furthers the mission of ETSU by providing a research and training ground for educator candidates and other school professionals.

3. ETSU operates the School, under the direction of its Trustees and as required by law the School is under the direct control of the president of ETSU.

4. ETSU, under the direction of its Trustees, enters this contract pursuant to Tenn. Code Ann. § 49-8-105(b), as amended effective May 11, 2023, to operate a training school for students in grades K—12.

5. While Tennessee law authorizes ETSU and Board to contract for the operation of pre-K, ETSU does not currently offer pre-K at the School and this agreement does not require it to add pre-K. If the Parties decide to add pre-K to the School operations, the Parties may amend this agreement to that effect.

C. Financial

1. The Board shall allocate state and local county education funds to ETSU in an amount equal to the per-student state and local funds allocations the Board receives. Funding sources shall include: TISA funding (base, weighted, direct, and outcomes-based), equalization funds, state capital outlay funds, and enumerated other funds limited to an ADA proportional share of sales tax, property tax, interest and penalty on delinquent tax, business tax, and marriage license tax.

2. To the extent the Board receives state and/or federal funds, including grant funds, based upon the School's students, the Board shall allocate those funds, except as referenced herein, to ETSU based on the method utilized to calculate the state or federal funding allocations to the Board. These methods include, but are not limited to, allocations determined based on the direct certified student population in a school, and TISA outcomes funding based on school's performance percentage.

3. The Board shall include the School in any capital or special funding requests from local, state, or federal funding sources.

4. During the first fiscal year of the term of this Agreement and each subsequent fiscal year during the term of this Agreement, the Board shall pay the allocation to ETSU from the allocations the Board receives from per pupil state and local education funds in ten (10) installments, each installment being due and payable on or before the 20th day of the month during said fiscal year as the Board receives allocations from state and local education funds. The Board shall not pay installments of state funds in May and July but shall pay installments of local funds. The first installment is due and payable on or before August 20 of each academic year. The Parties acknowledge and understand that Board will make payments to ETSU from funds the Board receives from state and local education funds.

5. The Board and ETSU shall comply with the provisions of state and federal laws that govern the allocation, receipt, and reporting of per student state, local, and federal funds the Board receives and all allocations under federal law or regulation, including, but not limited to, Title I, Title II, and Every Student Succeeds Act (ESSA) funds. As needed, the Board may act as fiscal agent for grant funds that the grantor has specifically identified for ETSU or which Board obtained because of ETSU, in compliance with this Agreement, state, and federal laws, and in compliance with such regulations as provided by the Tennessee Department of Education.

6. ETSU shall be responsible for reimbursing the Board for all fines, including, but not limited to, all fees and lost revenue, known or unknown at the time of the violation, that the Board incurs because of ETSU's actions. For all such violations, the Board reserves the right to not renew this agreement, revoke the agreement, or withhold funds from ETSU.

7. The Parties understand that they are responsible for their respective Other Post-Employment Benefits. The Parties will amend this Section of the Agreement according to any changes in the law.

8. ETSU shall own all property, improvements, furnishings, and equipment purchased with public funds, subject to complete satisfaction of any lawful liens or encumbrances. ETSU shall submit all required compliance documents for federal programs to the Board's Office of Federal Programs and Grants by the designated deadlines. Further, ETSU shall make all expenditures with federal funds in compliance with federal laws and regulations governing use of the funds.

9. ETSU shall be responsible for using allocated funding exclusively for operation, administration, employment, and other expenses of the School.

D. Admission and Enrollment

1. **Non-discrimination.** The School shall make student recruitment and enrollment decisions in a non-discriminatory manner and without regard to race, ethnicity, religion, national origin, English language proficiency, academic or athletic ability, sexual orientation or the need for special education and related services. The School will enroll students consistently with all applicable state and federal laws.

2. **Admissions and enrollment process.** The Board shall have no responsibility for the School's admission and enrollment process, except for allowing the School the option to access PowerSchool or other student management system for purposes of student scheduling, reporting, and data management.

3. **Tuition.** Nothing in this Agreement shall restrict School's ability to charge tuition to non-county resident students, if at any time, School determines it is in School's best interest to do so.

E. Curriculum and Instruction

1. **Statutory and Regulatory Compliance.** ETSU operates the School under the direction of its Trustees, which put the School wholly under the control of the ETSU president; therefore, ETSU shall have independent authority regarding the design and implementation of its educational program, but shall operate its academic programs in accordance with state and federal law as well as according to the standards prescribed by the Tennessee State Board of Education for the Tennessee public school system.

2. **Academic Calendar.** The School shall develop its instructional calendar in its sole discretion in accordance with state and federal laws.

3. **Assessment.** The School will perform assessments in accordance with state and federal mandates and in alignment with the School's curriculum. The School may perform any supplemental assessments beyond state and federal mandates in its discretion. The Board may use the School's assessment data for submission to the state Department of Education and in compliance with any other state or federally mandated data requirements for reporting educational progress. The Board may use the School's assessment data for any other purpose only in accordance with any data sharing agreements or otherwise with ETSU's prior written approval.

F. Student Administration

1. **Policies.** ETSU operates the School under the direction of its Trustees, which put the School wholly under the control of the ETSU president; therefore, ETSU has independent authority to adopt policies in its discretion and in accordance with state and federal law. The School may, in the exercise of its sole discretion, adopt and adhere to the Board's policies as set forth in the _____ Schools' student and parent handbooks and policy manuals, including utilization of the processes and procedures set forth therein.

2. **Student Discipline and Due Process.** The School shall administer its discipline policy in accordance with its policies and applicable state and federal law. The School shall ensure that it protects its students' due process rights, including through provision of appropriate hearings. The School shall promptly notify the Board of students it expels. Board shall provide the School's expelled students access to the Board's alternative school programs in the same manner as it provides access to any student within the LEA. If the expelled student came to the School from a public school system outside the Board's authority, the School and the Board may refer the expelled students to their home school. The School shall reimburse to the Board state and federal funds allocated to the School for students enrolled in the School who are subsequently expelled, referred to, and attend a Board alternative school. The School and the Board shall calculate the reimbursement amount based on the number of days the student(s) attended the Board's alternative school. Expelled students shall not be eligible to return to the School.

3. **Title IX and Child Abuse Reporting.** The School shall comply with Title IX of the Education Amendments Act of 1972 and state of Tennessee child abuse reporting requirements.

ETSU and/or the School, as determined in ETSU's sole discretion, shall fully perform investigations, and required actions of any reported Title IX and/or child abuse matters. ETSU and/or the School shall retain full responsibility for the personnel management and/or discipline of the School's employees and students as it relates to such allegations.

G. Food Services

The Board shall provide cafeteria services, including staffing and kitchen and food service equipment needed to provide such services, for the School in the same manner as it provides food services for other schools within the local education agency ("LEA"), including appropriate inspection and repair. Equipment already installed and in use is sole property of School. Board will provide meals in accordance with federal and state laws. The Board shall retain any of the School's state and federal funds, received pursuant to Tennessee Code Annotated, Section 49-8-105, and use those funds for the food services referenced herein.

H. Transportation

1. Board shall be responsible for providing transportation services to students requiring such services as provided in the students' IEPs or Section 504 plans but shall not be responsible for providing any other transportation services for the School's students except that the Board will provide limited bus services that have been provided in the past relationship between the parties.

I. Information Technology and Support

1. The Board will allow the School to access technical/helpdesk support provided by Board vendors for current or future programs provided for state/federal funding sources (such as student management system, universal screener, state required testing materials, systems, and software, etc.)

2. Except as stated above, ETSU shall be responsible, financially, and otherwise, for IT services for the School.

J. Exceptional Education

1. The Board shall be legally responsible as the LEA for special education services for students who are eligible under the Individuals with Disabilities Education Act Section 504 of the Rehabilitation Act of 1973 (Section 504) and Tenn. Code Ann. § 49-10-101 *et seq.* Board is responsible for ensuring that the School complies with federal and state special education laws and regulations, and that School provides special education and related services in the same manner as provided in the Board's schools. Additionally, the Board will oversee the School's procedural compliance with the previously mentioned federal and state laws and regulations concerning accommodations for and education of students with disabilities.

2. Individuals or agencies qualified to provide exceptional education services shall provide all exceptional education services at the School. Board shall be responsible for hiring, training, and employment of site staff necessary to provide exceptional education services to students, including without limitation, gifted education teachers, resource teachers, special education teachers, speech therapists, nurses/health assistants, occupational and physical therapists, and one-on-one educational assistants or assigned educational assistants. Staffing of the instructional resource positions will be based on the total IEP service hours of the students served, in the same manner as with other Board

schools. Regarding Board staffing placed at the School, ETSU and/or the School shall have all rights of selection, rejection, or removal that LEA principals exercise over staff assigned to their schools.

3. The Board shall retain all state and federal funding received by the Board for the provision of services in this Section J in exchange for the provision of the exceptional educational services referenced in this Section. If the Board does not provide those services, the Board will pass those funds through to the School to hire appropriate staff.

K. Procurement

The Board will provide the School with access to instructional materials, as available, including textbooks, musical instruments, curricular materials, and online learning platforms (*e.g.*, Canvas, AIMSweb, *etc.*). The Board will allow access to other supplies, materials, and goods/services at its discretion. ETSU shall bear the full responsibility and cost for procurement of any supplies, materials, IT equipment, and other goods/services this Agreement does not require the Board to provide or facilitate for the School. For purposes of this subparagraph, “facilitate” may include, but is not limited to, permitting ETSU to “piggyback” on an existing contract for goods and services the Board procured.

L. Personnel

1. **ETSU Employees.** Except as stated otherwise, ETSU will employ the School’s administrative, instructional, and support staff, subject to exceptions designated herein. ETSU shall be responsible for salaries, assignment, supervision, performance management and evaluation, retention, promotion, discharge, and control of such employees, and shall be solely responsible for salaries and associated benefits. The Board will employ the School’s special education and cafeteria staff.

2. **Exception from teacher tenure provisions.** Board acknowledges that instructional staff employed by ETSU shall not be subject to Teachers’ Tenure Act, Tenn. Code Ann. § 49-5-501 *et seq.*, and shall not accrue or be eligible for tenure under said statute while ETSU employs them.

3. The School’s employees who are qualified under state law to participate in the Tennessee Consolidated Retirement System (“TCRS”) will become and/or remain part of TCRS or any successor governmental retirement system. Employees who separate from employment with the School to accept a teaching position at a school in the Board’s system shall receive service credit as allowed by law for the purpose of establishing salary and retirement service credit under the TCRS system. The School will be responsible for providing any retirement benefits for the School employees who do not qualify for TCRS.

M. Board’s Use of University School Data

1. The School shall allow the Board to use the School’s data and test results for inclusion in district wide reporting. The School shall supply in a timely manner all reports, data, test results, and other information required by state and federal law necessary for the Board to comply with applicable submissions.

2. The Board shall only use data received through these reporting requirements in accordance with the purposes defined in the Family Educational Rights and Privacy Act, and any agreements prepared for data sharing purposes. The Board shall not use the data for any other purpose.

N. Research and Proprietary Works.

1. The Board acknowledges that ETSU owns and shall own all existing, and hereafter created, copyrights and other intellectual property rights with respect to all works of authorship, inventions and work product, including instructional materials, training materials, curriculum and lesson plans, and any other materials, teaching methodologies, school management methodologies, and all improvements, modifications, and derivative works thereof that are created, invented, or developed by ETSU's or the School's employees, agents, or contractors.

2. Any data use and sharing agreements between ETSU and the Board shall govern this Agreement. The Parties incorporate herein by reference any such agreements, whether existing now or in the future.

O. Records and Audits.

1. ETSU and the School shall make, keep, and accrue full and complete books, documents, accounting records, and other evidence that specifically relate to this Agreement in accordance with generally accepted accounting principles. ETSU shall retain such records, and shall make them available to the Board upon reasonable request during the term of this Agreement and for a minimum period of 5 years thereafter. If either Party institutes any litigation, claim, or audit before the expiration of the required retention period, ETSU shall retain the records until the Parties resolve the litigation, claim, or audit finding. ETSU shall furnish copies of the records to the Board upon request at the Board's expense, as calculated in accordance with the cost provisions of the Tennessee Public Records Act, Tenn. Code Ann. § 10-7-503(a)(7)(C).

2. Upon reasonable notice, ETSU shall permit the Board, any other governmental entity, any agency participating in the funding of this Agreement, or any of their duly authorized representatives, to enter the School's offices during regular business hours or otherwise as agreed to interview employees and to inspect and/or copy the records and books of accounts together with any documents pertaining hereto that the School may keep, maintain, or possess. The Board shall pay any cost associated with production or inspection of the records and books of accounts as calculated in accordance with the cost provisions of the Tennessee Public Records Act, Tenn. Code Ann. § 10-7-503(a)(7)(C).

3. Pursuant to state laws, rules, and regulations, ETSU shall keep financial records of the School's operations, including revenues and expenditures. ETSU shall provide to the Board a detailed accounting, including the amounts and sources of funds, upon reasonable request.

P. Term and Termination

1. This Agreement shall be effective for a period of five years from the date of execution.

2. Either party may terminate this Agreement for convenience by giving at least two (2) full school years notice to the other party in advance of the renewal date of _____. If it is determined that ETSU cannot continue operation of the School, ETSU may at its option terminate

this Agreement immediately. Further, if the State of Tennessee or the local government does not budget or appropriate sufficient funds for operation of the School either party may terminate this Agreement.

3. Upon expiration or termination of this Agreement for any reason, the Parties agree to cooperate in good faith and use their best efforts to complete a prompt and orderly separation, it being the intention of both Parties that the School shall remain open and operating in its normal course in the event of such expiration or termination of this Agreement, in accordance with the following rights and obligations of the Parties:

- a. The Parties shall facilitate the transfer of data, written and electronic, not currently in the other's possession, and necessary to fulfil any state or federal requirements including, but not limited to, student records, financial reports, and other academic data.
- b. Board will provide the School with reasonable educational and operational transition assistance for a period of 60 days after the termination of this Agreement. Likewise, ETSU will provide the Board with reasonable education and operational transition assistance for a period of 60 days after the termination of this Agreement.

Q. General Terms

1. **Governing Law.** The laws of the State of Tennessee shall govern the validity, construction, and effect of this Agreement and any extensions and/or modifications thereof by. Tennessee law shall govern regardless of any language in any attachment or other document that the Board may provide.

2. **Claims.** Neither party shall be responsible for personal injury or property damage or other loss except that resulting from its own negligence or the negligence of its employees or others for whom the party is legally responsible. The Tennessee Claims Commission or the state or federal courts in Tennessee shall be the venue for all claims, disputes, or disagreements arising under this Agreement. The Board acknowledges and agrees that any rights, claims, or remedies against ETSU, the School, the State of Tennessee, or their employees arising under this Agreement shall be subject to and limited to those rights and remedies available under Tenn. Code Ann. §§ 9-8-101—408.

3. **No Conflict of Interest.** The Parties represent that they have not paid and will not pay any fee directly or indirectly to any officer or employee of the other party as wages, compensation, or gifts in exchange for acting an officer, agent, employee, subcontractor, or consultant to that party in connection with this Agreement.

4. **Illegal Immigrants.** Per Tennessee law, neither party will knowingly utilize the services of illegal immigrants in the employment performance of this Agreement and will not knowingly utilize the services of any subcontractor, if permitted under this Agreement, who will knowingly utilize the services of illegal immigrants in the performance of this Agreement.

5. **Non-Discrimination.** The Parties shall not exclude any person from participating in or benefiting from this agreement on the grounds of disability, age, race, color, religion, sex, national origin, veteran status, or any other classification protected by Federal and/or Tennessee State constitutional and/or statutory law.

6. **Section Headings.** The headings in this Agreement are for the convenience of the Parties only and shall have no effect on the construction or interpretation of this Agreement and are not part of this Agreement.

7. **Entire Agreement.** This Agreement sets forth the entire agreement between the Parties with respect to the subject matter hereof and shall govern the respective duties and obligations of the Parties. This Agreement supersedes all prior understandings and agreements, expressed or implied, written or oral, between the Parties.

8. **Modifications and Amendments.** The Parties may modify this Agreement only by executing a written modification or amendment.

9. **Assignment.** The Parties shall not assign, subcontract, transfer (whether by assignment or novation) the work, services, or any interest in this Agreement without the prior written consent of the other Party.

10. **No Partnership/Joint Venture.** The Parties do not intend to create a partnership or joint venture through this Agreement. Neither the Parties nor any court of law shall interpret or construe this Agreement as creating a partnership or joint venture between the Parties. Nor shall the Parties or any court of law interpret or construe this Agreement as creating a principal-agent relationship between the Parties. Neither of the Parties shall hold itself out in a manner contrary to the terms of this paragraph.

11. **Severability.** If any court of competent authority declares any provision of this Agreement invalid, the court shall sever the invalid provision and the severance shall not affect the validity of the remaining provisions of this Agreement.

12. **Negotiated Agreement.** The Parties negotiated and jointly drafted the terms of this Agreement.

13. **Approvals.** By signing this Agreement, both Parties acknowledge that they have received the appropriate approvals from their governing agency.

14. **Laboratory/Teaching School.** The Parties intend for ETSU to maintain the School as a laboratory/teaching school in accordance with Tenn. Code Ann. § 49-8-105, as amended effective May 11, 2023, and as the General Assembly may amend the Act from time to time. The Parties and the courts shall interpret and construe this Agreement to effectuate that purpose. This Agreement shall be automatically amended to conform with any subsequent amendments to the Act, unless the Parties agree otherwise in writing in accordance with section Q, paragraph 8. Any provision of this Agreement that contravenes the Act shall be deemed invalid.
