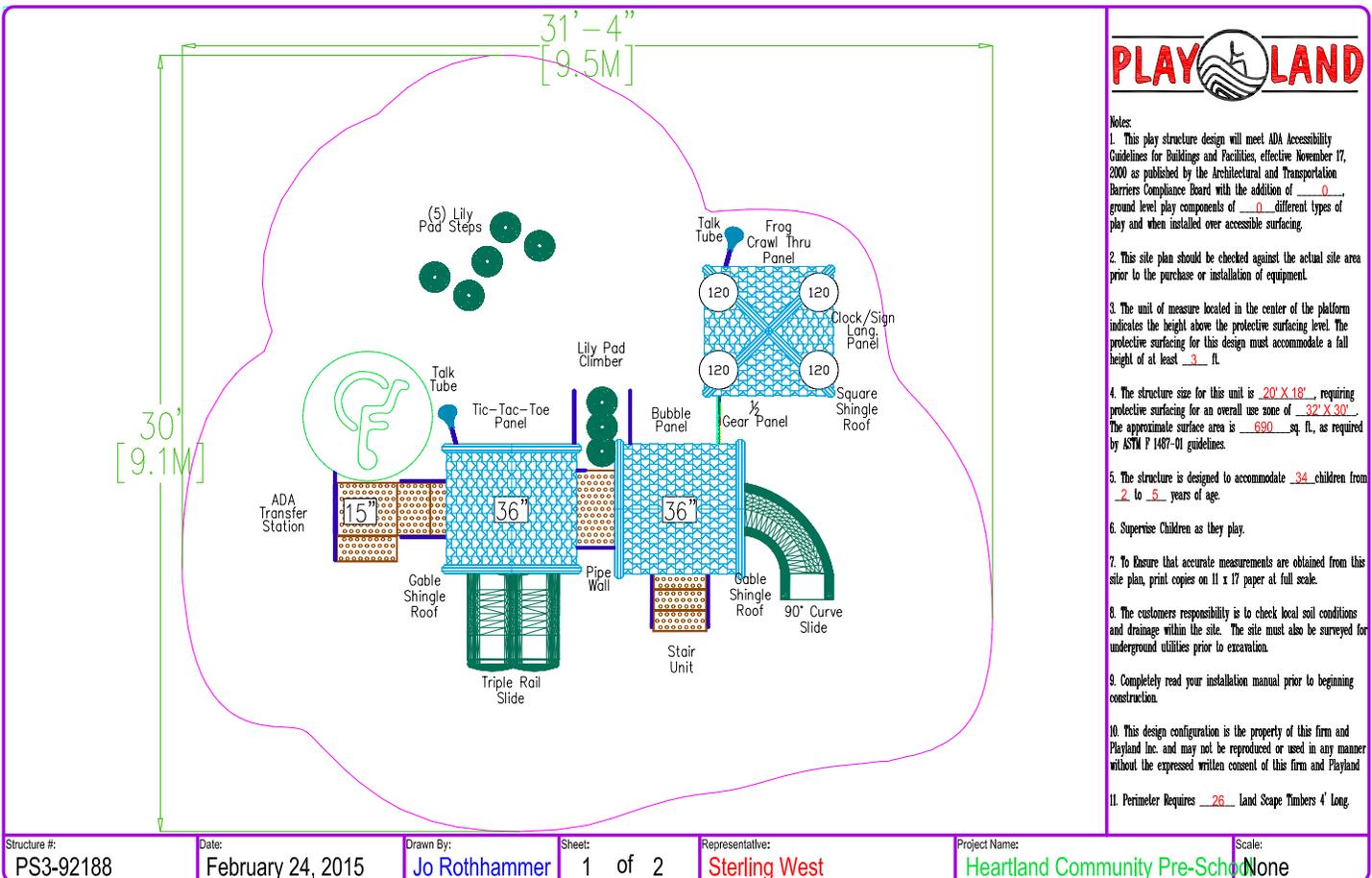

- This play structure design will meet ADA Accessibility Guidelines for Buildings and Facilities, effective November 17, 2000 as published by the Architectural and Transportation Barriers Compliance Board with the addition of 0 ground level play components of 0 different types of play and when installed over accessible surfacing.
  - This site plan should be checked against the actual site area prior to the purchase or installation of equipment.
  - The unit of measure located in the center of the platform indicates the height above the protective surfacing level. The protective surfacing for this design must accommodate a fall height of at least 3 ft.
  - The structure size for this unit is 20' X 18', requiring protective surfacing for an overall use zone of 32' X 30'. The approximate surface area is 690 sq. ft., as required by ASTM F 1487-01 guidelines.
  - The structure is designed to accommodate 34 children from 2 to 5 years of age.
  - Supervise Children as they play.
  - To ensure that accurate measurements are obtained from this site plan, print copies on 11 x 17 paper at full scale.
  - The customers responsibility is to check local soil conditions and drainage within the site. The site must also be surveyed for underground utilities prior to excavation.
  - Completely read your installation manual prior to beginning construction.

# Heartland Community School and Hampton Public School Cooperative Sponsorship Agreement for Junior High Football

## **Purpose:**

The philosophy of Heartland Community School and Hampton Public School is to provide an opportunity for students to participate in a variety of activities. Through cooperative sponsorship, the opportunity for student participation is to be maintained or increased. The cooperative agreement may be voided or modified at any time by mutual agreement of both schools and approval by majority vote of the Boards of Education of both school districts. No other cooperative agreement in the same activity may be made with another school during the terms of this cooperative agreement.

## **General Guidelines**

- The cooperative agreement for **Junior High Football** shall be for **school years 2015-2016 through 2016-2017**.
- Heartland Public School shall be responsible for the following:
  - Scheduling of contests
  - Hiring of officials
  - Purchasing/maintenance of jerseys and required equipment
- Hampton Public School shall be responsible for the following:
  - Transportation to practices
  - Transportation to the Heartland site for “away” competitions, as necessary
- Each individual school district will be responsible for the following:
  - Concussion testing of their athletes prior to participation
  - Transportation to practice
  - Individual coaching salaries and contracts (Heartland-1 Coach, Hampton-1 Coach)
  - Insurance costs/coverage
  - Supervision of contests
  - Equal shares of game related costs (officials, clock, chains)
- Practice locations will be designated at Heartland
  - Practices will begin at 3:45
  - Practices will last no longer than two hours
  - Practices will allow Hampton students to be home by 6:00 P.M.
- School Identity
  - 2015 - Heartland-Hampton Huskies
  - 2016 – To be determined based upon discussions relative to varsity activities
