**Summer School**

Due to the fact that we have students who are either off track or nearly off track to graduate with their class, and students who will not be promoted to the next class until they “make up” credits. We will again offer a summer credit recovery program. We believe we will have 4 to 5 students enrolled in summer credit recovery.

**Graduation**

We will have all 24 students graduating on Saturday! We are definitely hoping for 70-degree weather and sunny skies

**ACT**

We had a successful April 5<sup>th</sup> ACT testing day. All students were at school, on time, ready to load the bus, and worked hard during the test, we had promised them a day out early; if they worked hard at John Baylor and ACT prep program during personal finance study time and their scores met projections. Many of our students improved by 2 points, and everybody improved if they had taken the test before.

## **Superintendents Comments - May 2018**

### **Kenesaw Logo**

We have several nice Kenesaw Logos to select from and use.

### **New School Website**

Angela continues to make excellent progress on the new website. We will have more time to work together this summer. The teacher group is now going through web pages and providing feedback to Angela.

### **Preschool Grant**

We got the Preschool Grant - \$390,000 over three years and a one time start up cost of \$25,000. I will have to now work with Kristine Luebbe from the state department. She indicated that I may have to rework the budget part of the grant. I was also provided with the Strengths and Weaknesses of the grant that we wrote.

### **Software Unlimited Training**

Deb, Shandra, and I all attending the Software Unlimited training. The girls took part in three days of training and I did two (General Ledger, Payroll). We think the software will work well even though it has been a lot of work to convert over from the old system. Deb has worked extremely hard at this working to 10pm each night that she stayed over in North Platte. Deb continues to work with the new software and get more comfortable. The girls seemed to pick it up very fast. They did a great job!! I was just there to keep the mood light!

### **Time Management System**

TMS is clock-in (Punch Card) system that is digital. This system would work directly with the Software Unlimited School Accounting software and would allow the clock-in times of classified staff to go directly into the system. This would eliminate Deb from needing to manually input time cards. I am viewing a webinar near the end of May.

### **Old Gym Industrial Doors**

Double doors will be installed on the east end of the old gym. These are industrial doors which will help with safety. We got a couple of bids - Price is around \$1,500.

### **REAP Grant Completed**

### **School Shop**

First, we will need to look at opening the shop area up this summer. Once this is done we can begin to determine how best to use this space. There are many needs that must be considered - painting area, air ventilation, how to keep dust from getting on wet projects. Mr. Perry also asked if we could get a bigger overhead door. He would like to bring larger items in for welding such as large trailers.

**CMBA Architects**

Made first payment for \$19,362.50 to Carmichael for Preschool Project Work.

**TVC ACT Results**

We had the most students by a large margin of any conference school recognized for their ACT score. Kenesaw 14, Deschler 9, Blue Hill 6, Shelton 4, Harvard 4, Franklin 3, Lawrence/Nelson 3, Red Cloud 3, Silver Lake 2.

**Doris Baisinger Memorial Books**

The Baisinger Family will be providing kindergarten students two books, one in the fall and the other at the end of the year, in memory of Doris Baisinger. This program will continue until funds are depleted. Mrs. J. Burr will be helping students with the selection of books. The money will run through the school foundation. We are very appreciative of the Baisingers and their generous contributions.

**Option In Student**

We will be getting Stefanie Anderson as an Option Back In student.

**Natural Gas Contract**

Locked in .315 for the next two years. Most gas companies were around .55 and were not able to compete with CenterPoint Energy Services. We had not renewed our contract for several years so we were paying .848. I hope this to be a nice cost savings for the school.

**Something to Consider**

Justin Knight sent out an email regarding a recent student yearbook/memorial matter that is currently taking place. He is urging school boards to have a policy in place before dealing with such a tragic event. I do believe that this would be something that we should discuss and have a plan for already in place.

Thank you Mr. Masters for contacting us in regards to the clarification of what this Catastrophic Accident does. This is an accident policy that we had recommended several years ago. This policy is not written through Krull Agency, but we do help administer the policy.

Attached is a copy of the benefits which is costing you approx. \$653.00 per year. The school does have a \$25,000 deductible but it will pay up to \$5 million per accident. Death and Dismembership, I believe are paid without the deductible being applied.

If you remember a few years ago we had the bus accident where the bus slid off and overturned in the pond or river involving the Seward School District, this is the type of policy Seward had that paid out.

I did ask them if they have ever paid out in regards to school shootings. The company said that Great American actually has not had a school shooting, but did feel this could be another type of claim that would possibly be paid.

We have recommended this policy due to the low cost to help meet the natural needs of the school boards wanting to fulfill an obligation to the students/parents.

Another option that we have presented before is a coverage to insure every student enrolled as a student during the school year. Cost is \$6.95 per student or would run approx. \$1775 per year based on 255 students. No deductible and provides partial coverage depending on what type of care is needed up to \$50,000 per injury. Sample policy is enclosed. This policy however does not cover any type of sports coverage for 7th-12th grades, but would cover PE classes.
