Providing Input to the School Board

(Revised 08-02-16)

The Corvallis School Board values the opinions and input of community patrons. As such, the purpose of this document is to provide general guidelines about how to make the most of your time when communicating with the Board. The public may offer comments during meetings or correspond in writing via email or U.S. mail, as outlined below.

I. Written Correspondence

Letters, emails and other written materials submitted to the Board are considered public record. They may be submitted via U.S. mail to: Corvallis School Board, Attn: Julie Catala, P.O. Box 3509J, Corvallis, OR 97339. Emails may be sent to: schoolboard@corvallis.k12.or.us, which will reach all Board members as a group. Others who will receive emails sent to this address: Superintendent, Assistant Superintendent, Teaching and Learning Director, Human Resources Director, Finance and Operations Director, and Executive Assistant to the Superintendent and Board of Directors (aka Board Secretary).

II. Public Comment at Meetings

Members of the public have the opportunity to share their ideas and opinions with the Board during the agenda item labeled *Public Comment*. These opportunities are offered only at certain School Board meetings.

To request the opportunity to offer public comment

- A. Complete a *Request to Address the Board* card, which can be found on a table at or outside the entrance to the meeting room, and give it to the Board Secretary at the head table **before** the meeting begins.
- B. Complete all requested information. Failing to fully and clearly complete the card and/or to submit it to the Board Secretary before the meeting begins may affect your opportunity to testify at the meeting.
- C. Although it is not required, you may wish to prepare a written statement from which to read during the meeting; if so, you may choose to leave your written comments with the Board Secretary to file with the official minutes of the meeting.
- D. Although they are not required, you are welcome to provide handouts to the Board; if so, please bring 13 copies and give them to the Board Secretary to distribute.
- E. The Board Secretary will sort comment request cards that are completely filled out and submitted before the meeting begins, into sets by topic (if there are multiple requests for each topic). The Board Secretary will draw one card from each set, in turn.
- F. If more comment requests are submitted than can be accommodated during the allotted time on the Board's agenda, you might not be called upon to provide your comments. In that case, you may submit your comments in written form; see below for information.

- G. When you testify, your name, address and comments are matters of public record; however, students and staff do not need to provide their addresses.

Rules for Public Comment

- A. When you're called on to comment, proceed to the podium/table in front of the Board, state your name and the topic you will address before you begin. This is a matter of public record and will not count against your time. Only one person at a time will be allowed at the podium/table, with exceptions at the discretion of the Board Chair.
- B. Direct your comments to the Board. The Board Chair will refer any questions or requests for action to the proper person for a response at a later date.
- C. Keep your comments within the specified time allotted, usually three minutes. The Board Secretary will signal you with one chime when you have 30 seconds remaining and with two chimes when your time is up.
- D. If others have spoken before you about the same issue, please state that fact and either decline to comment or limit your comments to points not already stated.
- E. If a group wishes to speak, designate one spokesperson for the group; that person will stand at the podium/table. In order to maintain the meeting schedule, repetitious comments are discouraged.
- F. Speakers may offer objective criticism of district operations and programs but the Board will not hear complaints concerning individual District personnel. Any such complaints must be handled following the steps outlined in policy KL–Public Complaints and administrative regulation KL-AR, copies of which are available during meetings at which public comment is accepted or online at <http://policy.osba.org/corvall/KL/index.asp>.
- G. Complaints regarding budget, programs, or other District issues also should be handled by following the steps outlined in policy KL. Challenges of instructional resources or materials used by the District are subject to the rules and regulations of policy II/IIA–Instructional Resources/Instructional Materials at <http://policy.osba.org/corvall/I/index.asp>.
- H. Undue interruption or other interference with the orderly conduct of Board business cannot be allowed. Defamatory or abusive remarks are always out of order. The Board Chair may terminate the speaker's privilege of address if, after being called to order, the speaker persists in improper conduct or remarks.

The Muddy Creek Charter School Vision and Mission

Vision:

Muddy Creek Charter School is a rural public school dedicated to the integration of an outstanding academic program with its community – the land and its people. We offer a joyful and creative educational experience where engaged students practice the skills they will need to be effective citizens and stewards in the future. Muddy Creek Charter School will serve as a model for preserving schools in rural communities.

Mission:

Muddy Creek Charter School was founded to provide an outstanding K-5 public educational program for children who reside in and around the Muddy Creek Watershed. In multi-age classrooms, the school will deliver a place-based, project-based, integrated arts and science curriculum grounded in its rural agricultural setting and commitment to community service. Diverse learning styles will be fostered. MCCS will be supported in its efforts by forging and maintaining partnerships with local landowners and agencies, OSU researchers and the community at large. Our success will be our children. The students of MCCS will not only meet or surpass the state benchmarks but will also have a deeper understanding of their place in the world as demonstrated by portfolios of high quality projects, and they will be well prepared to transition into other schools for their continued education.

A. Introduction**Brief historical perspective**

Muddy Creek Charter School opened its doors in September of 2008, so we have begun our 9th year of operation. As stated in the charter agreement, the mission of the school was to provide an excellent and innovative public educational program for children in grades K-5 in the Corvallis School District. It is aimed at, but not restricted to, children who reside in and around the Muddy Creek and Beaver Creek Watershed. During the 2015-16 school year, 17 students were from these areas. The remaining students come from the Corvallis School District (68), Philomath School District (15), Monroe School District (3), Albany School District (2), or Central (1).

Our place-based curriculum is founded in its rural agricultural setting and commitment to community service. Learning takes place through a combination of direct (traditional) and multidisciplinary, project-based instruction that also integrates art. MCCS is supported in its efforts by forging and maintaining partnerships with local landowners and agencies such as the Fresh Water Trust, OSU researchers and the community at large. Our goal is that the students of MCCS not only meet or surpass the state benchmarks but will also have a deeper understanding of their place in the world as measured by a portfolio of the student's best work, and prove themselves well prepared to transition into other schools in the Corvallis School District for their continued education.

B. Physical Description

The school has five classrooms - a full-day kindergarten, a first/second grades classroom, a second/third grades classroom, third/fourth grades classroom and a fourth/fifth grades classroom. The blended approach helps to create a strong community with the classroom and school and provides with two placement options for students in second through fifth grades. Grades 1-5 received PE instruction three days a week, music instruction two days a week, and art instruction once a week. Special Education and counseling were additional instructional offerings. Each classroom has an assistant. The administration consists of an Executive Director, a Head Teacher, and an Administrative Assistant. There is a Financial Officer handling financial matters and technology issues. The District provides a quarter-time learning resource center teacher, a speech and language specialist and assistant time to meet the needs of students with disabilities. The Executive Director, Financial Officer, and Head Teacher work half-time. Recent physical improvements include roof replacement and exterior wall dry rot removal and

reconstruction. Testing revealed no traces of lead in the water and drinking fountains at the school.

C. Academic Description

Literacy

Our philosophy is to integrate phonics, skill development and whole language to promote a love of reading and opportunity to read chapter books. Instruction is based on Oregon's Common Core State Standards.

Literacy includes four areas: Reading, Writing, Speaking, Listening

All classrooms have:

- A collection of leveled books, both fiction and nonfiction
- Daily writing, following required state standards skills to be developed
- Regular practice to develop language, vocabulary and interpersonal skills by providing opportunities for students to speak publicly in the classroom, and at our weekly all-school assembly.
- Grades 1-5 participate in 4-H Wildlife Summit, presenting their project to judges. Projects consist of writing, research, art and presentation.

Literacy Instruction includes and is not limited to:

- Total ninety minutes per day of literacy, which includes spelling, phonics, vocabulary development, writing and reading...description following of reading Thirty minutes of reading instruction at their ability level (guided reading)
- Specifically chosen "Read-alouds" are shared with class daily.
- 30 minutes per day is designated for students to read independently; Independent reading practices include "Read to Self", "Read to Someone" and/or DEAR (Drop Everything and Read)
- A read-at-home program is encouraged that emphasizes 15-30 minutes of reading at home per day
- STAR testing is given twice yearly to document progress and to help plan instruction.
- DRA individual student assessments are given in the fall and as a progress check for reading fluency and comprehension.

Classroom teachers create a year-long teaching plan that includes Literacy skills, strategies and topics to be taught, using Oregon State Educational Standards

Math

Our math program is comprised of *Bridges* for Grades K-4 and *Everyday Math* for Grades 5. *Bridges in Mathematics: Second Edition*, is a comprehensive K-5 mathematics curriculum that

helps teachers to fully implement the Common Core State Standards for Mathematics in a rigorous, coherent, and engaging way. The curriculum focuses on developing students' deep understanding of mathematical concepts, proficiency with key skills and the ability to solve complex problems. They learn fluency of facts and how to use them in all problems. It is hands on, and develops a community of mathematicians. Fifth grade uses *Everyday Math*, which is a progression of skills with group lessons and individual advancement. Students take pre and post tests and continue at their own pace along with group instruction. The two programs work well together and students leave Muddy Creek with a strong mathematical sense.

Science (includes place-based projects)

Project learning follows a two-year cycle of Science and Social Studies topics. Students engage with a topic, then question and investigate (conduct field work), and share what they have learned. Whenever possible, projects are investigated through the lens of the place where children live or where our school is located. **The projects also give children an opportunity to apply literacy and math skills in an integrated context.** Project times vary in length and type. Some projects last for a few weeks and others last up to three or four months. Certain projects are worked on intermittently and others, such as seasonal comparisons, will last the entire year. Examples of project themes include:

- Farm animals
- Birds/migration
- Habitat Restoration
- Water and weather
- Astronomy
- Wetlands
- U.S. History
- Economics
- Food chains
- Engineering

Classes also completed smaller focused studies based on student and teacher interest.

4-H Wildlife Stewards Summit Presentations (second through fifth grade)

We participated in the 4H Wildlife Summit annually and Muddy Creek hosts the summit every 3 years. Our students produced and presented posters of their investigations.

Restoring plant life in the Rock Creek watershed
Restore Project – study of wetlands impact upon plants and soils
Finley Wildlife Refuge – study of bird migration patterns
Raised-bed potato trials

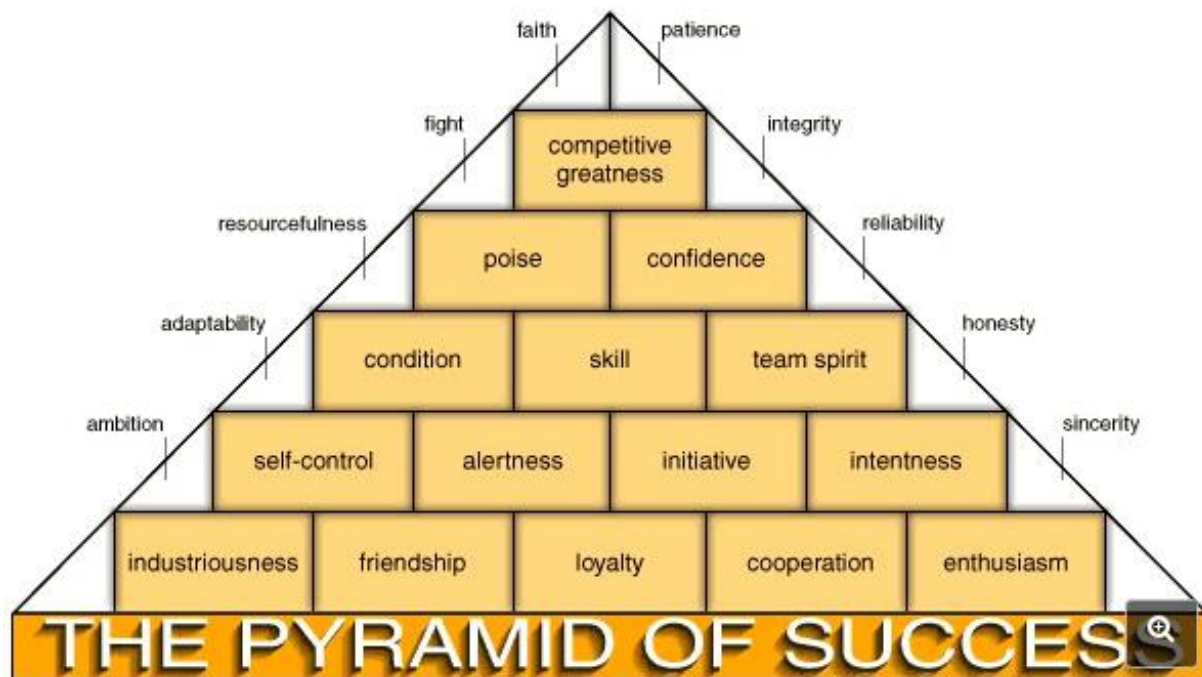
Art Integration

The Art Integration Specialist works closely with the K-5 teachers to develop projects and assessments that are integrated, not only with the science themes, but also with all other core subject areas. Place-based, project based lessons are created using a wide variety of mediums. The art curriculum is designed to develop the unique mental capabilities which foster flexible, divergent, original and imaginative thinking. The developmental stages and individual needs of each child are considered and celebrated. While the art projects are designed to enhance learning in all subject areas, art has intrinsic value and is worth learning for its own sake. Art at MCCS encourages inquiry, discovery and wonder. All K-5 students are offered a wide range of experiences in color, design, drawing, painting, sculpture and crafts. For example:

Enrollment Update

NO ACTION REQUIRED

Total Enrollment

On October 1, 2016 a total of 6,600 students were enrolled in district schools and programs (this count excludes Muddy Creek Charter School with an enrollment of 110 students). Compared to the same time last year, our total enrollment has decreased by 17 students or 0.2%. Compared to five years ago, our total enrollment has increased by 317 students or 5%. While we have experienced growth in the last five years, our total enrollment is still less than it was ten years ago at 6,726 students.

Actual vs. Projected

Our total enrollment of 6,600 students is 54 students less than what we projected for this year, with the largest fluctuations in kindergarten, and grades 10-12. Actual elementary enrollment is higher than projected by 31 students, while actual secondary enrollment is lower than projected by 85 students. Enrollment in grade 12 was significantly impacted this year by the creation of the new Post-Graduate Scholar Program.

Post-Graduate Scholar Program

The Post-Graduate Scholar Program was created by Senate Bill 1537 during the 2016 legislative session. This new program replaces what was previously the Running Start Advanced Diploma Program. Last year 156 students were enrolled in the Running Start Advanced Diploma Program, while this year, only 16 students are enrolled in the Post-Graduate Scholar Program. A comparison of program eligibility requirements is presented below:

Running Start Advanced Diploma Program

- Completed all of the requirements for a HS diploma
- Cumulative GPA of 2.0 or higher

Post-Graduate Scholar Program

- Completed all of the requirements for a HS diploma
- Cumulative GPA of 2.5 or lower (thus not eligible for Oregon Promise)
- Ineligible for the PELL Grant (or grant does not cover one year of college tuition and fees)

The demographics of students enrolled has also changed, as fewer students who are navigating poverty or identify as non-white are participating.

Student:Teacher Ratios

The average student:teacher ratio at our elementary schools is 24, with a low of 20 (Lincoln) and a high of 28 (Franklin). The average student:teacher ratio at our secondary schools is 28, with a low of 26 (Franklin), and a high of 31 (Crescent Valley).

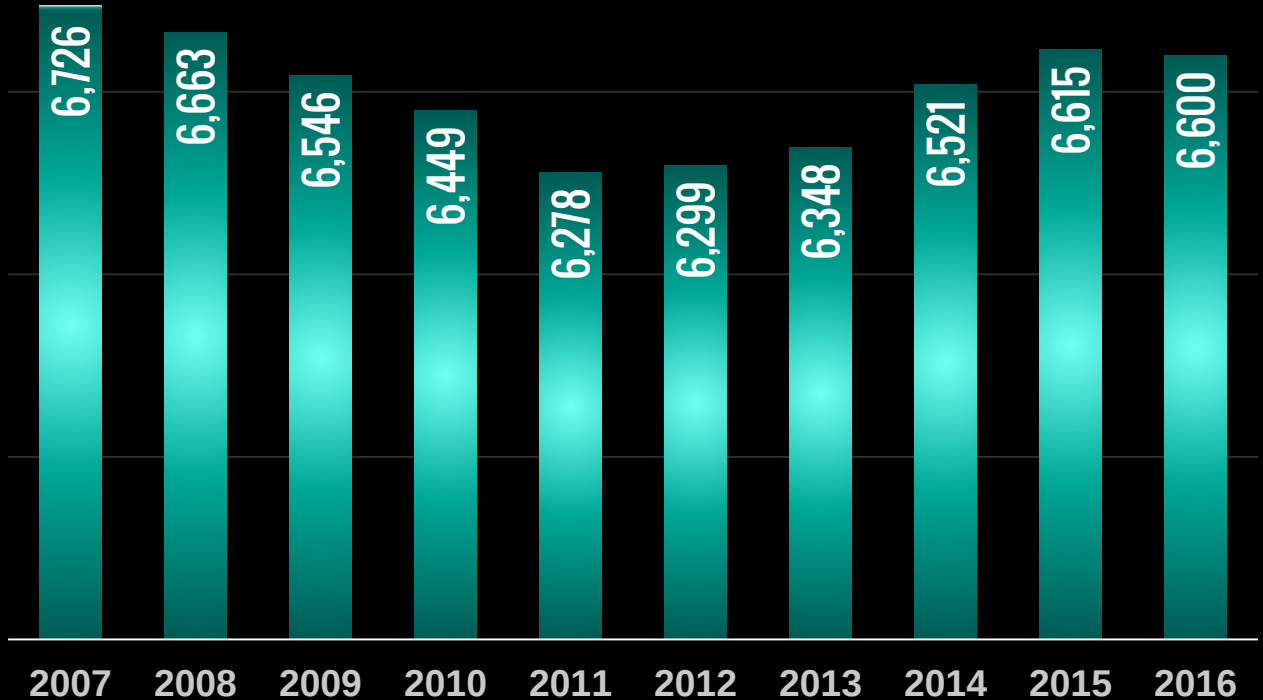

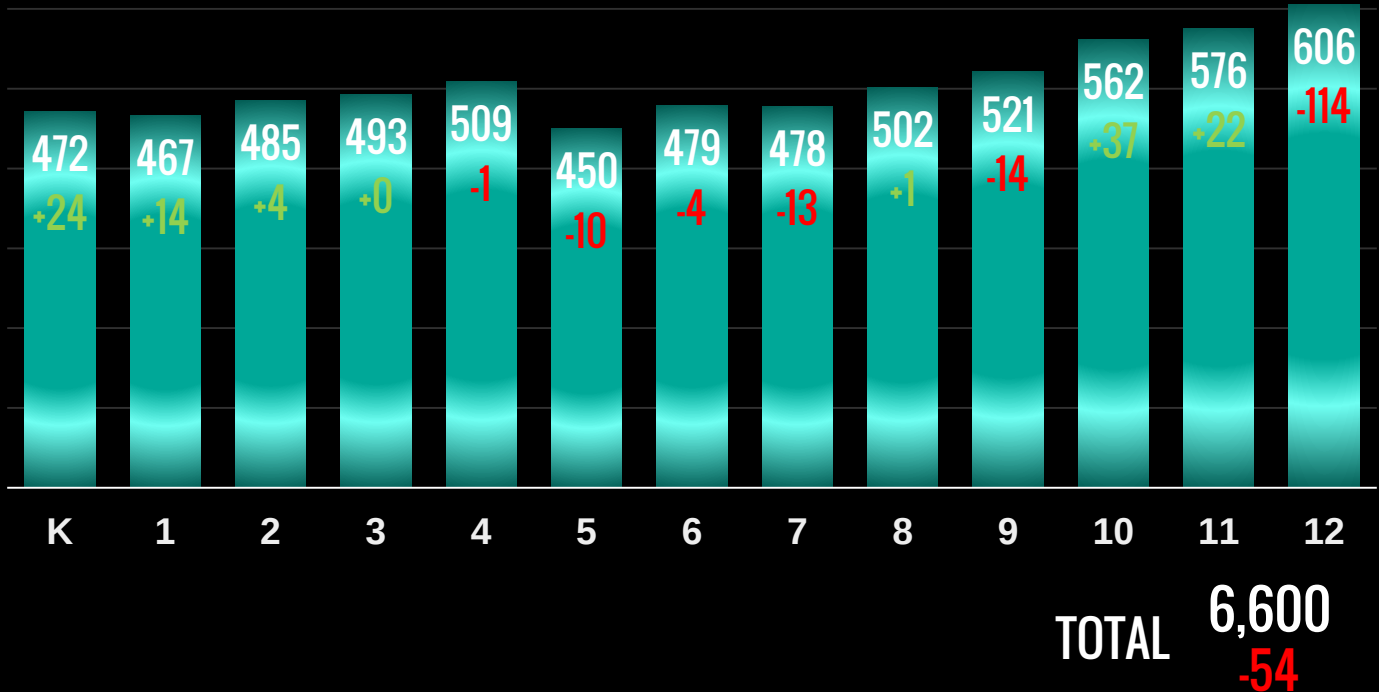

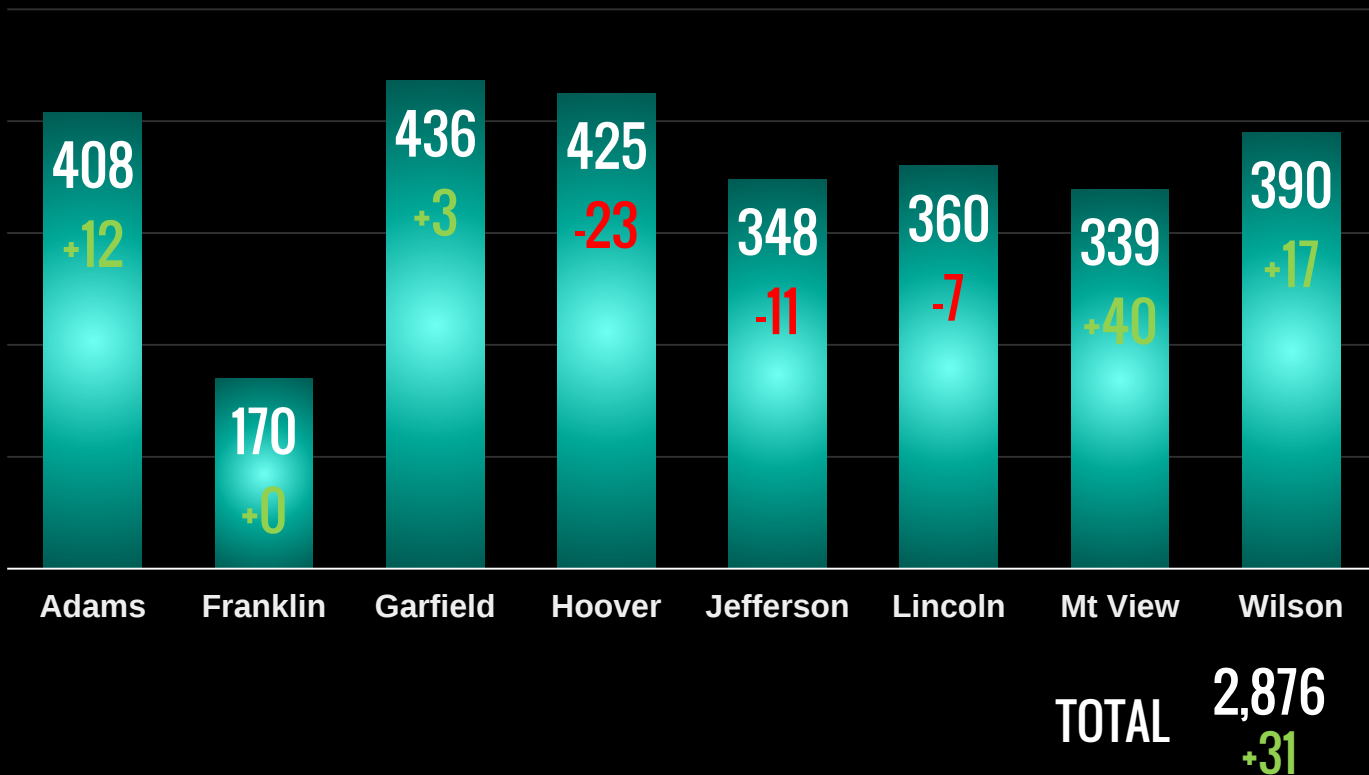

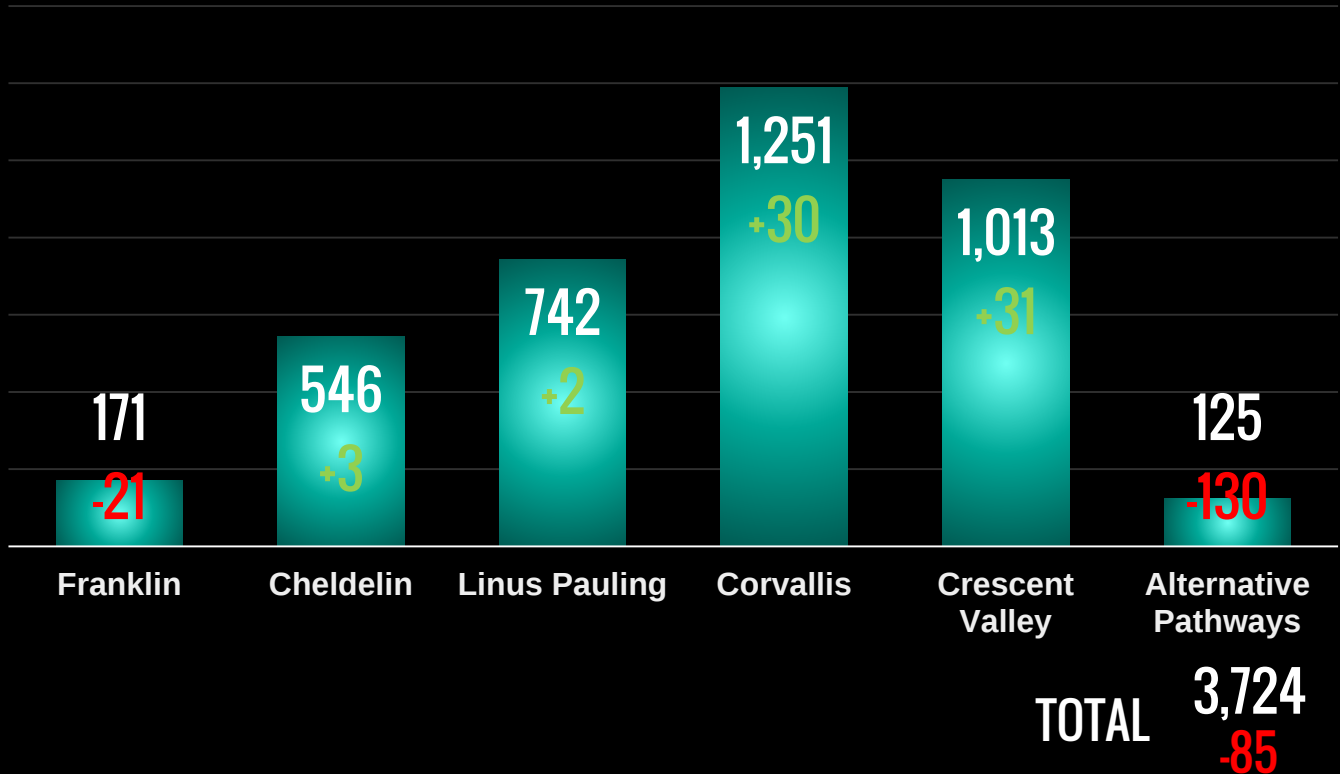
TOTAL ENROLLMENT BY GRADE

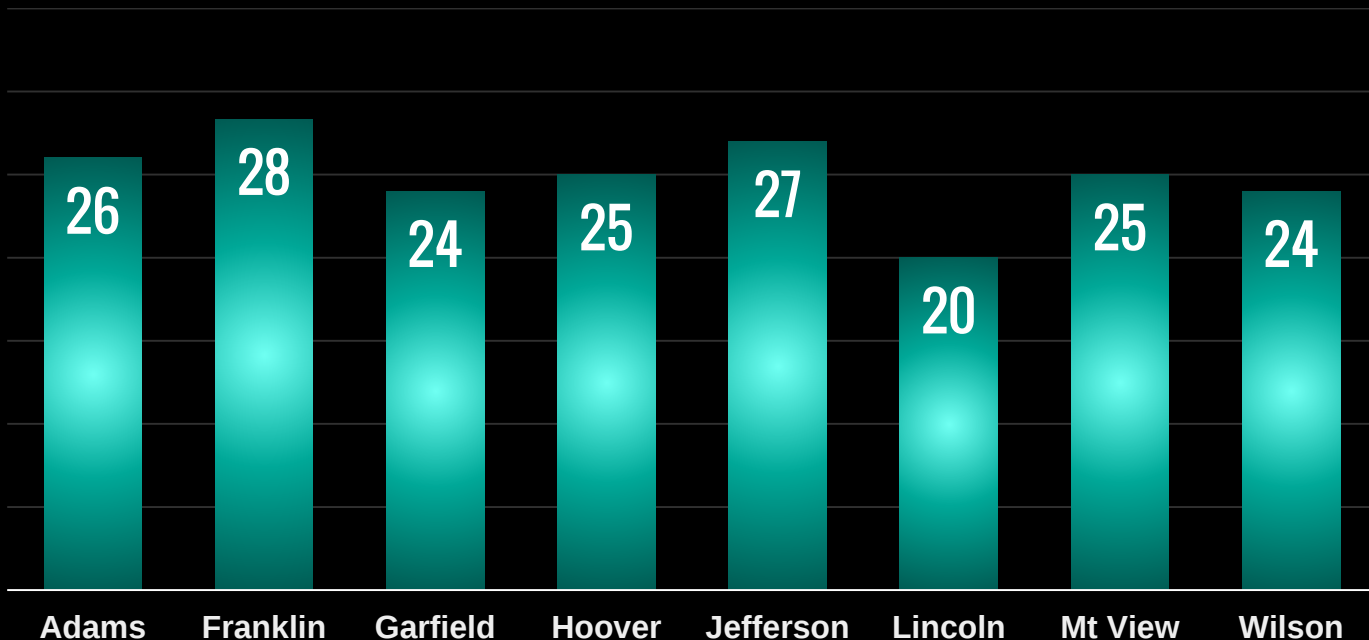

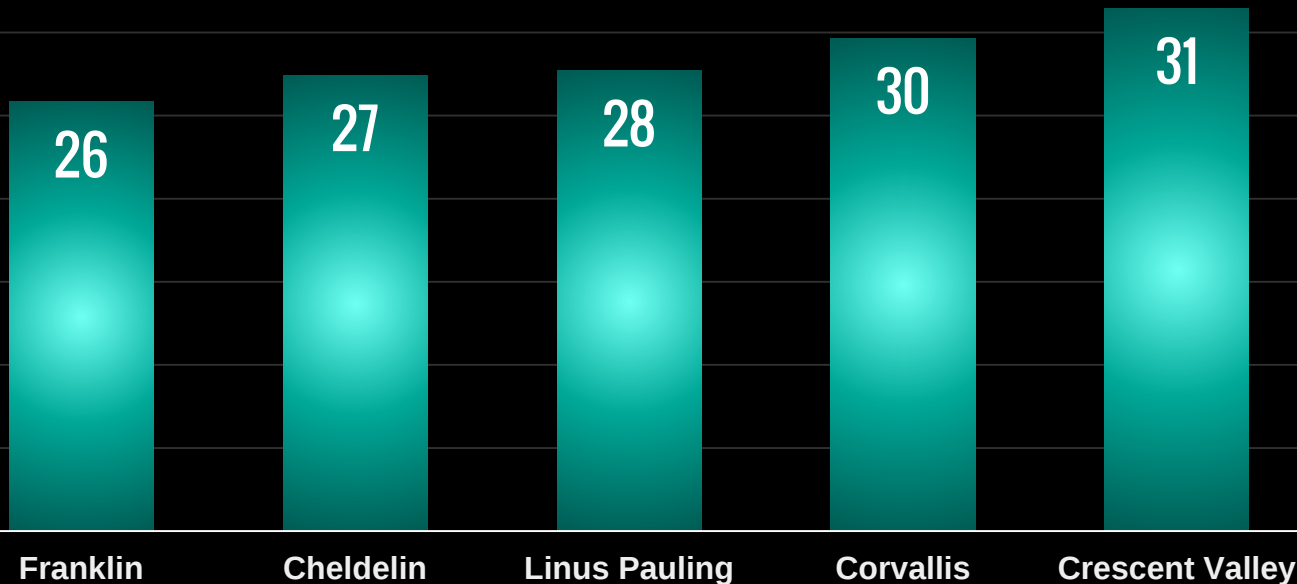

A. Healthy and Safe Schools Plan

Facilities Director Kim Patten provided highlights of the draft plan, which must be submitted to the state by October 1, 2016, with a final version due January 1, 2017; her written report will be filed as part of the minutes of this meeting. Ms. Patten said the plan calls for a five-year testing cycle for lead in drinking water, with 20% of the facilities tested each year. She touched on testing as it exists now for lead in drinking water, radon, and mold, and on pest management.

B. K-12 Bilingual Pathways Project Grant

Equity and ELL Coordinator Marcianne Rivero Koetje provided highlights of the report she had submitted to the Board, which will be filed with the minutes of this meeting. Additionally, she provided information regarding translation of curriculum, sought volunteers for the District's upcoming dual language summit, and noted the ongoing collaboration with the Center for Applied Linguistics.

C. District Fees

Assistant Superintendent Kevin Bogatin responded to questions from the Board regarding the report he'd submitted; that report will be filed with the minutes of this meeting. Board members raised concerns about the fees charged for graduation caps and gowns, college application processing services and admission to sporting events, and about the soliciting of cash donations by schools with more affluent populations. Board members expressed desires for student and community input in the decision-making process, general funds being distributed equitably among schools, and greater public communication about the positive impacts to date of the focus on equity.

August 31, 2016 Financial Statements (Unaudited)

NO ACTION REQUIRED

Background

The Statement of Resources and Requirements for the period ending August 31, 2015 and 2016 follow this report. Descriptions of resources and categorization of requirements have been modified to increase transparency with regard to what resources the district receives and how those resources are utilized during the fiscal year.

Year-to-date operating revenues through the end of August 2016 total \$8.3 million or 12.9% of total budgeted operating revenues as compared to \$7.6 million or 12.1% through the end of August 2015. Typically, at this point in the year, revenues from the state school fund constitute the significant source of funds, which is true this year.

The beginning fund balance reflects an increase of \$600,000 over the adopted budget of \$9.6 million. Overall, total resources in 2015-16 were 100.7% of budget while total expenditures were 98.9% of budget. A significant portion of the additional resources was due to an increase in state school fund formula revenue.

General fund expenditures through August 2016 are up \$700,000 as compared to the prior year. The bulk of the increase has come in the form of summer maintenance expenditures including lead remediation and annual maintenance, as well as planned technology purchases. Contracted payroll increases account for the majority of the balance of the increase.

Projected resources and requirements through June 30, 2017 result in an ending fund balance of \$9.3 million. The projected ending fund balance reflects a change in fund balance, or operating deficit, of \$900,000; however, all general fund reserves are still projected to be at or above the designations outlined in board policy on June 30, 2017.

Fiscal year 2015-16 financial records are in process of being closed and staff are preparing schedules in anticipation of the annual fall visit from the auditors. The auditors are scheduled to begin fieldwork October 24th.

Staff are also preparing a supplemental budget for board adoption on December 5th that will propose increasing appropriations to account for carryover allowances and staffing or programmatic changes made after the budget was adopted.
