**I. CALL TO ORDER AND ROLL CALL (CSD509J, 05-20-2021, 00:04:56)**

The meeting was called to order by School Board Chair Al-AbdRabbuh on Thursday, May 20, 2021 at 6:30 p.m. in the Board Room of the Central Administration Building, 1555 SW 35th Street, Corvallis, OR 97333, and live streamed on the district’s [YouTube](#) channel (CSD 509J, 05-20-2021, HH:MM:ss). Committee Member Al-AbdRabbuh called for nominations for Budget Committee Chair. Committee Member Finger McDonald nominated Committee Member Freborg; Committee Member Freborg accepted the nomination.

Hearing no further nominations, Committee Member Al-AbdRabbuh closed nominations and called for a motion.

Committee Member Al-AbdRabbuh turned the meeting over to Committee Chair Freborg.

Committee Chair Freborg called for nominations for Budget Committee Vice-Chair. Committee Member Adams nominated Committee Member Tadepalli; Committee Member Tadepalli declined the nomination. Committee Member Adams nominated Committee Member Clark; Committee Member Clark accepted the nomination.
