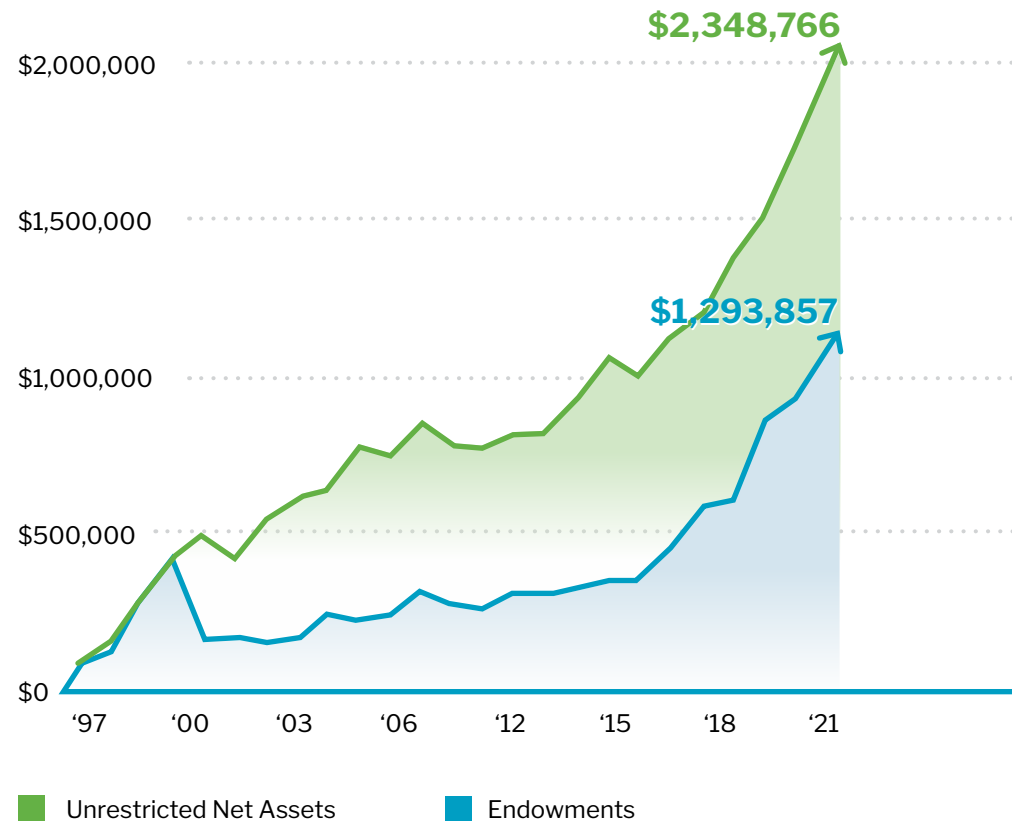

Commemorating our 25th Anniversary:

Original CPSF Trustee Comes Full Circle

The story of the Corvallis Public Schools Foundation starts, in some ways, with attorney Gretchen Morris—and a client in the mid-1990s who wanted to show appreciation for Corvallis schools.

The client was the grandparent of a Corvallis School District student. Morris asked how much the client wanted to donate.

“I was thinking maybe \$5,000,” Morris recalled. “The client said, ‘Oh, \$50,000 to start with.’ ... After I caught my breath and pulled myself off the floor, we talked about it, and I said, ‘You know, I don’t think you want

to just give this to the general budget; maybe there’s some way it could make a difference. How about if I talk to the superintendent?’”

The money eventually went to a computer lab at Highland View Middle School—and the superintendent asked Morris to brief the school board about the donation. The school board at the time included Larry Stuber, who asked Morris: “You wouldn’t

happen to have any more clients like that, would you?” Morris replied if she did, she wouldn’t have them donate money to the district’s general budget. She said: “You ought to have something like a foundation for it.”

The next morning, the superintendent asked his team: “OK, which one of you knows about foundations?”

Administrator Kay Reynolds was assigned to find out—and became the foundation’s first executive director, in 1996. As Reynolds assembled the first board, she ran the names by Morris, who had just one question: “Can I be on it too?”

She could.

After Morris retired from lawyering, she resigned from the board to spend time traveling with her husband, John.

Years later, Morris was having lunch with Liv Gifford, the foundation’s current executive director. Gifford asked Morris if she was interested in rejoining the board.

She was—and for the same reason she joined in the first place, a belief in the work that the foundation was doing.

“The reason I feel so strongly,” she said, “is that public education—and I get really emotional about this—is an absolute cornerstone of our democracy.” 🌱

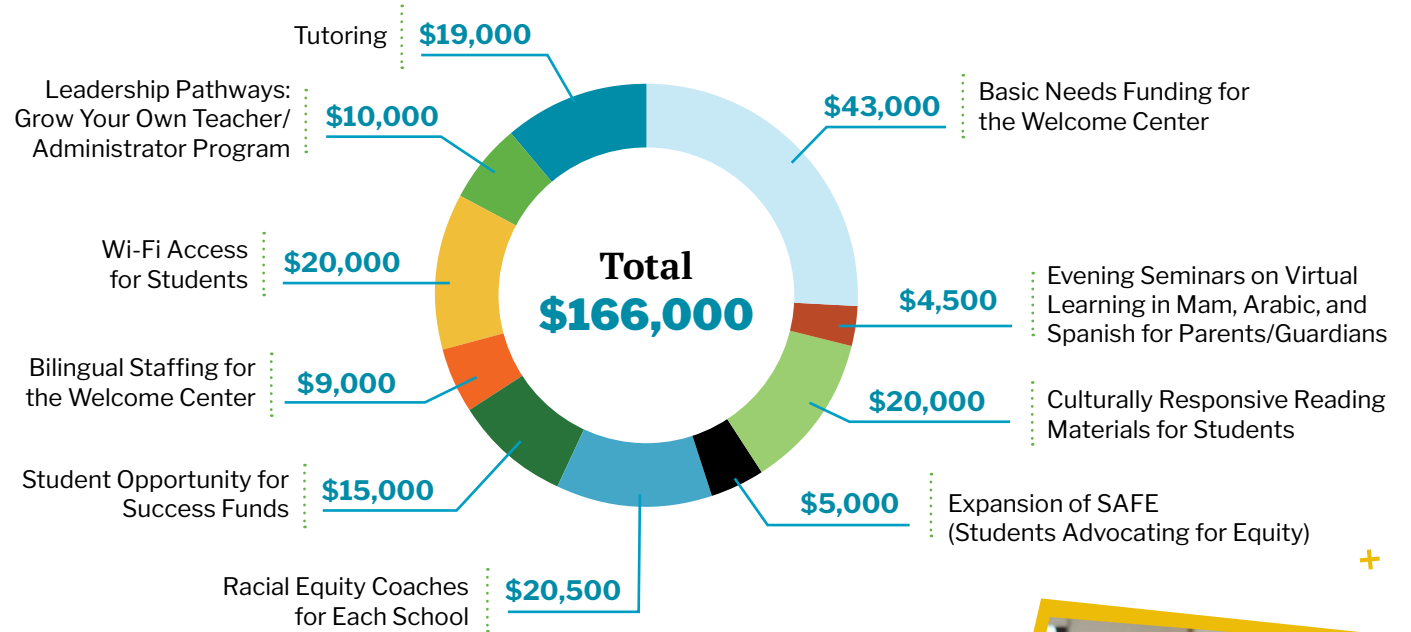

Helping Future Generations: CHS Class of 1958 Legacy Fund

It started as an idea to help celebrate the 80th birth years of the members of the Corvallis High School Class of 1958—but the gifts will be going to Corvallis High students for years to come.

COVID derailed plans for a 2020 gathering for the Class of 1958. But the idea to create a lasting gift kept gaining momentum.

James Woodcock, president of the Class of 1958, told his classmates, “Well, we ought to do something that leaves a real legacy.”

At first, the idea was a fund to award scholarships to Corvallis High School college-bound graduates. But two other ideas joined the mix: providing scholarships to students in vocational and trade programs, and supporting students with special needs and learning disabilities in the Life Skills Program. With these goals

in mind, the CHS Class of 1958 Legacy Fund was established at the Corvallis Public Schools Foundation.

The mix has appealed to donors like husband and wife Jerry and Julie Lear, both members of the Class of 1958: “I think that [having] those three pots ... appeals a lot more than just the standard scholarship thing,” said Jerry, a retired surgeon.

In May 2021, after less than a year of fundraising, the Class of 1958 crossed the \$20,000 threshold required for an endowed fund with the foundation. And it’s still growing: As of September 2021, the effort had raised nearly \$50,000.

Julie Lear, a longtime teacher, hopes other classes latch onto the Legacy Fund idea: “I hope that it’s catching for other classes,” she said. “I hope they’ll think about it.” 🌱

Trauma-Informed Teaching:

A Summer Course in English Literature

CPSF has been funding summer opportunities for students since 2014 as part of our commitment to increasing high school graduation rates. Since that time, graduation rates have risen by more than 20 percentage points, from 67 to 90 percent.

The room in Corvallis High School where Matthew King taught a summer 2021 class doesn't look like a typical classroom.

That's because it isn't a classroom. For his class on trauma-informed literature, King commandeered a staff room on the school's second floor, rearranged the couches and comfortable chairs into a circle and added lamps—in part because “I just don't like overhead lights,” but also because fluorescent lights can be irritants to students who have experienced trauma.

“One kid remarked that it looked like a therapist's office,” said King, who developed the summer class with help from a grant by the Corvallis Public Schools Foundation.

The class, which included 13 students, is an extension of King's work on “how traumatic childhood experiences affect the brain and how people view the world and behavior.”

“We're not necessarily talking about a class that is designed for people who are survivors of trauma or abuse or neglect,” he said, “although I think probably it might be a more friendly environment to those who are.”



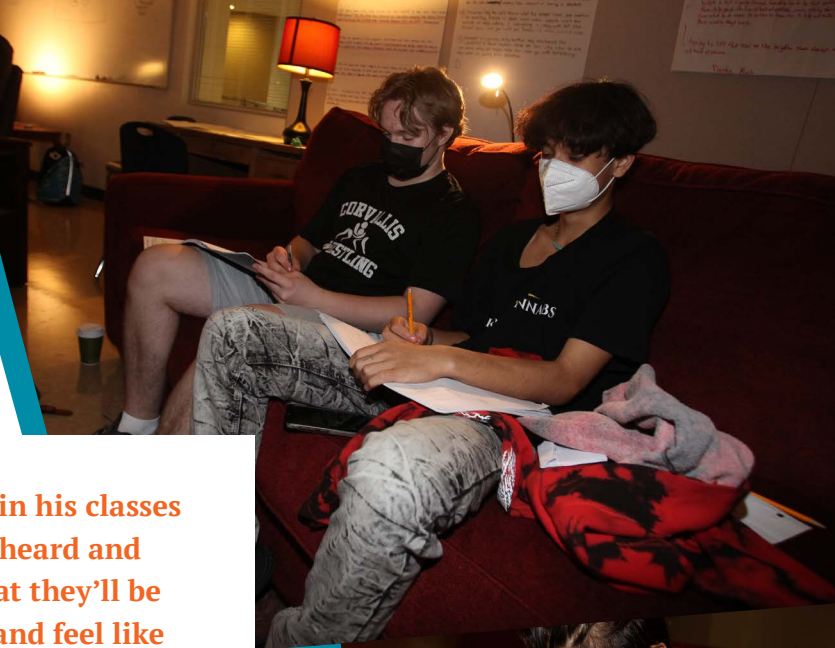
King hopes the students in his classes will “feel more seen and heard and understood at school; that they'll be able to walk into school and feel like there is someplace here that is for them and where they belong.”

So in the first week of class, for example, students watched and reflected on TED talks about how traumatic childhood experiences can affect the lives of survivors for years afterward—and can reduce their life expectancies.

Activities also included more traditional English class assignments—reading a variety of materials (including a novel written in verse) and writing.

King hopes the lessons he learns in developing and teaching the class will sharpen his skills when he returns to more conventional classrooms.

And he hopes the students in his classes will “feel more seen and heard and understood at school; that they'll be able to walk into school and feel like there is someplace here that is for them and where they belong.” 🌱

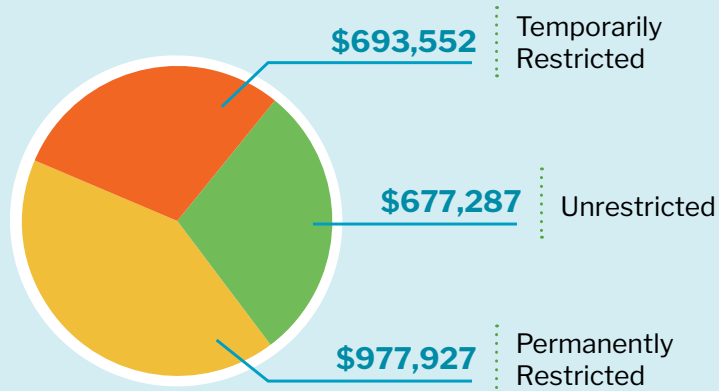

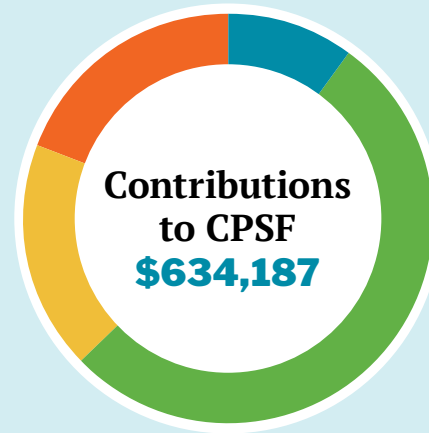

Walking the Talk on Equity and Inclusion: The SAFE Program



Each year, CPSF awards grants designed to encourage innovation and advance equity. Here is a glimpse of how one grant-funded program is making a difference.

It was 2017, and Yannie Reyes-Alvarez, then a senior at Crescent Valley High School, was answering questions as part of applying for a spot with a new Corvallis School District initiative, Students Advocating for Equity (SAFE).

One question stopped her: Have you ever experienced racism in Corvallis?

For Reyes-Alvarez, the answer was “yes.”

“I was about 16,” she recalled, “and I was with my mom and a cousin who had just moved from Mexico. ... This man and

his girlfriend just came up to us and started yelling at my mom, telling her that she was stealing and that she was the reason why this country was the way that it was and to go back to her country. I just remember feeling powerless, completely, because I had never experienced something so hateful in my life. I froze.”

That incident inspired Reyes-Alvarez to seek a spot on the district’s first SAFE team, a group of diverse high school students charged with providing a student perspective on race and inclusivity in Corvallis schools. She made the team.

Since that first year, SAFE has grown. In the 2021-22 school year, thanks to funding from the Corvallis Public Schools Foundation, the program will expand to every district school. In addition, one teacher at each school is being appointed to focus on equity issues.

SAFE students meet at their schools and, before the pandemic, met monthly at the district office. In the 2020-21 school year, most of the meetings were virtual.

SAFE offers students a safe place to discuss issues of race and equity. And sometimes it helps students work through issues of identity. College Hill High School student Maria Coppola has a father who identifies as Middle Eastern North African. Her mother is white. Coppola sometimes has felt caught in the middle.

“SAFE has helped me feel more confident that I can be

somewhere in the middle of white and not-white and still be whole and be worthy,” said Coppola.

The students say their SAFE mentors—teachers and administrators—are inspirational.

And the mentors say they draw inspiration—and hope—from their students.

“The students have changed,” said Isley Gonzalez-Dumble, the SAFE mentor at Cheldelin Middle School and a 2021 Golden Apple Award winner. “They stand up for each other more; they care about each other.”

Germaine Joseph-Hays, a SAFE mentor at Corvallis High School, has seen her students “just finding their voices, feeling secure about who they are ... and feeling like they can actually have conversations with peers that probably they were not able to have before.”

Reyes-Alvarez found her voice, thanks in part to SAFE: “I don’t want to freeze ever again,” she said, recalling that verbal venom aimed at her mother. “I want to be able to stand up for myself and for my mom.” 🌱

Donor Spotlight: Sharon Rackham King

“For Corvallis artist Sharon Rackham King, the Corvallis Public Schools Foundation is at the intersection where many of her passions meet—art and education and, more recently, speaking out about the importance of mental wellness.

King and her husband, Andrew, are frequent donors to the foundation, and many of their donations have concentrated on programs focusing on mental health.

It’s an issue that resonates with King, who moved to Corvallis in 2009 because she and her husband “wanted our two kids to have a really good educational experience.” She volunteered at Mountain View Elementary, including a years-long stint as the school’s artist in residence. At the time, she suffered from mental-health issues, including depression, but “I felt very awkward talking about it because there certainly was more stigma around it ten years ago.”

Reading statistics about mental health and youth—especially LGBTQ+ students and students of color, who may experience higher than average levels of stress, as well as barriers in accessing programs geared at addressing mental health—gave her additional motivation to speak out.

“It’s just hard to ignore that there are some vulnerable populations that can use more help,” she said, “and going to

school is one of the main ways where they automatically have access to a delivery system.”

Even a little bit of money can make a big difference. “Sometimes, it’s just snacks,” King said. “It’s snacks, so counselors can dangle a box of doughnuts and say [to students], ‘come talk to me.’ Sometimes we imagine the solutions to be out of reach more than they are.”

Her contacts with district employees working with students have been thrilling—and humbling, she said. “It’s humbling to know that a person or set of people in the district did the extra work, committed the extra time to using this gift to the betterment of students. It wouldn’t happen without that.”

“I’ve treasured my opportunity to partner with the foundation to make things that much better for our students.”

And that leads to a sense of gratitude.

“Not only have I had the opportunity to be a parent,” King said, “I’ve also been a volunteer in all the schools my kids have gone to, I’ve taught art alongside certified teachers—amazing teachers—and I’ve treasured my opportunity to partner with the foundation to make things that much better for our students.”

PROVIDING INPUT TO THE SCHOOL BOARD AT VIRTUAL MEETINGS DURING THE PANDEMIC

(Revised 09-09-21)

The Corvallis School Board values the opinions and input of students, staff, parents, and community members. Comments may be provided during certain meetings, via telephone, and via written correspondence, as outlined below.

Public Comment at School Board Meetings

This option is available when *Public Comment* is an item on the agenda. At this time, Board meetings are held virtually and there will be no in-person public comment. To offer comments via telephone during designated meetings:

- A. Email Board Secretary Kim Nelson at kimberly.nelson@corvallis.k12.or.us by noon on the day of the meeting.
- B. Provide your name, home address, and the telephone number you will be calling in on.
- C. You will be provided a telephone number and meeting access code.
- D. At the time designated on the agenda, call the number provided and enter any required access codes.
- E. You will be “in the waiting room” until it is your turn to provide comments; at that time, you will be admitted to the virtual meeting.
- F. When you provide public comment, your name, address, and comments are matters of public record; however, students and staff do not need to provide their addresses.
- G. Keep your comments within the specified time allotted, usually three minutes, to allow time for others to comment. Please be respectful of those who wish to comment after you.
- H. Direct your comments to the School Board. The Board Chair will refer questions or requests for action to staff for response at a later date.
- I. If you read from a prepared statement, you may choose to email your written comments to Kim Nelson at kimberly.nelson@corvallis.k12.or.us to post online with the informational packet of the meeting and to file with the official minutes of the meeting. It is not required, however.
- J. Speakers may offer objective criticism of District operations and programs but the Board will not hear complaints concerning individual District personnel.
 - Complaints shall be handled following the steps outlined in Board Policy KL and Administrative Regulation KL-AR, copies of which are available at <http://policy.osba.org/corvall/kl/index.asp>.
 - Complaints regarding budget, programs, or other District issues also should be handled by first following the steps outlined in policy KL.
- K. Undue interruption or other interference with the orderly conduct of Board business cannot be allowed.
 - Defamatory or abusive remarks are always out of order.
 - The Board Chair may terminate a speaker’s privilege of address if, after being called to order, the speaker persists in improper conduct or remarks.

Letters, emails, and other written materials submitted to the School Board are considered public record. They may be submitted via U.S. mail to: Corvallis School Board, 1555 SW 35th Street, Corvallis, OR 97333. GENERAL PROGRAM UPDATES

Schools are up and running, and the team is actively working to make students, teachers and administrators comfortable. Complex remodel projects, and to a lesser extent, new buildings, all go through a period of “shake-down” as occupants try out new systems and identify necessary adjustments. Thank you to CSD staff and our contractors as they diligently pursue any open issues.

There continues to be a lot of activity on all fronts:

- The design team and contractor continue to work with the City on the permitting process for Kathryn Jones Harrison Elementary and Letitia Carson Elementary. Construction work on the new additions is scheduled to start this fall. The projects will continue into the summer of 2022.
- The Adams Elementary building permit package is being submitted this week, and the project is out for subcontractor and supplier bids. Work will start in the spring of 2022.
- Lincoln Elementary is running well. The playfield area is under active construction. The new playground is open and being used! Although the bulk of the work will be done by the end of December, the seeded playfields will not be usable next spring, as they will need time to fully establish.
- Bessie Coleman Elementary construction is going well, with classroom wings already seeing paint, ceilings and cabinetry. This building is on track for winter completion and occupancy with sitework to complete the summer of 2022. Discussions with City on conditions of occupancy are underway.
- Garfield Elementary is operational and the contractor is cleaning up their staging areas as they leave the site.
- The Mt. View and Franklin projects are both getting close to building permit applications and subcontractor bidding. Projects will start on site in the spring of 2022.
- The work at CVHS is being fine-tuned, with designers and contractors working to adapt to evolving programs and operational needs. There will be a small amount of additional seismic work performed next year.
- Corvallis High is enjoying the new covered outdoor classroom area, and the covered walkway is progressing nicely.
- The Cheldelin Library is beautiful, and the new circulation desk (delayed by COVID) is now targeted for the end of this month.
- The College Hill project design is close to subcontractor bidding and permit submission. Construction will be starting in the spring.

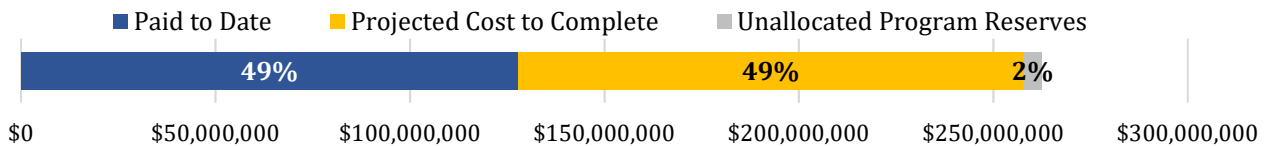

CVHS Renovation-Building F:

- Access controls are fully functional.
- Convergent & CSD anticipate that security cameras will be installed, aimed and functional by 10-21. Only 4 cameras remain on backorder (supply chain challenge) but the system can/will operate without them.
- The dust collector has been started, operated, and issues developed. The team is working with facilities and building staff to develop procedures for how to empty drums, maintain filters and work with a new system that has far more vacuum strength than the previous system.

- Challenges with installing epoxy anchors in an existing concrete structure have given the team fits and specialty drill bit unavailability (supply chain challenge) has extended the duration of this work.
- Elevator is installed 100% and is operational and available for ADA needs.

- Installation of delayed overhead doors – Thanksgiving time frame.
- Sorting out of surplus and disposal or repurposing of extra materials.

HIGHLIGHTS

- Despite the delay of 2 brace frames until next summer, the gym building is already substantially improved seismically.

CHALLENGES AND SOLUTIONS

- The construction and design teams are working with the building's CTE staff to ensure that technical systems effectively serve the growing needs of the programs.

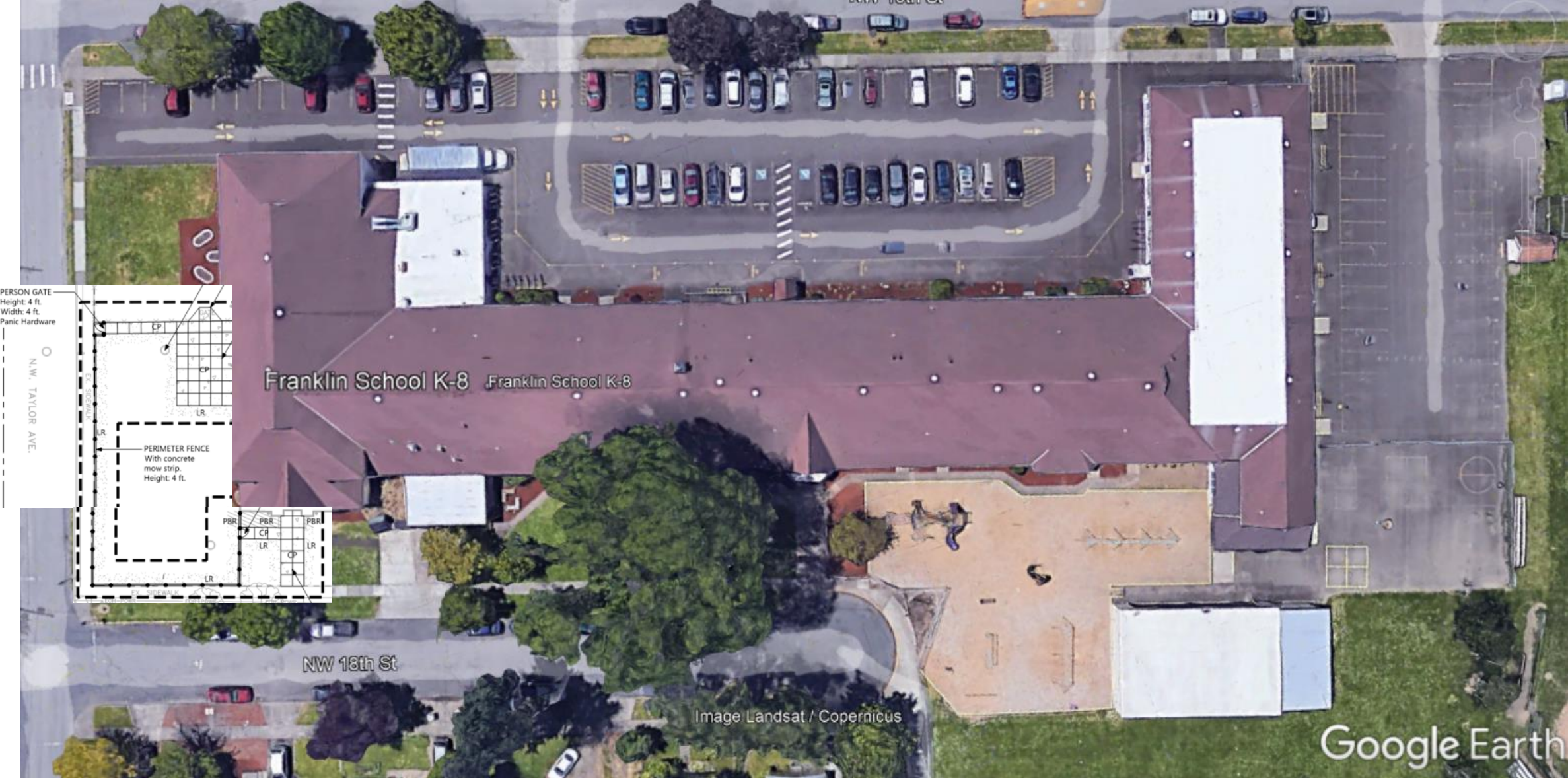

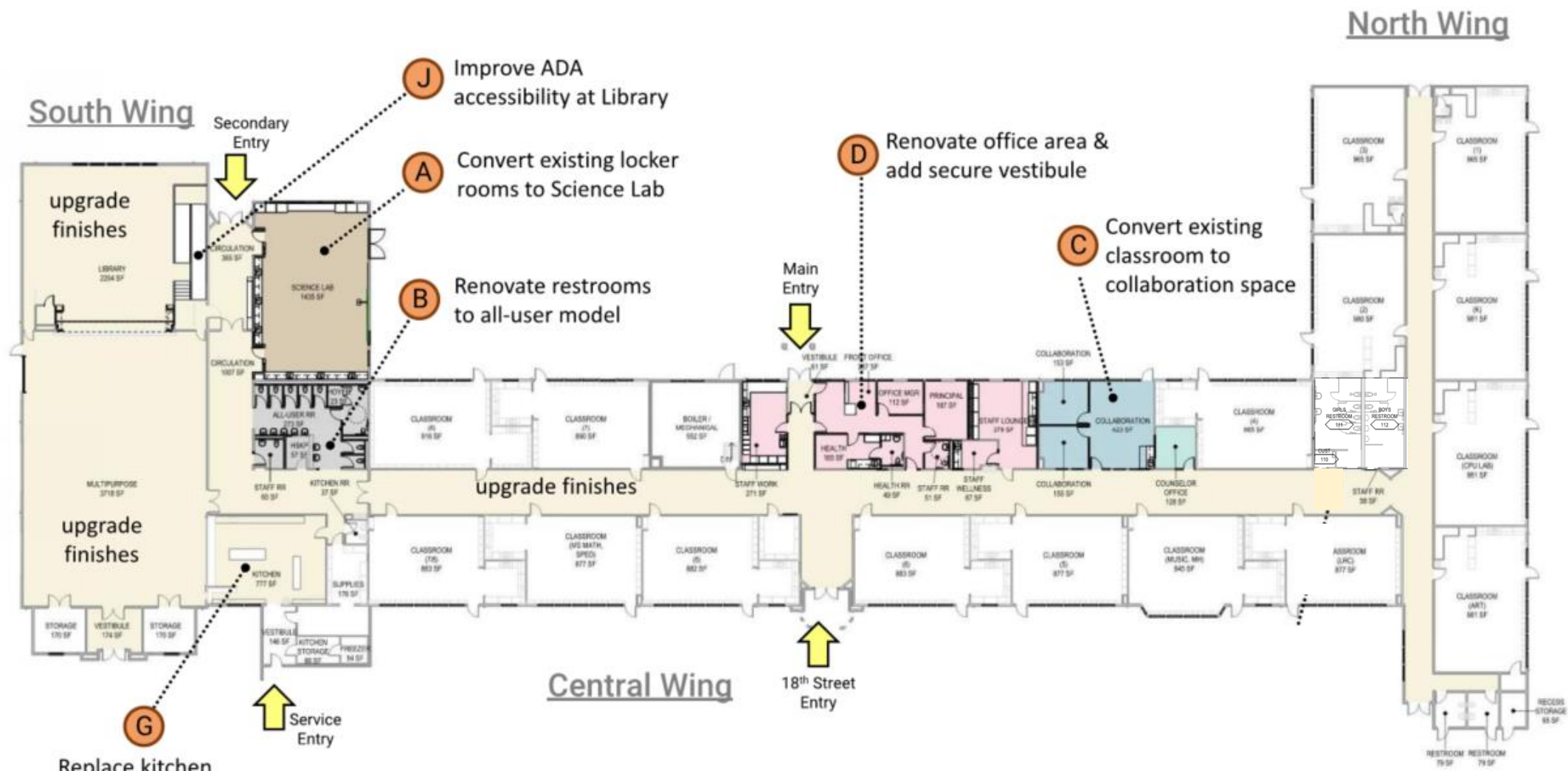

ACKNOWLEDGEMENT OF NATIVE AMERICAN HERITAGE MONTH
Resolution Number 21-1003

WHEREAS, the Corvallis School District recognizes and pays tribute to the significant contributions made in our community by Native American people which includes American Indians, Alaska Natives, and Native Hawaiians as well as Indigenous people from Canada, Mexico, Central America, South America, and the broader Pacific Islands; and

WHEREAS the Corvallis School District affirms that Native American students, families, staff, and community members should be valued for all aspects of their identities; and

WHEREAS, Native American Heritage Month grew out of efforts began by Dr. Arthur C. Parker of the Seneca nation's work with the Boy Scouts of America in adopting American Indian Day in 1912; and

WHEREAS, Rev. Sherman Coolidge of the Arapaho nation, and then president of the Congress of the American Indian Association, first proclaimed American Indian Day on Sept. 28, 1915, then calling on the nation to observe this day; and

WHEREAS, Red Fox James of the Blackfoot nation traveled across the country on horseback to gain endorsement of 24 state governments to hold a day to honor Native Americans nationally before presenting it to the White House on December 14, 1915; and

WHEREAS, American Indian Day was first declared May 1916 in the State of New York; and

WHEREAS, Native American Awareness Week was first proclaimed nationally in 1976; and

WHEREAS, what was then called National American Indian Heritage Month was first proclaimed nationally in 1990; and

WHEREAS, the Kalapuya people have called the Corvallis area and Willamette Valley home since time immemorial; and

WHEREAS, the Confederated Tribes of the Grand Ronde Community of Oregon and the Confederated Tribes of Siletz Indians continue to maintain their ancestral and cultural connections to the Corvallis area and broader Willamette Valley; and

WHEREAS, there are countless cultural heritages represented by Native American peoples; and

WHEREAS, The State of Oregon has a documented history of anti-Indigenous actions based on colonization which includes genocide, forced removals, deprivation, broken treaties, and the outlaw of Native American cultural practices; and

WHEREAS, education has been misused as a tool of colonization in Oregon serving to sever Native American children from their families, languages, and cultural heritages through boarding/residential schools beginning with the Indian Training School at Forest Grove which later moved and became Chemawa Indian School in Salem; and

WHEREAS, Native American Heritage Month provides an opportunity to continue the District's growth in learning about the many contributions of Native American people to the nation, world, and local community; and

WHEREAS, education is a necessary component for creating a more equitable and anti-racist community, nation, and world; and

WHEREAS, The Corvallis School District has made a commitment to equity and anti-racism; and

WHEREAS, The Corvallis School District has a responsibility to honor and respect the diverse histories of our community; and

WHEREAS, the Corvallis School District believes each and every student must be celebrated and appreciated for the distinct and vibrant contributions made by sharing cultures, language, ideas, beliefs and values within a school community.

Therefore, let it be resolved by the Board of Education of the Corvallis School District:

does hereby proclaim **November 2021**, as well as each November annually, as **Native American Heritage Month** in the District and strongly encourages students, families, staff, and community members to join in existing local celebrations; and

encourages all schools in the district to help highlight this month in grade appropriate ways as well as highlight the contributions of Native American peoples to the local community, nation, and beyond both, historically and in current times.

Division 22 Standards for 2020-2021 School Year

ACTION REQUESTED

Background

School district superintendents are required to provide a Division 22 Report to their local school board regarding the district's standing with respect to all Standards for Public Elementary and Secondary Schools as set forth in Oregon Administrative Rules [581-022-2305](#).

On June 3, 2021 ODE notified superintendents regarding the changes to OAR 581-022-2305 District Assurances of Compliance with Public School Standards that were adopted by the State Board of Education in May 2021. There are four major changes to the assurances process set forth in the revised rule:

- The timeline for districts to submit their annual Division 22 Standards Assurances shifts permanently from February to November.
- The rule explicitly states that assurances are made for the preceding school year.
- The rule includes clear language indicating that the district is reporting to the community (not just the school board) and that the report should be made “by presenting the report to the school board of the district in an oral presentation at an open public meeting, allowing for public comment, and by posting the report on the district’s webpage.”
- All districts are required to use the same report template for reporting to the community.

By November 1, 2021, school district superintendents are to report to their local School Board on the district's compliance with all Division 22 Standards in effect for the 2020-21 school year and to post the Division 22 Community Report for the 2020-21 school year on their district website. ODE also recommends that superintendents inform School Boards if there have been any recent changes in policy or practice that may take the district out of compliance with any of the Division 22 Standards during the current school year (2021-22).

After completing the local reporting process, districts will complete and submit to the Oregon Department of Education (ODE) the annual Elementary and Secondary Schools Assurance Form by November 15, 2021.

All changes and waivers to the Division 22 standards for the 2020-21 school year are set out in [OAR 581-022-0104](#): State Standards for the 2020-21 School Year.

The following rules were waived in their entirety:

- **581-022-2115 Assessment of Essential Skills**
- **581-022-2130 Kindergarten Assessment**
- **581-022-2325 Identification of Academically Talented and Intellectually Gifted Students**

Modifications were made to the following rules as described below:

- **581-022-2000 Diploma Requirements and 581-022-2010 Modified Diploma:** Diploma requirements for essential skills, education plan and profile, extended application, and career related learning experiences were waived.
- **581-022-2220 Health Services:** Required vision and hearing screenings were waived.
- **581-022-2263 Physical Education Requirements:** While specific grade level time requirements were waived, each public school student in kindergarten through grade eight should have received physical education throughout the entire school year.
- **581-022-2320 Required Instructional Time:** Districts were allowed to include in the calculation of required instructional time up to an additional 60 hours for staff professional development and up to an additional 60 hours for parent teacher communication to facilitate student learning, including parent teacher conferences, training, and support for distance learning. This allowance is in addition to the 30 hours allowed under OAR 581-022-2320(6)(d) and (e), respectively.
- **581-022-2350 Independent Adoptions of Instructional Materials:** Districts that use digital content as core curriculum for a course of study or any part thereof must complete an independent adoption of the digital instructional materials. If districts did not do this process in the 2020-21 school year, they will need to indicate this in their Division 22 reporting in November 2021, and complete the process to resolve this non-compliance. Districts must provide their local school board with the information in sections 1 through 7 of OAR 581-022-2350 to inform the local school board's review and independent adoption of instructional materials.

Corvallis School District is out of compliance with Division 22 Standards related to student assessment. These include:

- 581-022-2100 Administration of State Assessments
- 581-022-2110 Exception of Students with Disabilities from State Assessments
- 581-022-2120 Essential Skill Assessments for English Language Learners

The Corvallis School District did not administer the following statewide assessments in 2020-2021 – OAKS Tests (all subjects); Smarter Balanced (math and language arts); and Extended Assessments (all subjects). This was approved by the Corvallis School Board on May 6, 2021. The Corvallis School District will meet all assessment requirements set out in Division 22 in the 2021-2022 school year.

Additionally, Corvallis School District is out of compliance related to 581-022-2445 Universal Screenings for Risk Factors of Dyslexia. Elementary schools did not provide opportunities to universally screen for dyslexia in the primary grades due to required comprehensive distance

learning for most of the 2020-2021 school year. STAR tests (our usual universal screener) were not administered in the 2020-2021 school year. The Corvallis School District will meet all universal screening for dyslexia requirements set out in Division 22 in the 2021-2022 school year.

Board Policy DA—Fiscal Policies

Background

Fiscal policies clarify and crystalize the intent behind how a district will manage its financial resources. While districts should always comply with relevant laws and regulations promulgated by federal and state government, laws and regulations alone do not provide sufficient guidance for the board and staff to work together, optimally, towards the district's goals. Policies go further by establishing local standards for acceptable and unacceptable courses of financial action, parameters in which the district can operate, and a standard against which the district's fiscal performance can be judged.

Board policy DA was originally adopted by the board in December 2007, and then readopted in February 2011, June 2013, and October 2018. The current policy covers a wide array of fiscal policy topics including general fund ending fund balance, the use and replenishment of reserves, notice of shortfall, definition of a balanced budget, one-time nonrecurring revenues, financial reports, revenue forecasting, and year end budget surplus.

With specific regard to the level of general fund ending fund balance, the Government Finance Officers Association (GFOA) recommends, at a minimum, that governments maintain an unreserved (not earmarked for a specific purpose) ending fund balance of no less than five to fifteen percent of its general fund operating revenues, or of no less than one to two months of regular general fund operating expenditures.

In general practice, levels of fund balance, typically, are less for larger governments than for smaller governments because of the magnitude of the amounts involved and because the diversification of their revenues and expenditures often results in lower degrees of volatility. Higher levels of unreserved fund balance may be needed if significant revenue sources are subject to unpredictable fluctuations or if operating expenditures are highly volatile. Due to the volatility of state revenues and PERS employer contribution rates, devoid of any significant changes concerning state taxation or PERS, staff believes that the district's current policy designations and targets are set at an appropriate level.

Recommendation

Staff recommends a review of Policy DA and preservation of the existing ending fund balance designations and targets.

Function

No revisions proposed or needed at this time. Review of current policy.

Fiscal Policies

1. General Fund Ending Fund Balance

The Corvallis School District 509J School Board works to ensure that the district delivers the best educational program available within the constraint of well-managed resources. To offer such a program the Board recognizes the importance of a budget that delivers sustainable levels of instruction, staffing, number of instructional days and maintenance of facilities.

The State of Oregon has a volatile tax structure which results in unstable levels of school funding. This instability can cause a significant variance in the level of programs school districts are able to financially support. Until such time that the state creates a stable funding system that will see Oregon schools through recessionary periods, the Board directs the superintendent to propose a budget that will allow for sustainability over a five-year period.

The Board recognizes its responsibility to establish an ending fund balance in an amount sufficient to:

- a. Allow the district to deliver a sustainable level of programs through anticipated recessionary periods;
- b. Protect the district from unnecessary borrowing in order to meet cash-flow needs;
- c. Provide prudent reserves to meet unexpected emergencies and protect against catastrophic events;
- d. Meet the uncertainties of state and federal funding; and
- e. Help ensure a district credit rating that would qualify the district for lower interest costs and greater marketability of bonds that may be necessary in the construction and renovation of school facilities.

Consequently, the Board directs the superintendent to include in the annual proposed budget designations to ensure an ending fund balance as follows:

- a. Appropriated Contingency Reserve of two and a half percent (2.5%) of the General Fund total resources net of the beginning fund balance;
- b. Appropriated Rainy Day Reserve of five percent (5.0%) of the General Fund total resources net of beginning fund balance;
- c. Unappropriated Ending Fund Balance of five percent (5.0%) of the General Fund total resources net of the beginning fund balance; and
- d. Targeted Reserves Ending Fund Balance as may be allocated and designated for specified purposes such as a reserve to offset future PERS employer contribution rate increases, a reserve to offset a 50/50 biennial State School Fund allocation, or a reserve for equipment replacements.

2. Use and Replenishment of Reserves

- a. Appropriated Contingency Reserve may be used for unanticipated expenditures or for emergencies.
- b. Appropriated Rainy Day Reserve funds may be used to address adverse economic conditions which negatively affect the district's revenues and ability to meet the needs of students
- c. Unappropriated Ending Fund Balance is unavailable for expenditures as not appropriated.
- d. Targeted Reserves Ending Fund Balance may be used for specified purposes as designated.

In the event the Board authorizes use of reserves, the superintendent shall propose a plan to restore budget sustainability and replenish reserves within three years of use. At least fifty percent (50%) of unanticipated revenues, exclusive of State School Fund grant or other non-General Fund revenue, shall be dedicated to replenish reserves to target levels.

3. Notice of Shortfall

Should the projected ending fund balance for the current and ensuing fiscal year fall below target levels, the superintendent will notify the Board and propose a corrective plan of action to prevent or limit any further erosion of the fund balance, including measures to increase balances to target levels if possible. The plan will be submitted to the Board for consideration and action.

4. Definition of a Balanced Budget

The budget should be structurally balanced, where recurring revenues equal or exceed recurring expenditures. The annual proposed budget presentation will identify how recurring revenues are aligned with or not aligned with recurring expenditures.

5. One-Time Nonrecurring Revenues

One-time resources should be used for one-time expenditures that will not create a continuing obligation for the district or an unsustainable level of expenditures and should not be expended before revenues are received.

6. Financial Reports

The Board will receive regular financial reports that include estimates of expenditures for the district's various funds in comparison to budget appropriations, actual receipts in comparison to budget estimates and provide an update on the district's overall financial condition. Reports will keep the Board informed of significant changes impacting the district's overall financial condition due to changes such as state funding, demographics or other key factors. Supplementary reports will be furnished as needed or upon request by the Board or superintendent.

7. Revenue Forecasting

All revenue forecasts shall be based on conservative assumptions, though reflective of the latest, best information available. Revenue estimates shall be made through an objective, analytical process. The district will not include revenue in budget preparation that cannot be verified with documentation of its source and amount. Key assumptions will be presented in the budget document.

8. Year End Budget Surplus

To encourage responsible expenditure of budgets, fifty percent (50%) of unused budget appropriations for the General Fund will be made available to schools or departments in the following year, or an alternative rate as recommended by the superintendent in the proposed budget document and as adopted by the Board. The Board believes that the current budget allocations should benefit primarily current year students.

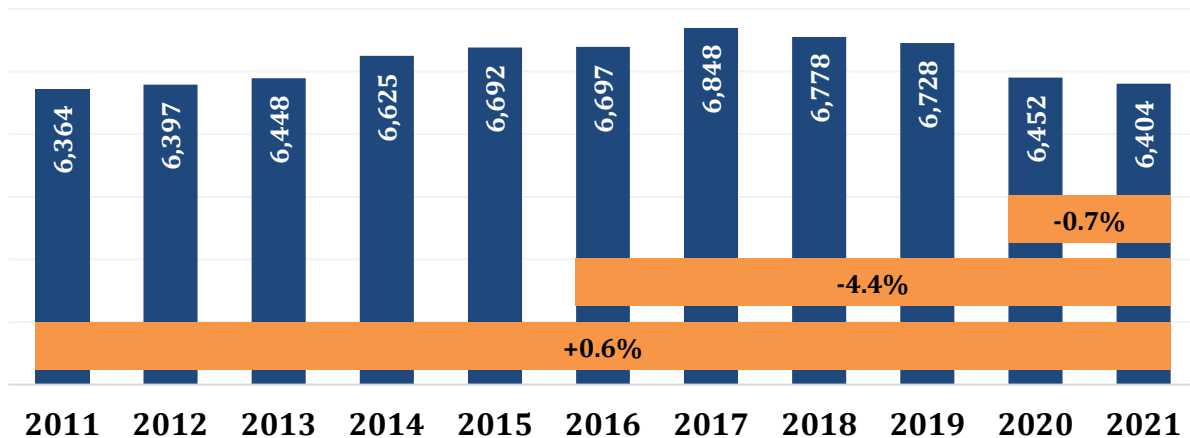
Enrollment Update

NO ACTION REQUIRED

The fall enrollment update is a representation of the preliminary number of K-12 students enrolled on the first school day in October each year. On October 1, 2021 a total of 6,404 students were enrolled in the district's schools and programs, including all regular and charter school programs.

Excludes YES House Alternative School

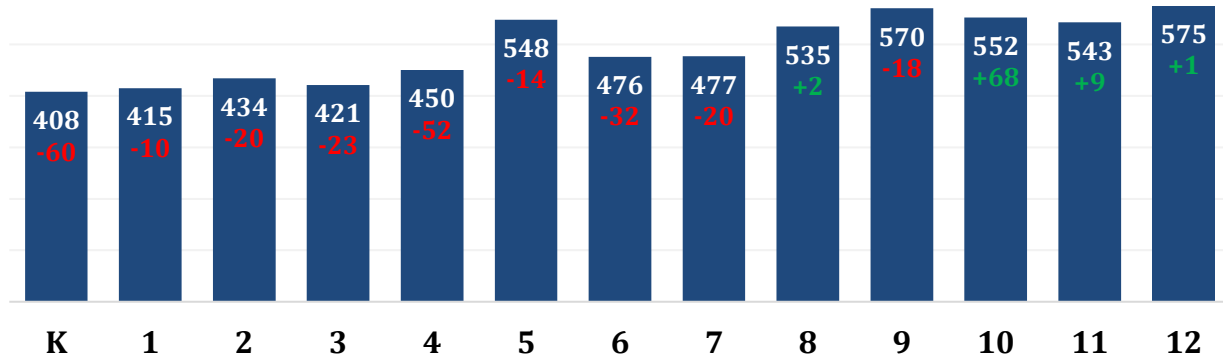


Compared to last year, total enrollment has decreased by 48 students or -0.7%. Compared to five years ago, total enrollment has decreased by 293 students or -4.4%. Compared to ten years ago, total enrollment has increased by 40 students or +0.6%.

Actual vs. Projected

The total enrollment of 6,404 students is 169 students less than what was projected for this year. Actual elementary enrollment is lower than projected by 179 students, while actual secondary enrollment is lower than projected by 10 students.

Enrollment by School

The average elementary school enrollment is 332 with a low of 260 (Mt View) and a high of 386 (Garfield). Middle school enrollment varies significantly between Cheldelin and Linus Pauling - by a difference of 241 students (46%). High school enrollment between Corvallis High School and Crescent Valley High School varies by 246 students (27%).

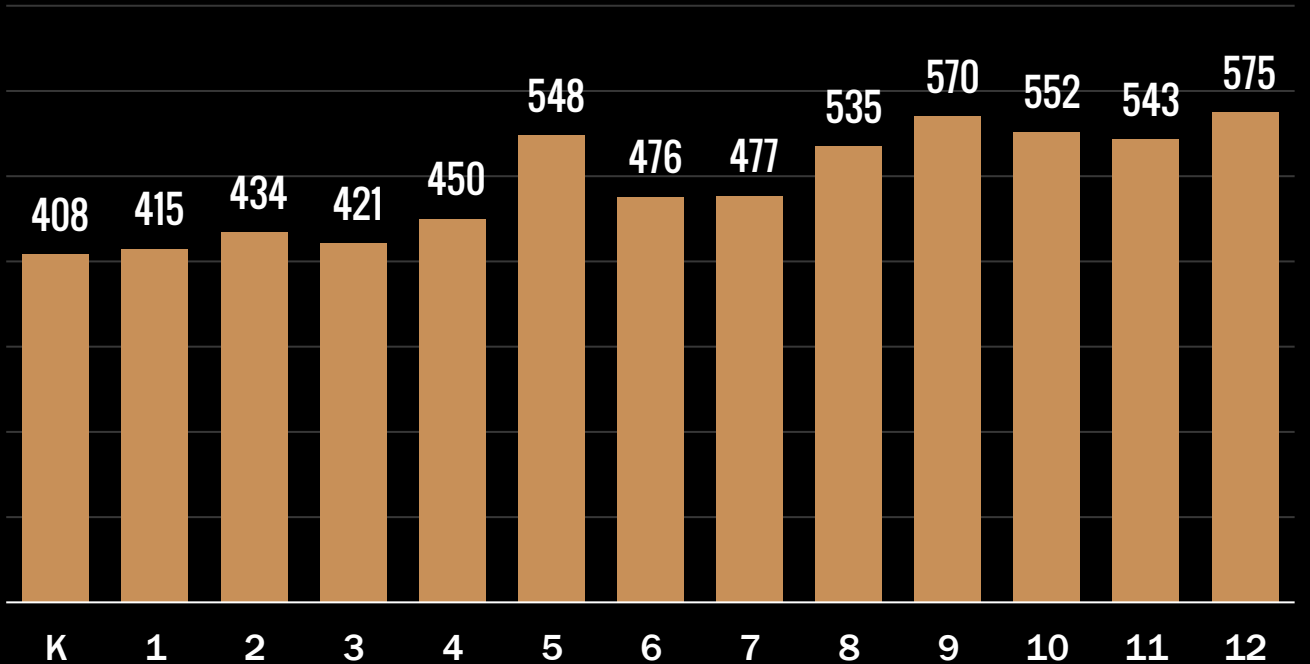

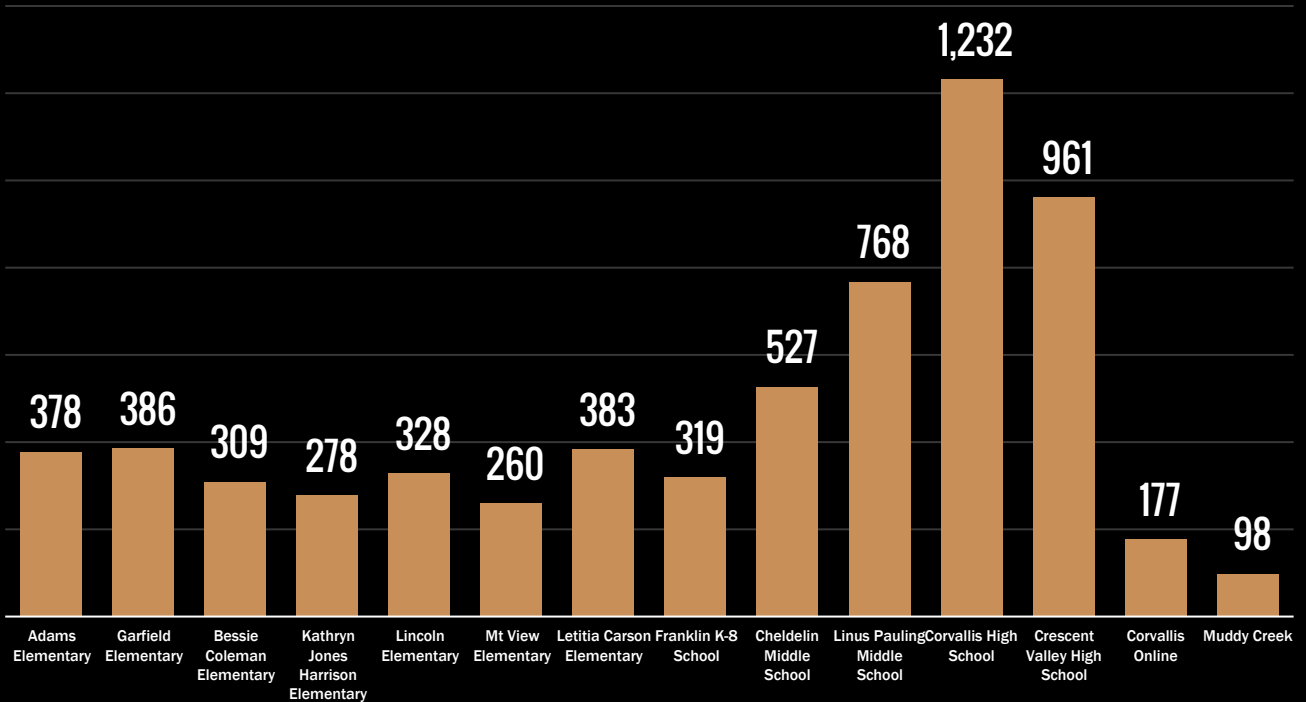

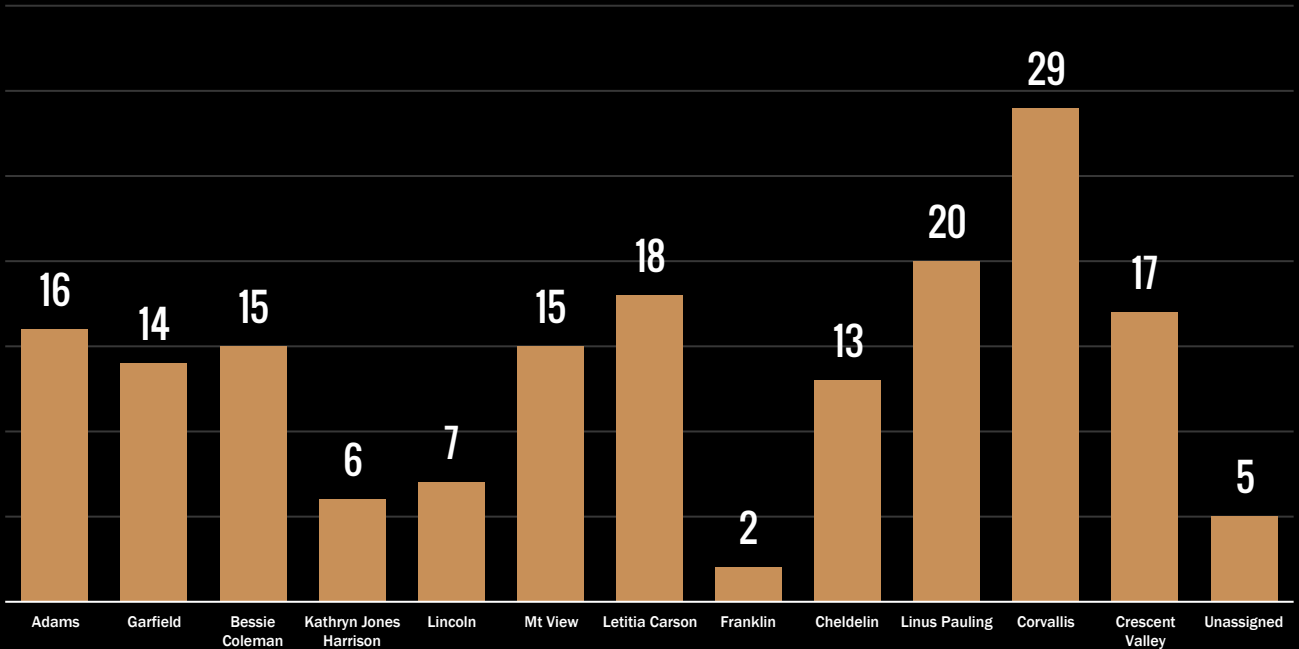
TOTAL ENROLLMENT BY SCHOOL

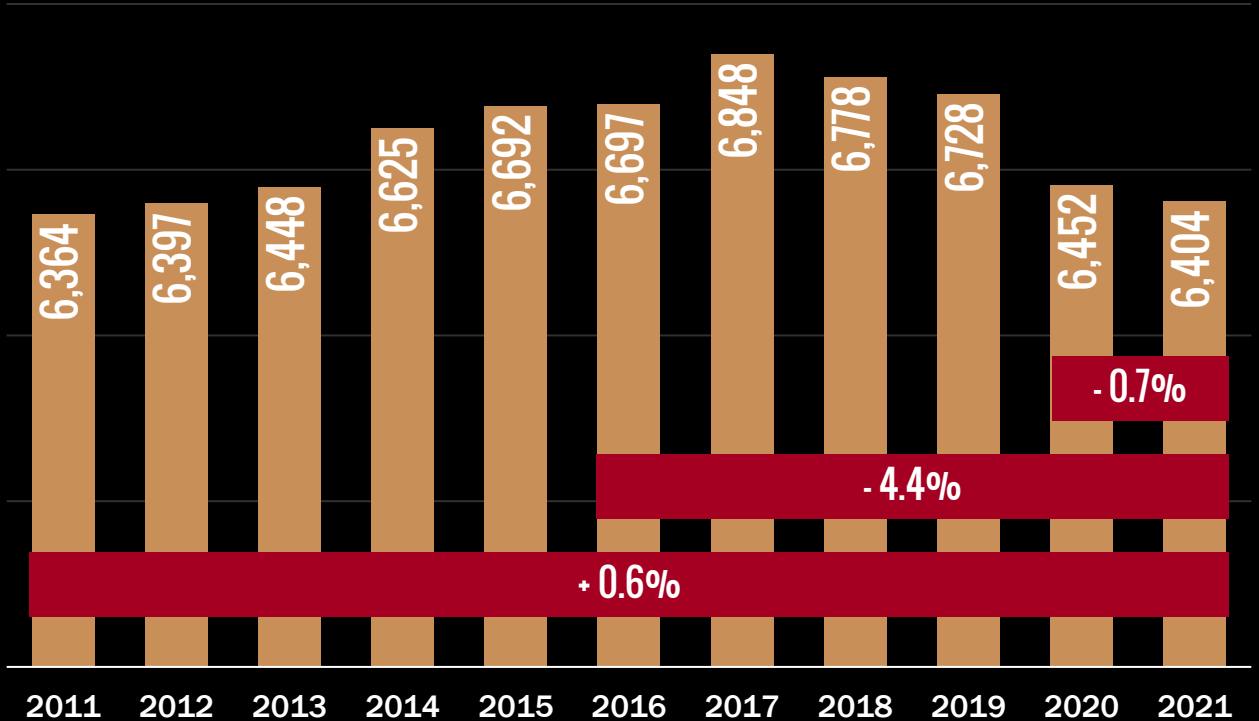

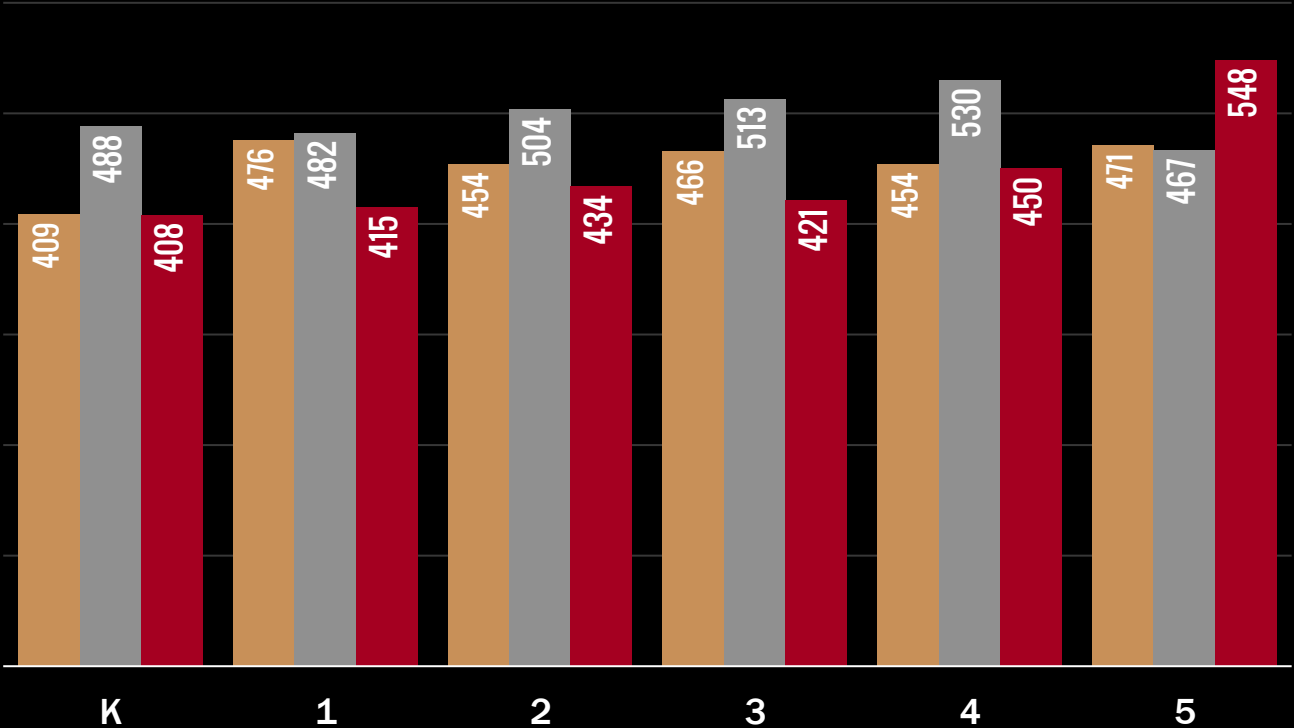

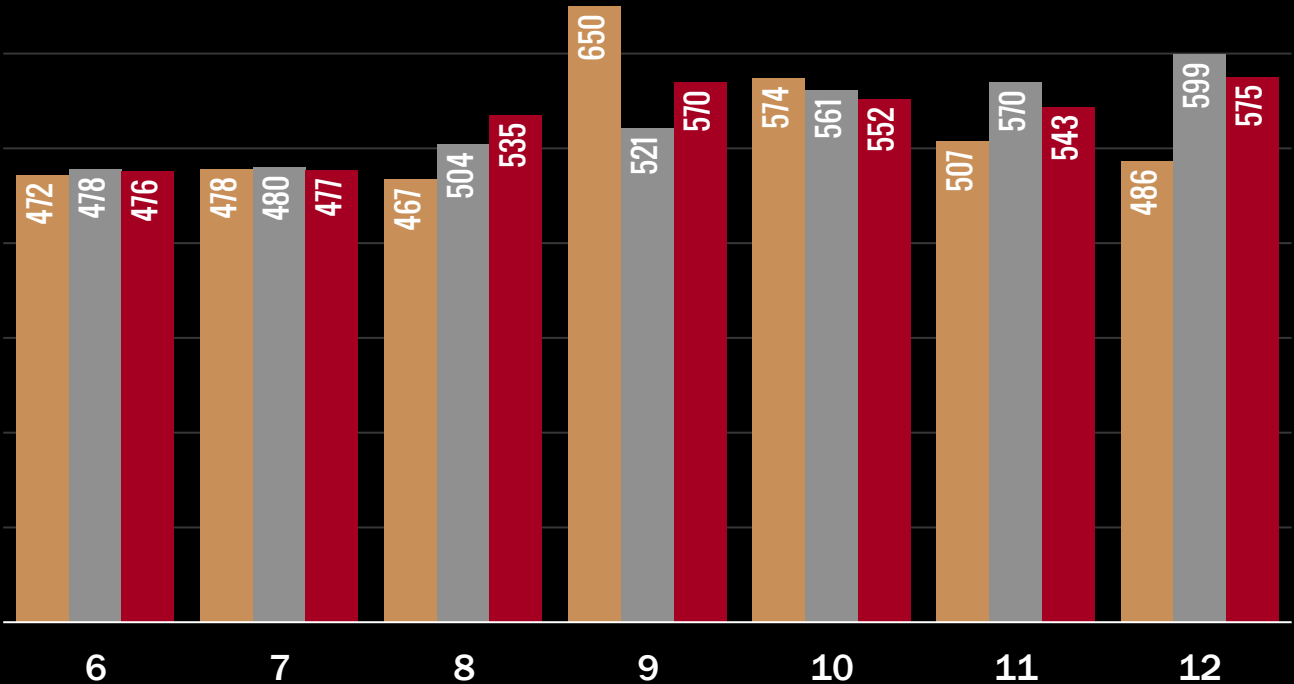
TEN YEAR ENROLLMENT BY GRADE

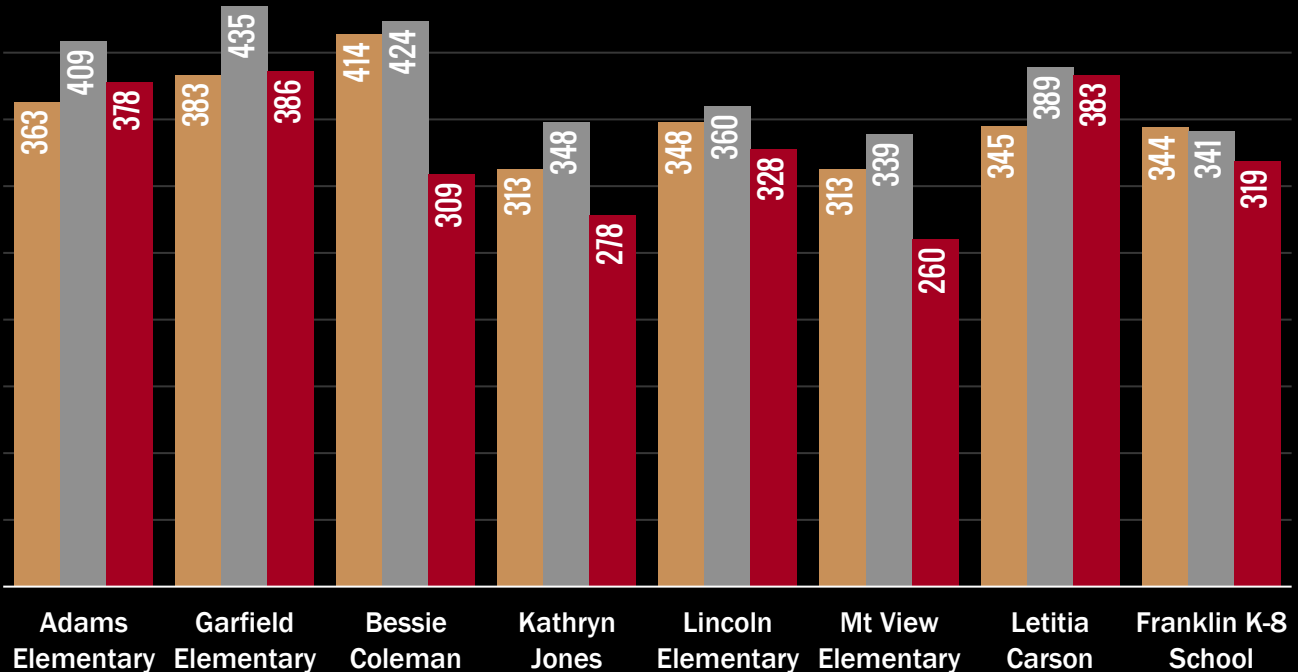

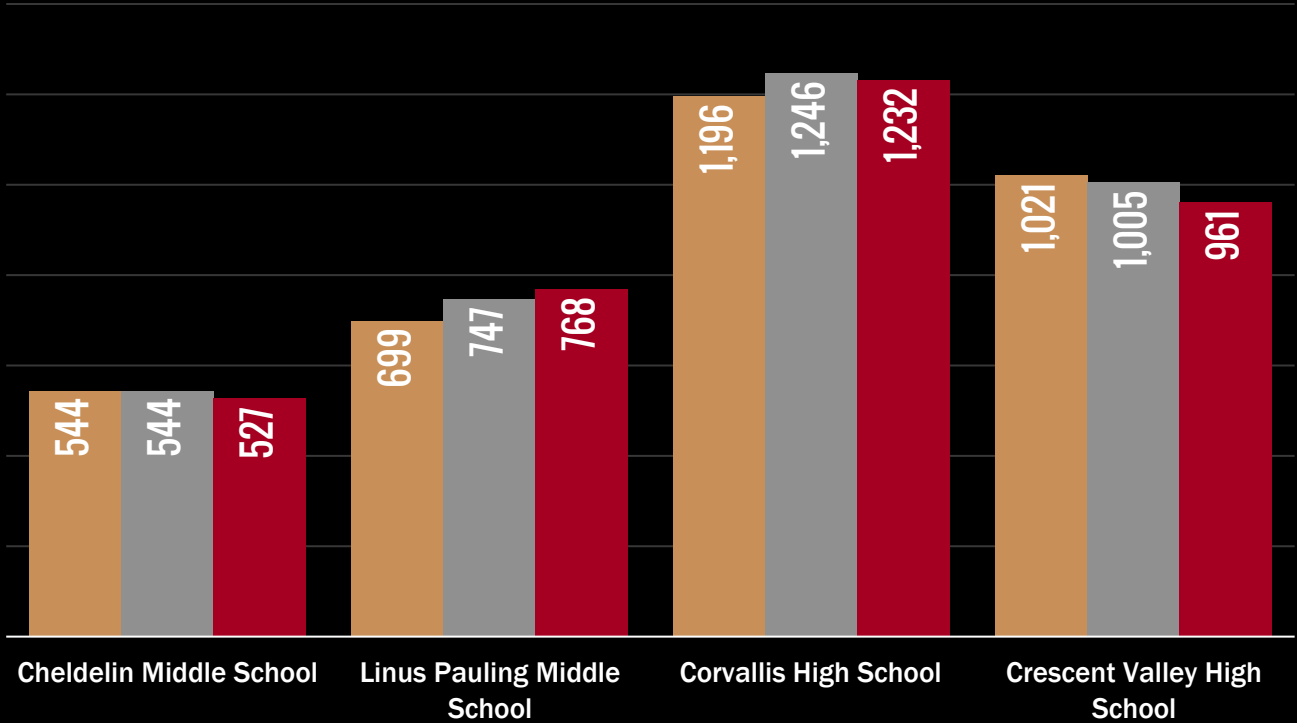
TEN YEAR ENROLLMENT BY SCHOOL

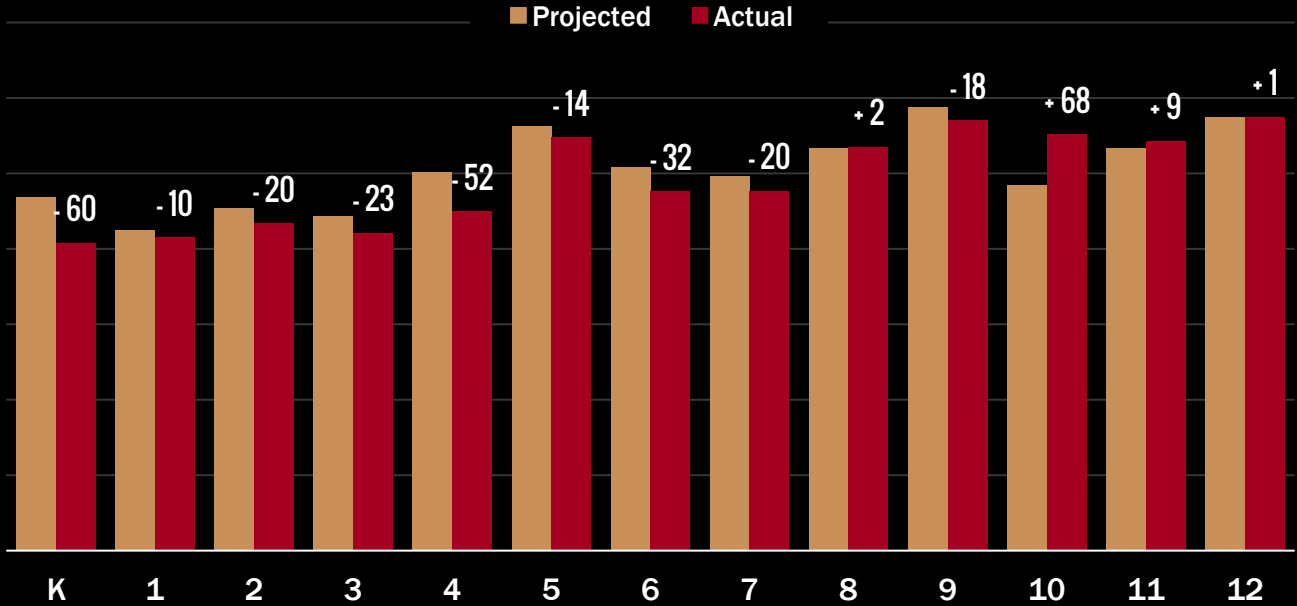

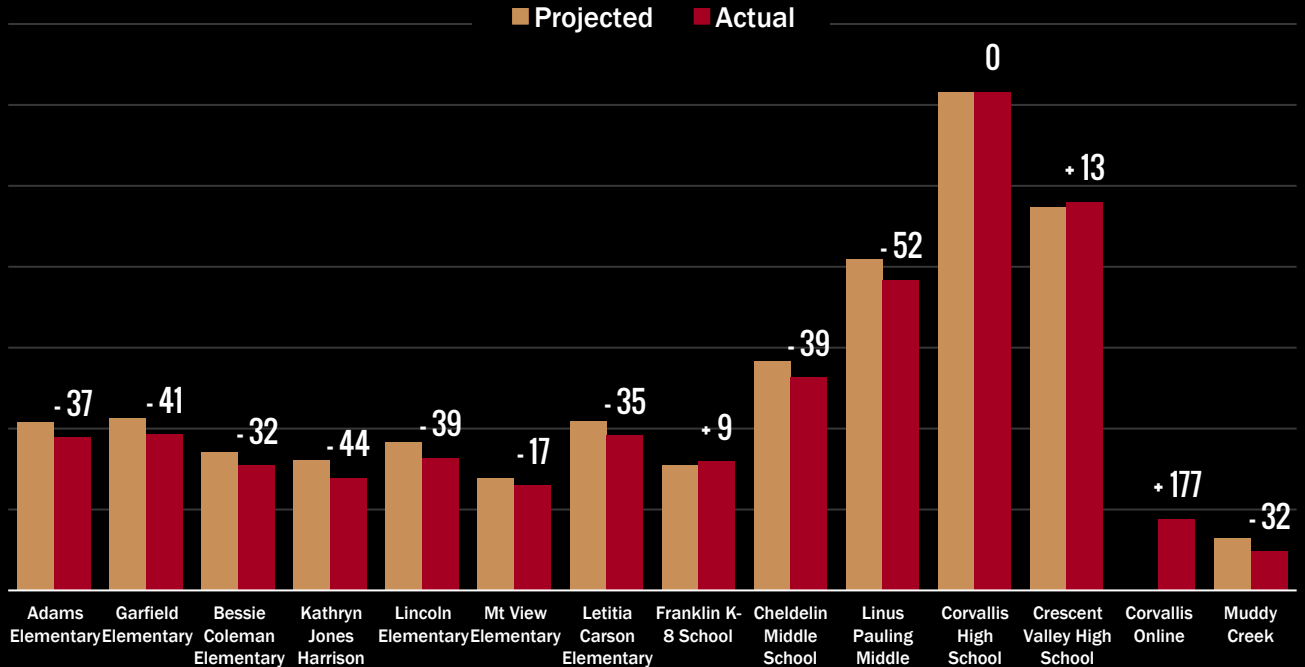

TOTAL ENROLLMENT BY SCHOOL



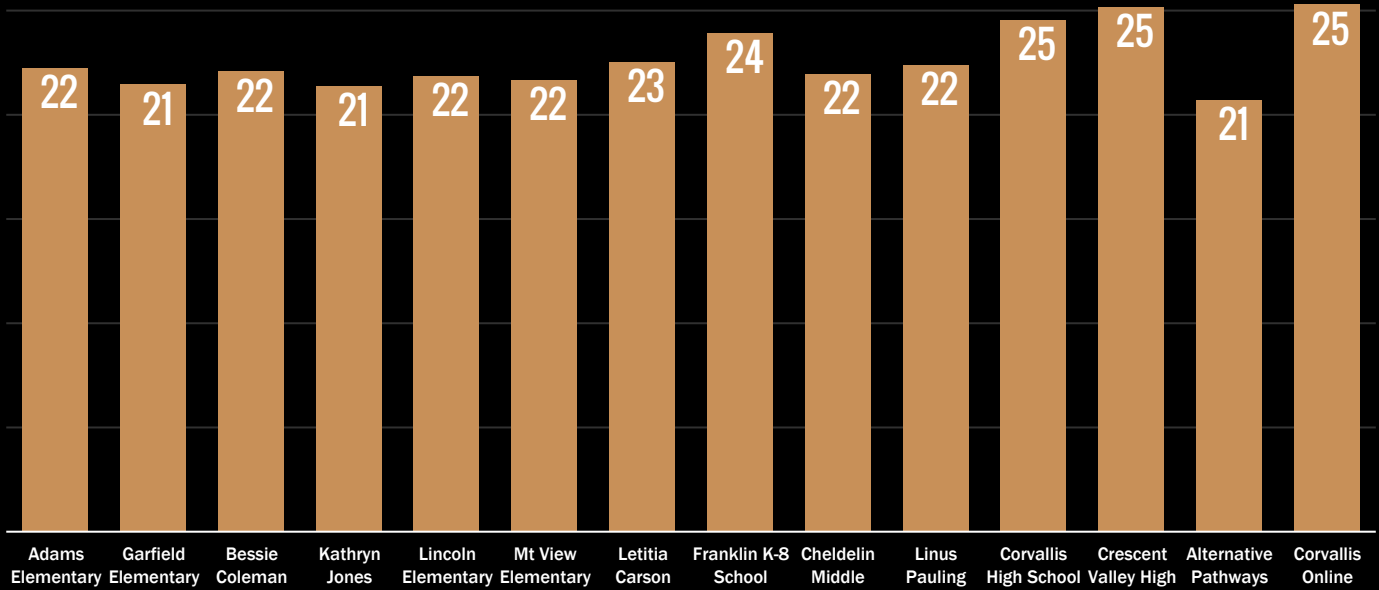
