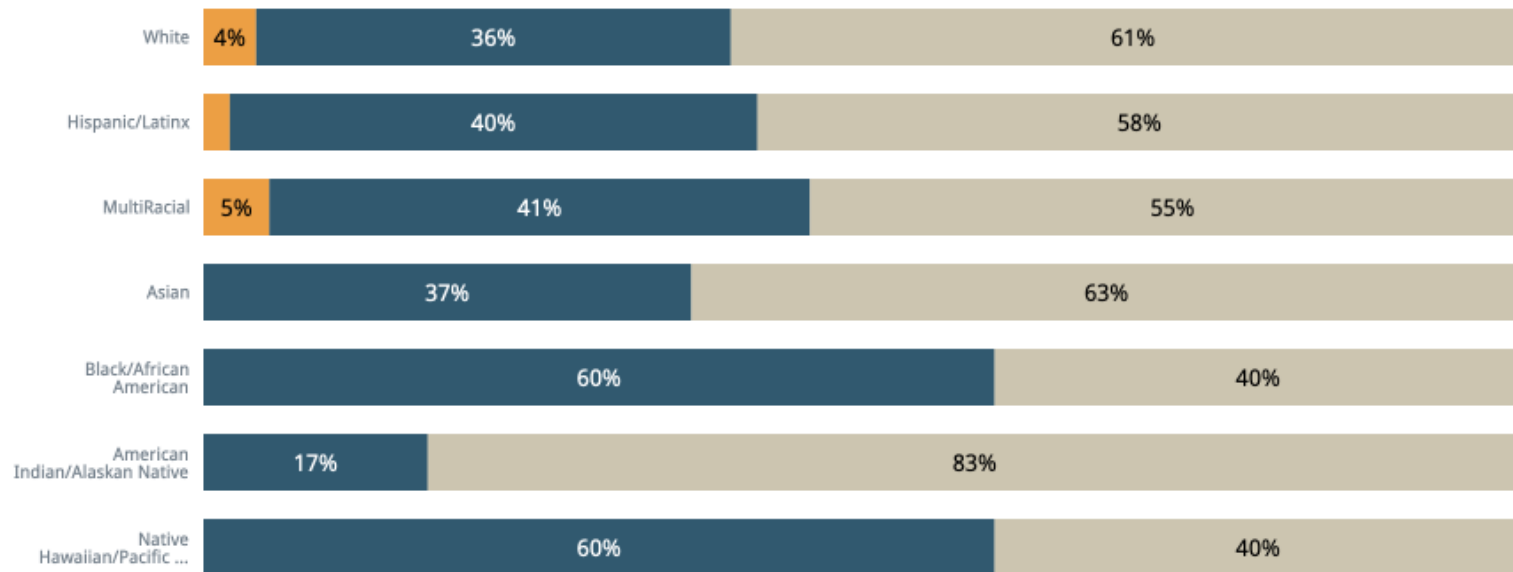

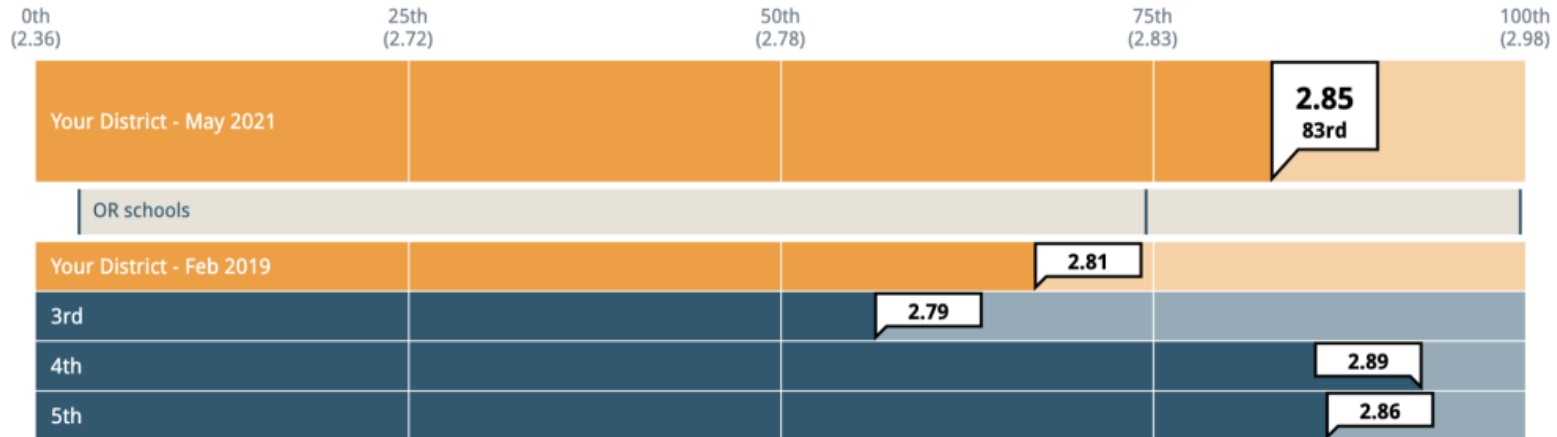

Do adults in your school respect people from different backgrounds? (People with different skin colors, boys and girls, people from different countries)

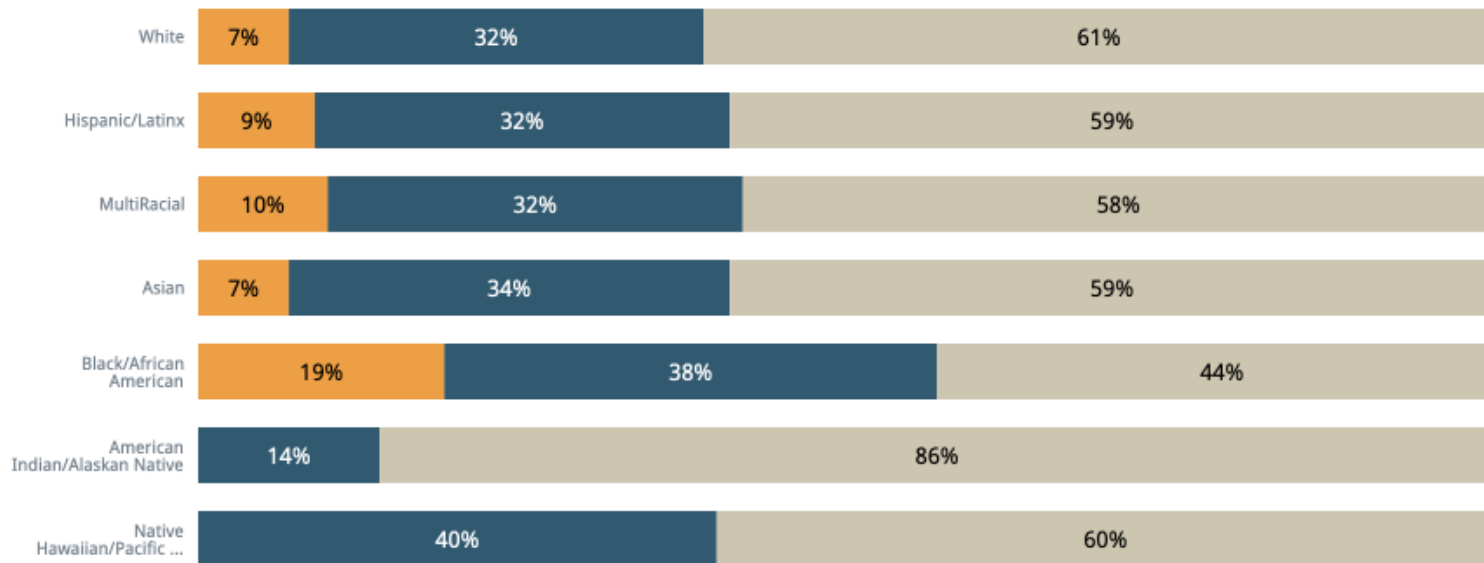

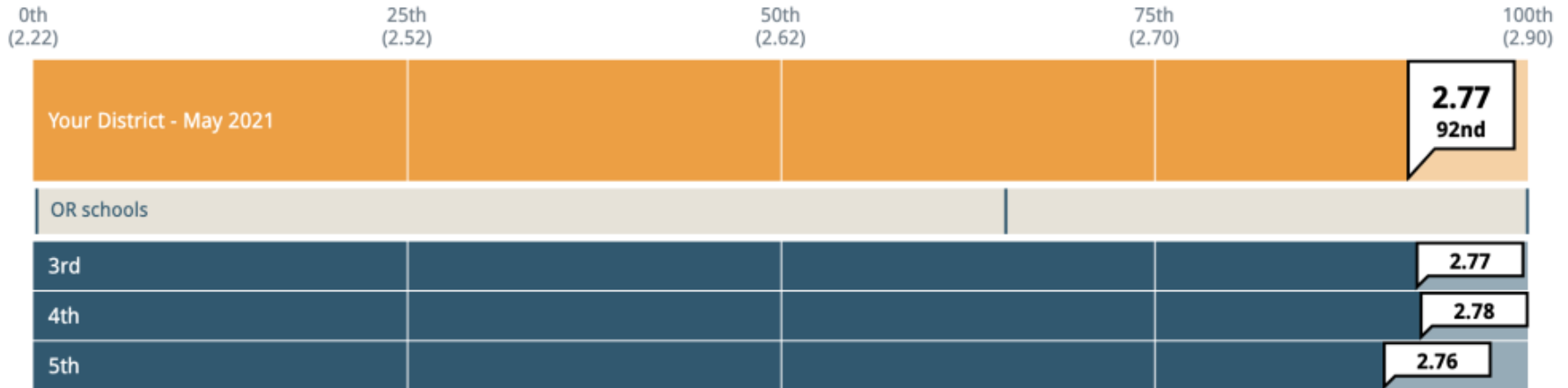

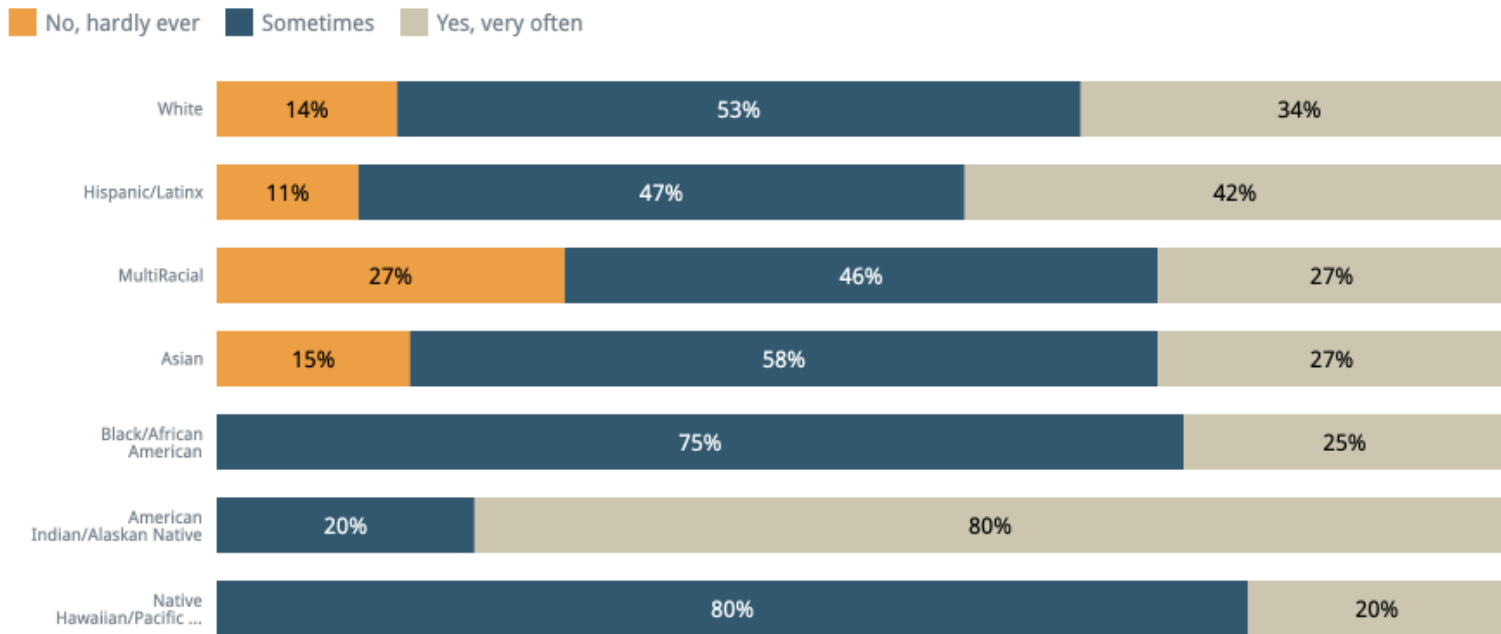

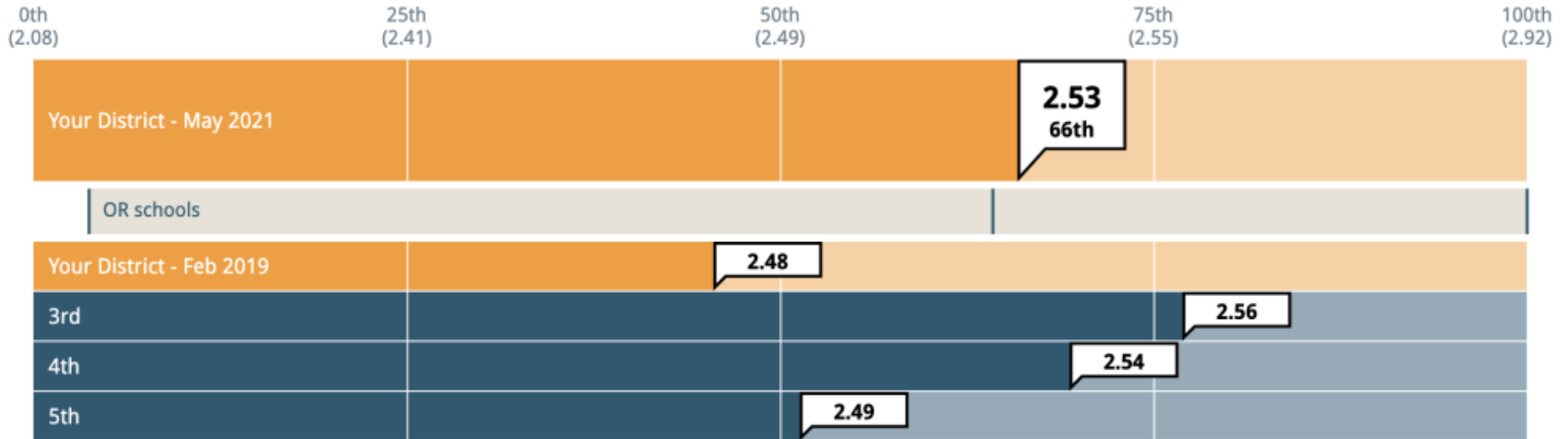

Do you like attending your class?

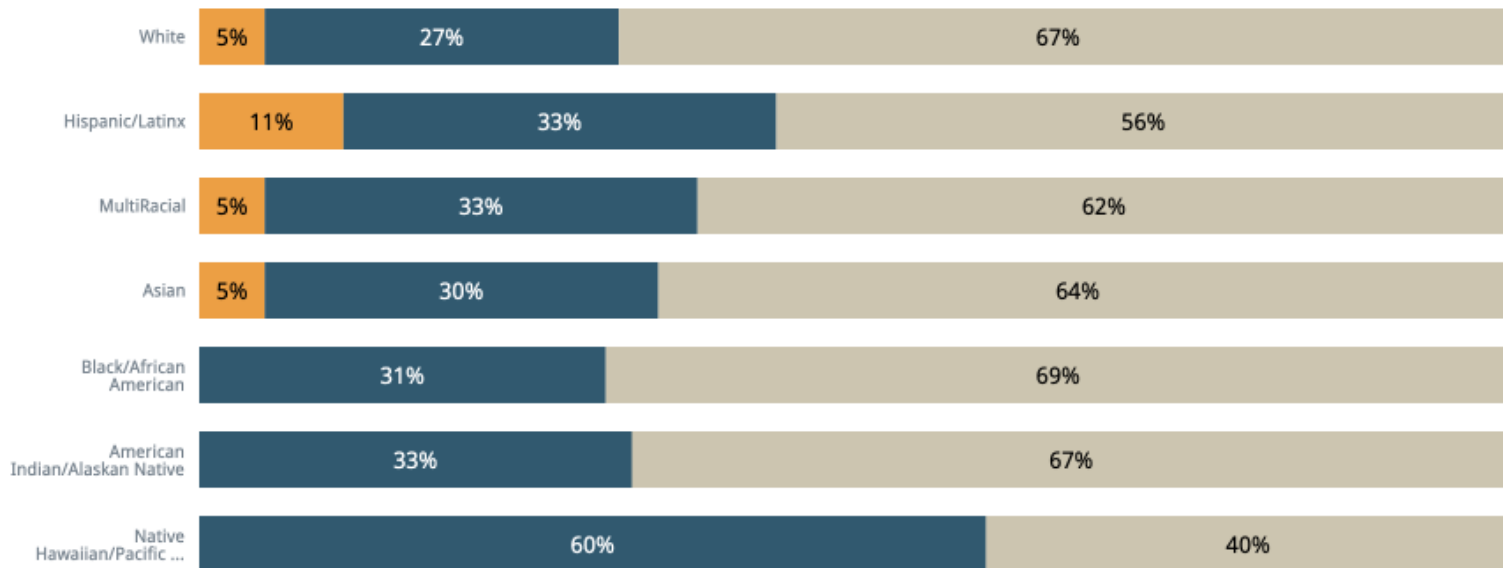

Bond Program Update

Wenaha Group's project managers will prepare a monthly report to communicate status and progress on bond projects. GENERAL PROGRAM UPDATES

Projects are actively bidding, and our contractors are assembling their Guaranteed Maximum Prices for our five remaining projects. We will present to the board this month pricing for Adams Elementary and the second phase of Cheldelin Middle School. Market conditions are challenging, with lots of subcontractor interest, but with higher than anticipated prices due to labor and material shortages, and a surprising amount of construction work happening in the region. Regardless, we've been forecasting increases, and are close to currently budgeted values. We are asking for a modest amount of bond reserve funds to cover these two projects.

In addition to the financial work, the teams are actively working on logistics planning. The construction managers are preparing site layouts and schedules to allow the work to complete while maintaining safety for staff and students. Our move coordination teams are taking these plans, synchronizing the necessary move activities and working with staff on packing and timelines.

Here's a brief overview of specific project activity:

- The Adams Elementary building permit is being reviewed by the City. A proposed contract amount will be before the board on November 18. Work will start in the spring of 2022.
- The building at Lincoln Elementary is under normal operations. The playfield area is being winterized and will resume in the spring, primarily to seed to fields.
- Bessie Coleman Elementary remains the hotbed of activity, with occupancy planned for December, with students and teachers using the building in January. Demolition of the existing school and the west side sitework will be complete the summer of 2022.
- Garfield Elementary is down to a few punch list items. It was great to see the green field where not-to-long-ago, there was a very active contractor staging area.
- Mt. View Elementary has just gone out for bids, with results targeted to the board in December and possibly January. Depending on the results, we may bring a partial package to the board in December for long-lead equipment and critical subs, and the balance in January.
- By the time of this November 18 board meeting, we will have a sense of the Franklin pricing, with GMP scheduled for the board in December.
- There continues to be refinement and enhancement of the CTE spaces at CVHS. There will be a small amount of additional seismic work performed next year.



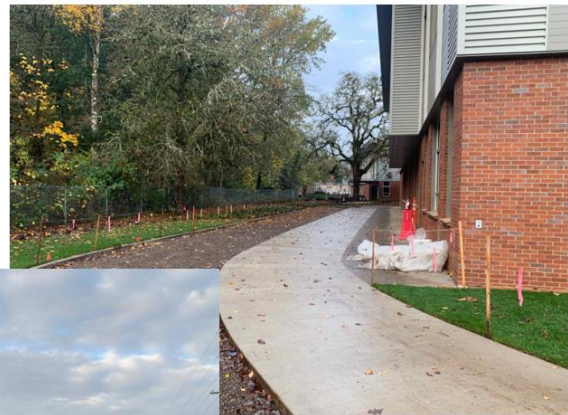
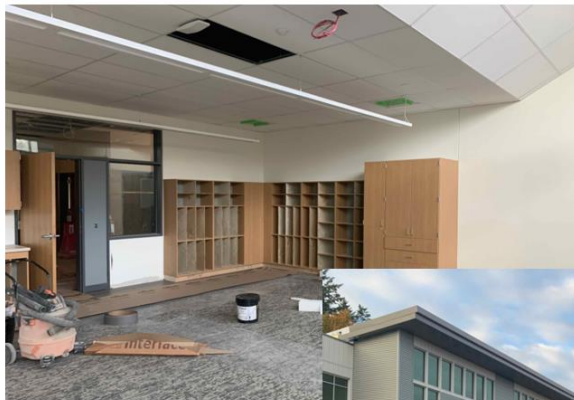

- The new covered walkway at Corvallis High is scheduled to complete in December. There will be some late materials (supply chain) being installed as they arrive later, and also work on the greenhouse remains.
- The Cheldelin Library circulation desk (delayed by COVID) is scheduled for the end of this month.
- The College Hill project design is going out for bids very soon, with board action anticipated in January.
- The design team and contractor continue to work with the City on the permitting process for Kathryn Jones Harrison Elementary and Letitia Carson Elementary. Construction work on the new additions is scheduled to start this fall. The projects will continue into the summer of 2022.

Highlights from Bessie Coleman Elementary (l-r)

- Classrooms are very close to completion.
- The bus loop area is ready for asphalt paving.
- The backside of the school, showing a wide sidewalk, an area prepared for “reinforced lawn” and landscaping. The reinforced lawn area provides a drivable surface for the fire department, while still being comfortable for student play.

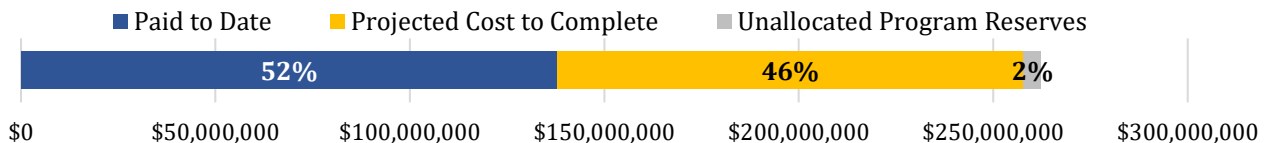

PROJECT DESCRIPTION

Add five (5) permanent classrooms, create collaborative/small group learning areas, create dedicated PE space by adding multi-use cafeteria, renovate existing classroom space for student support services, improve ADA accessibility, install energy efficient lighting, replace covered play shelter, upgrade finishes in hallways and shared spaces including floors, paint, and ceilings, upgrade mechanical infrastructure including electrical, heating, and plumbing systems, replace emergency communication systems, secure front entry, and office modifications.

CURRENT ACTIVITIES

- Both building permit and PIPC documents have been submitted to the City. Waiting for first set of comments.
- Fortis has bid the project. Despite large participation by the subcontractor market, cost escalation is a factor. GMP to be submitted to the board at the November 18th meeting.
- Fortis Construction working on project logistics and schedule strategy for a Spring Break start dependent on receipt of permits.
- Electrical service replacement work and low voltage fiber work for the District Office and Food Warehouse - Underground and vault work 90% completed and panels/equipment/transformers scheduled to arrive in January. This has shifted due to supply chain issues.

ACTIVITIES SCHEDULED FOR NEXT QUARTER

- Respond to comments from the City on PIPC and building permit applications.
- Continue with electrical service replacement project.
- Start move coordination for emptying locker room before Spring Break for construction work to commence.
- Coordination and permitting of modular placement for receipt of modulars from Bessie Coleman Elementary early in new year.

PROJECT DESCRIPTION

Renovation: Renovate classroom to create a STEAM lab, renovate library/media center, improve ADA accessibility to the front office and elsewhere in the school, renovate cafeteria, renovate restrooms, replace kitchen flooring, upgrade mechanical infrastructure including electrical, heating, and plumbing systems, improve emergency lighting, improve seismic safety, replace wooden bleachers in the gym.

Resurface existing track: Scope also includes enlarging the high jump area to accommodate two jumping areas and improving drainage around the long jump area – Now Complete.

CURRENT ACTIVITIES

- Updated: The new library circulation desk is re-scheduled for installation in the last week of November. This delay is due to a COVID impact on a small business.
- Pivot to submitted construction drawings for this next phase to the City for permit review before Thanksgiving.
- Phasing and schedule refinements continue as Gerding interviews Phase B subcontractors and discuss current scheduling environments.

- Gerding will install 2 replacement acoustical panels near the projector screen when they arrive in November.

HIGHLIGHTS – N/A

CHALLENGES AND SOLUTIONS

- Package B bids came in above our current allocated budget. The team has worked closely with architect and engineers to reduce scope without impacting school programming. Reductions include refining HVAC work to include refurbishment of existing equipment (rather than replacement) and seismic work has been focused to prioritize the highest risk areas. These scope reductions also enhance the project schedule by eliminating HVAC procurement challenges as well as minimizing impacts on classroom operations. These adjustments are being made while still meeting the bond promises for the project.

PROJECT DESCRIPTION

Adds multi-use cafeteria like reception, renovate two (2) classrooms to support science construction, improve ADA accessibility, renovate locker rooms, replace cabinetry in classrooms, replace roof and gutter system, upgrade mechanical infrastructure including electrical, heating, boilers and plumbing systems, improve emergency lighting, improve seismic safety in one and two story portions of the building, install access control system, replace emergency communication systems, replace fire monitoring system and add an outdoor covered classroom space.

CURRENT ACTIVITIES

- Pivot is still on track to issue bid documents (100% CD) on November 18th.
- Wenaha is actively preparing and planning for CIMC move prior to spring break.
- Pivot has continued to conduct fun and interactive design meetings with staff. The teams have helped select colors, materials, and various power, plumbing and audio-visual products for spaces.
- Pivot also conducted meetings to confirm front office layout preferences and specialty classroom needs.
- Gerding has brought on board the superintendent for the project – James Lutz. James has put together a great start on a construction and phasing schedule that continues to evolve as our design finalizes. Particular attention has been paid to allowing enough time for Pacific Power work to occur and temporary conditions for data, power and heating needs during the first phase of construction.

Adams Elementary Guaranteed Maximum Price and Bond Reserve Allocation

Action Requested

Background

In May 2018, voters approved a Facilities Improvement Bond in the amount of \$199,916,925. An Addition and Renovation at Adams Elementary school was approved within the bond projects.

On October 11, 2021, Fortis Construction first advertised bids for the Adams Elementary Addition and Renovation project on Building Connected. On October 16, 2021, Fortis Construction published an advertisement in the Corvallis Gazette-Times, requesting bids for the Adams Elementary Addition and Renovation project. Bids were due to Fortis on October 28, 2021, at 11:00 AM.

On April 25, 2019 the board approved use of bond program contingency to fund the seismic renovation costs that were over the seismic grant amount. \$591,163 of additional bond funds were required to complete the seismic renovation at Adams Elementary. During the 6/10/2021 board meeting, EC Electric was awarded \$390,270 to complete the electrical upgrades to the school. EC Electric has been issued two changes orders totaling \$67,632, bringing the total electrical upgrade to \$460,402. To fund the current GMP and complete the balance of the Adams project, Bond Leadership is recommending the board approve a bond reserve allocation of \$348,917 to cover the forecast costs at Adams Elementary. We anticipate utilizing all of the bond reserves, including premium from the most recent bond sale, to ensure the remaining bond promises are met district-wide.

Action Requested

Background

In May 2018, voters approved a Facilities Improvement Bond in the amount of \$199,916,925. Renovations at Cheldelin were approved within the bond fund.

On September 15, 2021, Gerding Builders published an advertisement in the Oregon Daily Journal of Commerce, and on September 14, 2021, in the Corvallis Gazette-Times, requesting bids for the Cheldelin Renovation-Package B, which includes seismic improvements to the gym and arts classrooms, multiple HVAC unit refurbishments, one new HVAC unit, complete renovations to multiple mechanical rooms, including adding terminal in line duct units to the duct systems throughout the school, adding ceiling fans to classrooms and increased ventilation to the classrooms. Bids were due to Gerding Builders on October 7, 2021. Previously completed Package A renovations included ADA improvements to the administration area, STEAM classroom improvements, restroom improvements, library improvements, cafeteria, and kitchen improvements, and the corresponding structural, HVAC, and electrical improvements related to those areas. The table below outlines the previous bond work approvals.

The bids that Gerding received for the Package B work exceeded the available funds. The District has requested a reduction to the seismic work in the classrooms and deleting the covered bike parking/solar work in order to bring the project within budget. At this time, Gerding Builders is requesting a Guaranteed Maximum Price Amendment in the amount of \$3,737,181, which will require a Bond Reserve allocation of \$258,282 to fund the work.

Authorize staff to execute a Guaranteed Maximum Price Amendment with Gerding Builders LLC for the Cheldelin Renovation- Package B project and a Bond Reserve Allocation to fully fund the project.

Education Update: Vaccination Progress Update **NO ACTION REQUIRED**

Background

At its October 14, 2021 meeting, the Corvallis School Board gave the Superintendent several directives relating to COVID-19 vaccinations. Following is the work done to-date as well as the next steps for the directives.

1. Conduct community engagement by gathering feedback and information on vaccine hesitancy among vulnerable populations with low vaccination rates.

Work To-Date

Benton County Health Department and Corvallis School District co-hosted a vaccine information event and resource fair at Linus Pauling Middle School on November 9, 2021, to reach out to families from Guatemala. Gabriel Ledger, MD, of Samaritan Health Services, was present to answer questions.

Next Steps

Staff will reach out to local faith-based communities to gather feedback and information on vaccine hesitancy among our vulnerable populations with low vaccination rates.

2. Engage with our vulnerable populations to create greater confidence in the vaccine and increase vaccination rates.

Work To-Date

A Vaccine Outreach Team, composed of District staff and community partners, meets every two weeks to review data and decide on outreach efforts. Lincoln and Garfield vaccine clinics were held on November 14 and 15 and resulted from this partnership. At each of the clinics, 100 pediatric and 25 booster shots were distributed based on the principles of health equity. Volunteers at these events were staff members from each school.

Next Steps

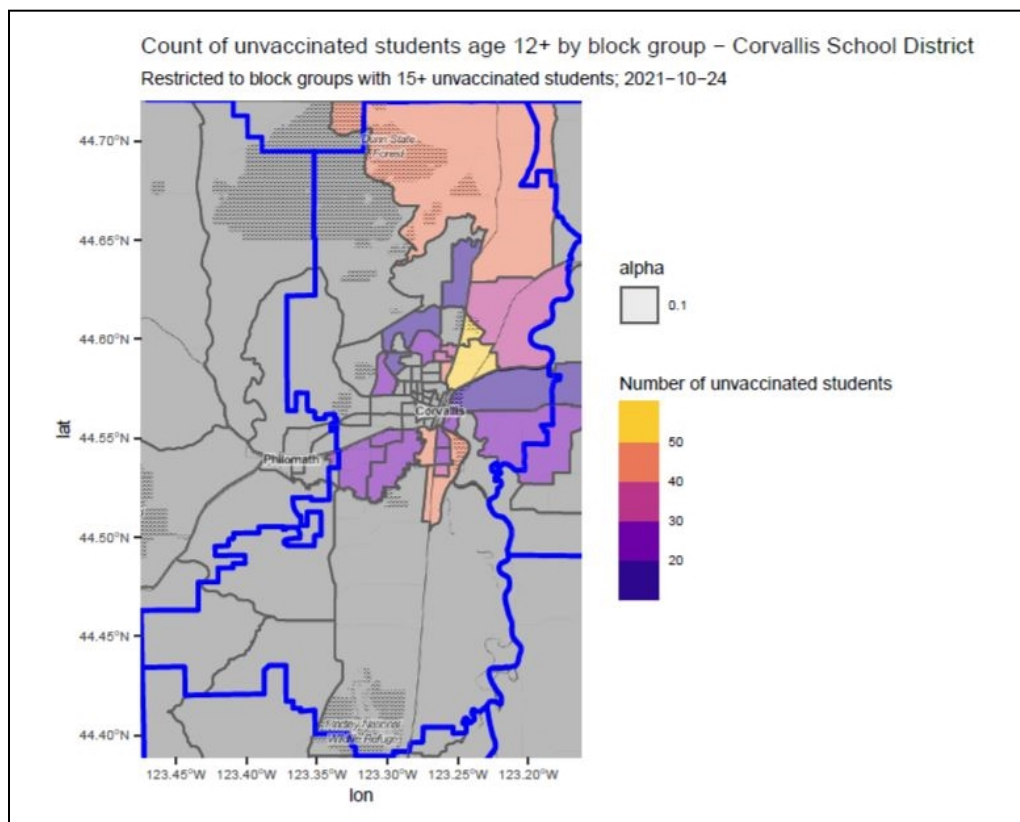
- Communicate with the broader CSD community to access pediatric vaccination through provider offices.
- Health Navigators and Family Liaisons will connect families with their providers when available.

3. Continue to provide updated data and information on COVID-19 vaccination rates among CSD students.

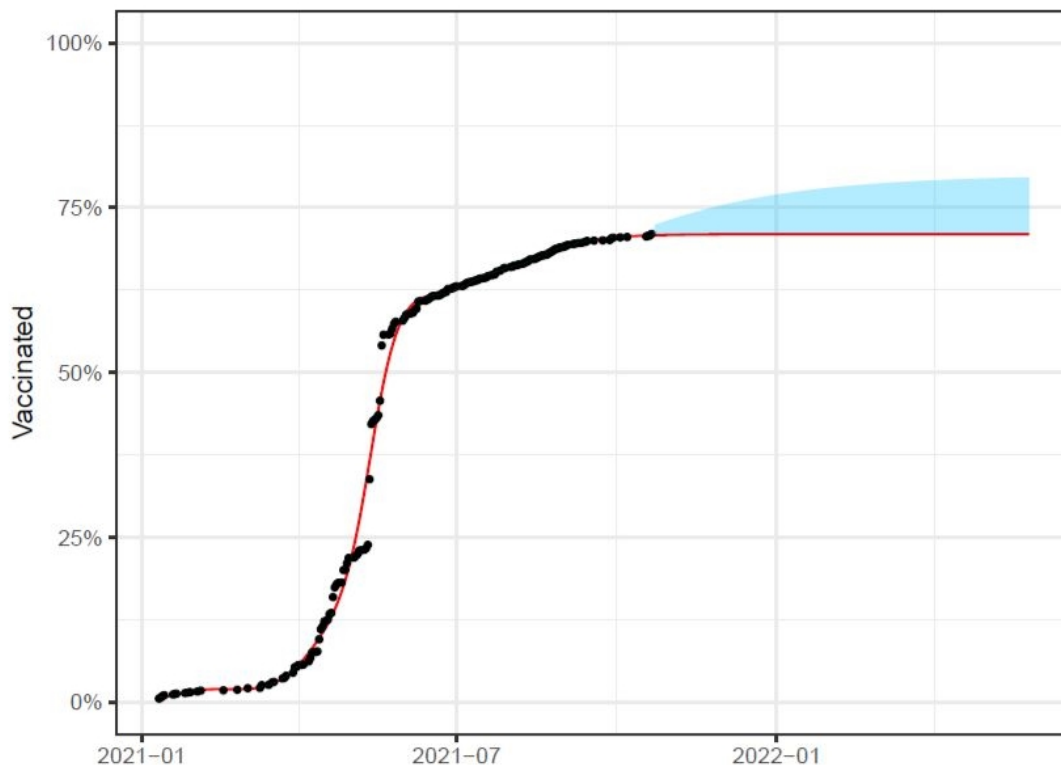
Work To-Date

The Benton County Epidemiologist provides District staff disaggregated and trend data approximately every two weeks to measure the impact of outreach efforts. Following are examples of the data the District has received.

The following map shows vaccination rates among Corvallis School District (CSD) students age 12 and older within the CSD boundary. The grayed-out block groups have fewer than 15 unvaccinated CSD students age 15 and older. The “alpha” parameter is an artifact of the mapping algorithm; it has no meaning related to vaccination. The purpose of this map is to provide the District with an up-to-date snapshot of high-priority areas in terms of outreach and access.



The graph below depicts the forecast of the total CSD vaccination rate for ages 12 and above based on high school pathways. This graph shows modeled forecasts of vaccination rates among CSD students. The forecasts are shown by the red line. The blue band is an estimated range of possible vaccination rates moving forward, and the black dots are the actual vaccination rates on each day.

September Financial Statements (Unaudited)

NO ACTION REQUIRED

Background

The Statement of Resources and Requirements for the General Fund for the period ending September 31, 2020 and September 31, 2021 follow this report.

Year-to-date operating revenues through the end of September 2021 total \$13.3 million or 16.1% of total budgeted operating revenues as compared to \$14.2 million or 17.6% through the end of September 2020. As usual, revenues from the state school fund constitute the majority of funds received at this point in the year.

The beginning fund balance reflects an increase of \$2.2 million over the adopted budget of \$12.7 million. Overall, total operating revenues in 2020-21 were 99.6% of budget while total operating expenditures were 90.5% of budget.

Year-to-date operating expenditures through the end of September 2021 total \$11.2 million or 13.0% of total budgeted operating expenditures as compared to \$12.3 million or 14.3% through the end of September 2020.

Projected resources and requirements through June 30, 2021 result in an ending fund balance of \$13.5 million, or 16.2% of projected operating revenues. The projected ending fund balance reflects an increase in fund balance, or operating surplus, of \$1.4 million. All General Fund reserves are projected to be at or above the designations outlined in board policy on June 30, 2021.

Please contact me with questions or if you would like any additional information. Due to staffing shortages and workload constraints, staff are not currently preparing quarterly statements on all other reportable funds in addition to the General Fund at this time. If continuing to receive quarterly statements on other funds is important to the board, please let me know and we will work to shift our priorities.
