Subject: Proposal by Dr. Marlon James for Working with the District to Address System Equity

Background:

During the September 12, 2012 meeting, the Board of Education voted to authorize the Superintendent to execute an agreement with Dr. Marlon James and Loyola University, which passed 6-3 with a motion by Ms. Darleen Klase and a second by Mr. Kenneth Williams. Following the meeting, I notified Dr. James that his proposal had been accepted by the Board of Education and he began making preparations with the University to finalize a contract with the Windsor Public Schools. To date, the contract has not been signed.

At the most recent Executive Committee meeting Mr. Panos requested that the item be placed on the agenda and subsequently he has indicated that he intends on making the following motion: *I move to rescind the motion regarding the authorization of the Superintendent to execute an agreement with Dr. Marlon James and Loyola University, which was passed during the September 12, 2012 meeting.*

Status: Recommendation:

Roberts Rules of Order allows for restorative motions which allow a group to collectively change its mind when it believes that a decision has been made too quickly or without enough information.

In this instance, it appears that the applicable motion would be a motion to rescind. However, Roberts's Rules indicates that such a motion is subject to the following:

SUBJECT: Fiscal Year '12 Year End Financial Report

BACKGROUND:

Each year at this time, the budget from the previous school year is officially closed and a report made to the Board on the end year status.

The Board of Education's budget for Fiscal Year 2012, which ended June 30th, was \$61,829,029. Our unexpended balance is \$151,947. (NOTE: results have not been audited.) The unexpended balance, .25%, represents ¹/₄ of 1%, of our budget. At its June 19, 2012 meeting the Board of Education approved the budget transfers necessary to cover any deficits in the budget line items for the fiscal year.

The unexpended funds are a result of under expenditures in salary and benefits. Offsetting these under expenditures is over expenditures in pupil transportation, Special Education tuition and technology. The savings in salary and benefits are attributable to favorable hiring and lower than predicted cost increases in health benefit plans for employees. The favorable trend in hiring was reflected in the FY 13 budget projections. The increase in transportation costs were a result of rising fuel prices, additional runs as a result of the elementary reorganization that took effect in the 2011/12 school year and increased requirements for Special Education transportation.

In the latter part of the fiscal year, May and June, funds were expended to upgrade technology and major maintenance items for our schools.

STATUS:

A letter will be sent to the Town of Windsor notifying them of the amount that will be returned.

RECOMMENDATION:

That the Board approves the return of \$151,947 to the Town. (Final amount subject to completion of audit).

SUBJECT: Budget Assumptions in Preparation for Developing the FY 2013 - 2014 Budget

BACKGROUND:

Each year a set of Budget Assumptions is adopted by the Board of Education. These assumptions include cost estimates for the next fiscal year's budget and priorities in the development of the budget. The Superintendent is presenting proposed budget assumptions for consideration by the Board.

RECOMMENDATION: That the Board of Education accept for a 1st Reading of the Budget Assumptions for 2013-2014.

Budget Assumptions 2013 - 2014

The charge of the Board of Education is to develop a fiscally responsible budget that meets the needs of the Windsor Public School students.

- 1. Enrollment in 2013-2014 is projected to remain flat.
- 2. Decisions around staffing and program redesign or development will be driven by their potential impact on raising student achievement while honoring the commitment to be fiscally responsible.
- 3. The Board of Education will make every attempt to honor class size guidelines.
- 4. Salaries of certified staff will increase based on results of current negotiations.
- 5. Health insurance costs are estimated to rise by approximately 9-10%. Windsor is in year one of self funding for health insurance. On going evaluation of claim data will narrow this number.
- 6. Special Education out-of-district tuition costs will again increase by 10%. The district is currently engaged in an independent study of out-of-district tuition costs and the expansion of in-house programs. The goal is to reduce the increase in costs.
- 7. Utility costs (heat & electricity) will remain flat.
- 8. Transportation costs are estimated to rise by 4%.
- 9. Magnet school per-student tuitions will increase by 10%. The cost is dependent on number of students enrolled and tuition cost per student.
- 10. The budget will include a contingent expenditure in amount of \$75,000 for anticipated reduction in Federal Grants IDEA and Title 1.
- 11. We will continue our commitment to finding efficiencies within the budget.



These profiles provide baseline data for Connecticut's new accountability system. BACKGROUND: The Windsor School Food Service participates in the National School Lunch Program at each of our school facilities and at St. Gabriel's, Trinity Christian School, CREC's Metropolitan Learning Center and Medical Professions and Teacher Preparation Academy. We also participate in the National School Breakfast Program at our four elementary schools, Sage Park Middle School, Windsor High School, and the two CREC schools, Metropolitan Learning Center and Medical Professions and Teacher Preparation Academy. We operated our second year of the Seamless Summer Feeding program serving both breakfast and snacks at Metropolitan Learning Center in July 2012 and added the same service to Medical Professions Teacher Preparation Academy. Windsor School Food Service is complying with the Healthy Food Certification again this year to send a consistent message to our students in keeping with our wellness policies.

Our annual goal is to operate with a small reserve account to offset unanticipated needs and to increase participation from students and staff in both the breakfast and lunch programs.

A monthly financial report is presented to the Board of Education. This report includes sales and financial information for the current period.

1. Call to Order, Pledge of Allegiance, Moment of Silence

Discussion:

The meeting was called to order at 6:30 p.m. by Chairperson, Cristina Santos. Ms. Santos welcomed Mary Anne Butler, the new Assistant Superintendent for Instructional Services, to the district and to the Curriculum Sub-Committee.

2. New Curriculum Framework

Discussion:

Mary Anne Butler began by discussing the Curriculum Team in place this year consisting of Katrina Palazzolo, Chris Rau, Deb Maccarone, Christine Tedisky, Tom Baird, and Tracie Peterson.

Atlas Rubicon, an electronic component used for curriculum work, had originally been set up for 200 seats predominantly at the secondary level. The number of seats has been decreased and access will be redistributed to reassess continued use of Rubicon. If we decide to go with Atlas at the end of the year, all teachers will need access. Implementation of a new electronic piece, Silverback, will be used for curriculum and shared more evenly with secondary and elementary.

3. Measures of Academic Progress

Discussion:

Testing of grades K-8 on academic performance, are now much more abbreviated and tests have been consumed into MAP, Measures of Academic Progress. MAP testing is a computer-adapted test and reports are accessible that will provide immediate results and feedback. The requirements are a bit heavy, particularly for kindergarten, but this is a learning phase and it will be adjusted as we move forward. We will be moving to a larger testing window with a new system that will take the place of CMT/CAPT tests. Training on report interpretation will occur in the district on October 11 and 12. We need to make sure that the importance of the reading and writing components crosses into other subject areas such as social studies.

4. New Assessment Calendar

Discussion:

Mary Anne Butler distributed a copy of the district assessment calendar for the elementary and middle grades and stated this information is also available on the district website.

5. Program of Studies

Discussion:

Mary Anne Butler will begin visiting schools and will start with the high school this week in order to gain some insight. Many new initiatives will begin at the high school so definite changes can be in place by 2018. One change will be to require 25 credits to graduate, which will have financial implications to the district, but it needs to move forward. The second item concerns many parts of algebra in tiers that has seniors who still have not passed the class. The plan is to have Algebra I in grade 9 and have students in the class every day, which will double the current time in class because students need the help. The assignment of credits will need to be looked at to determine how to categorize them suitable for college admission requirements. Some elective courses at the high school, such as Meteorology do not give credit to science, but they should because of the curriculum and to fit with the new guidelines. English 12 is a onesemester course which should be changed to a full-year course, instead of a follow-up communication course.

The credit recovery policy needs to have different options added such as Virtual High School and summer school options. Virtual Learning Academy does not have a "live" teacher on the other end so it requires a staff member to assist with lessons. Virtual High School can be very structured, but it also offers quite a selection of courses. Teachers have been asked to think about electives they would like to see offered. A questionnaire would be put on the high school website and students could respond to the possible offerings. These courses would be put in the Program of Studies with the caveat that final curriculum would be written and approved by the Board of Education. The curriculum must get to the Board Sub-Committee by November, and a second reading could be waived to get to the Board for final approval by December to get a course approved in time for the next school year.
