The Board supports the Superintendent's emphasis on student achievement. From spring of 2020 to the end of 2021, we were in pandemic mode. Last year, the district focused on learning loss and SEL. (Supt. letter dated 8/22/22 attached)

The Board of Education is always looking to expand opportunities for vocational education. This past spring, district administration worked with Berlin Public Schools' administration and teachers and outside educators in the firefighting field to create a new curriculum offered to our high school students.

Our Long Range Planning Committee first discussed the possibility of the firefighter course and the information was fast tracked to the curriculum committee. The curriculum committee received a presentation from the Instructional Services department on the new firefighting course at their May 12, 2022 meeting. ## **LEVEL 2 ITEM 1C. BOARD LEADERSHIP/STUDENT ACHIEVEMENT**

The Board of Education supports the appropriate use of technology in educational programming.

Through its budget process, the Board receives detailed information from the Director of Information and Technology. The Board of Education supports the use of technology in the district through programs listed on the attached documents. In addition, the Board supports technology through steady financial increases to support 21<sup>st</sup> century instructional practices using technological tools including 1:1 Chromebooks, iPads, assistive technologies, and specialty software technologies used in CTE, unified arts, and in the general education environment.

# Technology

Technology tools are integrated within all of the day-to-day operations of the school district. They are an essential component of the educational curriculum that provides opportunities for students to develop critical thinking, communication, collaboration, and creativity skills while simultaneously strengthening attributes such as persistence and leadership. The department provides critical infrastructure, from broadband, devices, and policy recommendations, to digital content and instructional support for both staff and students to further teaching, learning, assessment, accountability, leadership, and culture with a focus on equity.

## **The goals for the 2021-22 school year are to:**

- Continue to develop a district 3-year Technology Plan to ensure the infrastructure is available to support the district's goals for students.
- Continue to leverage EduClimber platform to efficiently analyze data and support District systems, i.e., Professional Learning Communities (PLCs) and the Multi-Tiered System of Support (MTSS), especially at the secondary level.
- Continue to examine core technology and contracted services to seek efficiencies, streamline services, align technology to district priorities, and enhance network and data security.

## **Towards our goals, to date we have accomplished the following:**

- Reviewing security recommendations resulting from new federal K-12 Cybersecurity Act of 2021 to mitigate cybersecurity challenges facing K-12 districts.
- Pivoted from populating eduClimber to PowerSchool's Performance Matters analytics platform.
- Continued to align core technology and contracted services to district priorities as well as seek efficiencies, streamline services, and enhance network and data security.

## **Major 2022-2023 school year work:**

- Implement recommendations resulting from new federal K-12 Cybersecurity Act of 2021 to better protect student and staff data.
- Support professional development and additional student data sources in the Performance Matters platform to provide for our educators more timely and comprehensive assessment data about the progress of our students.
- Continue to align core technology and contracted services to district priorities as well as seek efficiencies, streamline services, and enhance network and data security.

The Board uses data to make informed decisions regarding student achievement (provide examples).

The Board received a presentation (attached) on SEL on Tuesday, April 5, 2022. It is the district's vision to increase student achievement through improved collaborative partnerships and to further develop capacity (skill and understanding) of families, the schools, and its partners.

Prior to the start of COVID, the BOE received an annual presentation on School Development Plans and the State Accountability Report. The reports are shared with the BOE at a special meeting where time is devoted to review each line item of the State Accountability Report. Discussion ensues and questions are answered by district leadership. The State was late in providing data again this year. The BOE will receive a presentation on academic and performance data on Tuesday, October 4, 2022 (agenda attached).

The BOE will also receive a presentation on special education on Tuesday, December 6.

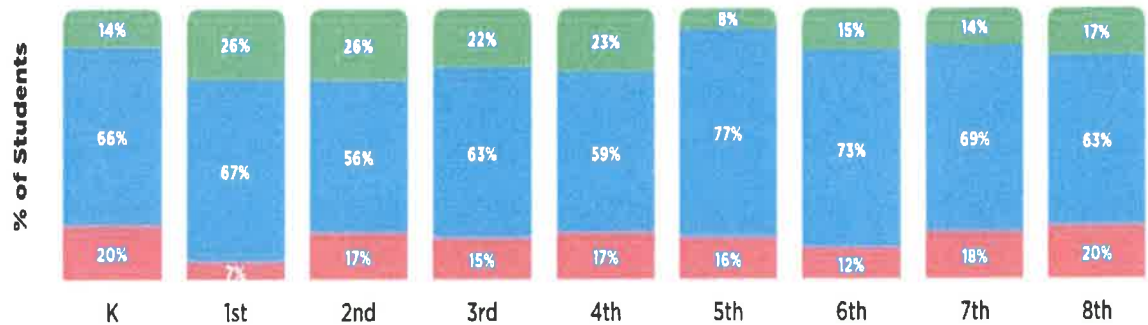

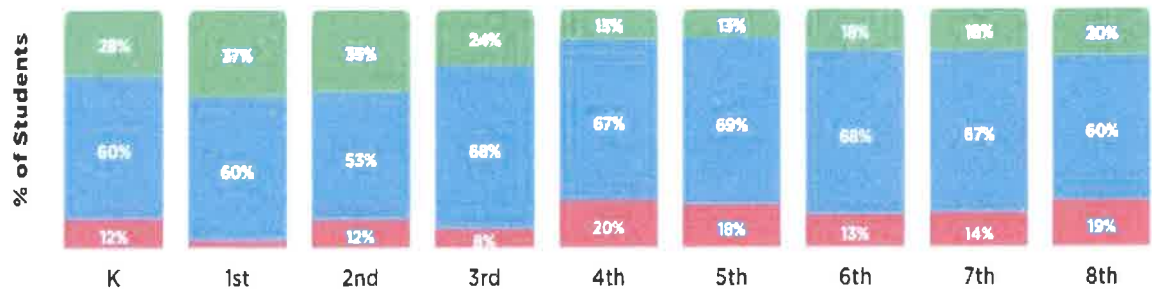

- C. Travel expenses for Board of Education members only; and
- D. Board of Education members shall not be reimbursed for expenses of a spouse or companion.

Each member of the Board may attend school Board conventions or seminars within the State without the prior approval of the Board, provided that the remuneration or reimbursement for expenses shall be limited to registration fees and housing accommodations if appropriate as provided for by the Board in its annual budget.

**c. Discussion on Policies**

Discussion to determine if the Board should request that wording for a new policy, or addition to an existing policy, be drawn up by the Policy Committee and/or the superintendent, which policy would prohibit the use of cellphones by students in school, which suggested policy is to be brought to the Board in future meetings this school year for first and second readings and votes of adoption. Possible Board action in the form of a motion to send the request to the Policy committee.(Tabled from 12/21/21 Regular Meeting and reworded)

Mr. Panos questioned the lack of a distinct policy limiting or denying the use of cell phones by students unless under the direct supervision of teachers. He said that abuses have occurred for years and there needs to be a policy in place.

Several board members and the student representative gave their perspective regarding cell phone use, specifically at the high school and Interim Principal Breon Parker spoke regarding the penalties in place, such as "bag and tag", the process by which a student is relieved of their phone to be claimed at the end of the day by either a parent or the student. Dr. Hill stated that he had not heard from the administration, parents, or teachers that this was an issue affecting the school.

Mr. Panos stated that it cannot both be "not a problem" and yet have discipline for disruptions. He said that he has spoken to teachers regarding their concerns on this topic.

Mr. Furie said he would not recommend this go to the Policy Committee.

Move that the Board ask the Policy Committee for wording for a policy that states that a personal devices, like cell phones, during the day, by students, will be prohibited according to the discretion and under the supervision of a teacher or staff member for the students assignments. 11. Superintendent's Report

Dr. Hill said that the most recent Coffee Talk was well attended and the next one will be held on February 28 at 6:00 PM at the LP Wilson Senior Center. He expressed thanks to the United Way of Central and Northeastern Connecticut and to Annie Sommers Fazzino, their Community Engagement and Marketing Manager, for their donation of winter items and supplies to be given to families in need. There were additional vaccine clinics held with two more scheduled for ages 5-11 on January 22 and February 12. No registration is required. In light of recent drug-related events in other area districts, there will be informational sessions for families and students to learn about current drug culture. On January 22, Sage Park Middle School will host their 2nd Vex-IQ Robotics Qualifying competition.

Mr. Panos mentioned a staff protest last week regarding the lack of masks and tests provided for them.

Both Dr. Hill and Ms. Batchelder spoke regarding this situation, which was not a protest but more to draw attention to the inequities in the distribution of supplies. **LEVEL 2 ITEM 3D. POLICY**

The Board has adopted a policy on civility. Board policy 9271 Code of Ethics addresses civility (attached).

## **Bylaws of the Board**

### **Code of Ethics**

As a guide to performing their duties, Board members should:

1. Be an advocate of high quality free public education for all Connecticut children;
2. As an agent of the state, uphold and enforce all laws, rules, regulations and court orders pertaining to public schools, and bring about any needed change only through legal and ethical means;
3. Help create public schools which meet the individual educational needs of all children regardless of their ability, race, color, national origin, ancestry, sex, sexual orientation, physical or mental disability, religion or social standing;
4. Work to help the community to understand the importance of proper support for public education;
5. Become informed about the nature, value and direction of contemporary education and support needed change in the schools;
6. Recognize that a Board member's responsibility is not to "run the schools," but to see that they are well-run through effective policies;
7. Exercise care in any discussions concerning the employment, performance, promotion, evaluation, health or dismissal of a Windsor Public School employee or applicant for employment because (1) they do not supervise such employees and (2) they may be required to make impartial judgments concerning such employees. Board members should refrain from such discussions unless acting as a personal reference during the normal course of the hiring process.
8. Recognize that they are prohibited from discussing confidential information they receive as Board members concerning academic or disciplinary matters related to Windsor Public school students except as permitted by law.
9. Confine Board action to policy-making, planning, and appraisal, and consult with those who will be affected by the Board's actions;
10. Arrive at conclusions after fully discussing the issue at an open meeting, and abide by the principle of majority rule;
11. Recognize that authority rests only with the whole Board assembled in a meeting, and make no personal promises nor take any private action that may compromise the Board;
12. Acknowledge that the Board represents the entire school community, and will refuse to surrender their independent judgment to special interests or partisan political groups;
13. Never use the position on the Board for personal gain;
14. Hold confidential all matters pertaining to the schools that, if disclosed, might needlessly injure

individuals or the schools;

15. Ensure that all school business transactions be open and ethical;

16. Ensure that the best personnel available are appointed to all positions in the district;

17. Refer all complaints through the proper "chain of command" within the system, and act on such complaints at public meetings only when administrative solutions fail;

18. Treat all fellow Board of Education members, school district employees and community members with mutual respect, trust, civility and regard for each other's respective roles and responsibilities; and

19. Practice and promote ethical behavior in the Boardroom as a model for all members of the school district.

## **Board of Education Report to Town Council**

**Tuesday, September 6, 2022**

- This year's Convocation was held on Tuesday, August 23 at Windsor High School. Convocation is always an exciting time for staff to be together after the summer break. Thank you to Mayor Don Trinks and Town Manager Peter Souza for their words of encouragement to district staff. After Convocation, staff returned to their buildings for professional development.
- On Thursday, August 25, the very first District-Wide OFCP (Office of Family and Community Partnership) Block Park was held on Sage Park Road between Sage Park Middle School and Windsor High School. Congratulations to OFCP Coordinator Christina Morales and Administrative Assistant Kate Ferris-Morell for planning such a successful event. Families were able to register in advance to receive a backpack and school supplies for their child. The district received many very generous donations from our community partners and a team of volunteers stuffed the backpack with many types of back-to-school school supplies. Each school was represented and mostly all staff member participated. Families were treated to food trucks, ice cream, bounce houses and activities sponsored by community partners, Northwest Park, Windsor Fire Department, Windsor Police Department, and the United Way among others. Thank you to our families and community members who came out to support our district and Dr. Hill's vision and goal to activate a collaborative district culture that enhances the experience of students and educators alike.
- Windsor Public Schools opened its doors for the 2022-2023 school year on Monday, August 29, 2022. There was much excitement for the students and staff as they returned to the school buildings and there were very few transportation issues. Central office administration toured the schools and found staff and students were very engaged in activities throughout the day.
- The State of Connecticut has allocated grant monies to assist with the transition from "Free for All" to "Full Pay" for school breakfasts and lunches. This grant money will allow Windsor Public Schools to provide free breakfasts/lunches for all students from August 29, 2022 through October 31, 2022. Effective November 1, 2022, the food service program will return to paid breakfasts and lunches unless a family qualifies for free or reduced priced breakfasts. Those families who qualify should complete a free and reduced-price meal application. The application and instructions for completing the form are located on the district website under WPS Food Services.
- The WHS track is now complete and the new scoreboard has been installed. The front of the Sage Park Middle School entrance has been renewed including new grass.
- Dr. Hill will continue his Coffee Talk series in September. Please watch the district website for more information.

## **LEVEL 2 ITEM 4C. COMMUNITY RELATIONS**

The Board of Education and district often work with Windsor Community Television: WIN-TV.

WIN-TV provides videotaping services for Board of Education meetings in our newly renovated Board Room and livestreams our meetings out into the community. They also are available to tape other district events. This year, WIN-TV taped our August New Teacher Orientation, a three-day event. They were able to take the taped video, and edit and produce training guides for our human resources department for future use with new employees.

From WIN-TV's website:

Windsor Community Television (WIN-TV) is a private, non-profit, corporation and was incorporated by the State of Connecticut in January of 1982. WIN-TV is a public, education, and government (PEG) cable community access provider. The Hartford area franchise holder in 1981 was Times Mirror Communication Inc. and was required, by a franchise agreement with the Connecticut Department of Public Utilities Control (DPUC), to establish Community Access Television in each of the six Hartford Franchise towns once proper wiring passed a sufficient number of homes in each town.

Once the station was incorporated, Times Mirror supported WIN-TV through direct dollar grants, employed the Station Manager, and shared equipment. With this strong support from the Franchise, WIN-TV was ready to begin programming from its first home, the basement of Windsor Public Library. Programming was created by community volunteers and we were on the air two hours each weekday evening when volunteers could come to the station and run the tapes.

The station has grown since then to a 24 hour community station. With the ability to watch programming on demand as well as a mobile app coming soon.

Dear Jane and Maryam

Jane thanks for meeting with me and Leonard yesterday morning and Maryam thanks for meeting with us last night.

Doug and Bobby, sorry we have not able to have a chance to meet with you yet this legislative session on the many education issues facing us and we know this is a short session. Doug we appreciate your leadership as Co-Chair of the Education Committee and Bobby your leadership as well on the committee and your successful effort requiring that all schools offer a Black and Latino studies course.

Many of the issues faced are the same for schools in Hartford, Bloomfield and Windsor.

Here are the most significant issues we talked about yesterday:

1. Special education funding. As you know the federal government created certain special education mandates, but has not provided needed funding. So, the responsibility has fallen to the state and local districts. The state formula requires local boards to fund an amount equal to 4.5 times the cost of regular education funding and the state is then to fund the balance. However, the state has capped the excess cost which again requires local districts to fund the balance. So, both the state and federal government are not providing their fair share. This problem has made budgeting at a local level a nightmare. HB 5283 and SB 232 both try to address the Excess Grant Funding Cap. Although our preference, speaking only for Leonard and myself, would be to have the state fully fund its statutory responsibility we agree that reducing the 4.5 threshold has some merits. We know that the solution will have to be done over time. However, this should start now.

2. Minority teacher recruitment. Bloomfield, Hartford, and Windsor are all districts where the majority of students are students of color, yet the staff is predominately white. I was the Windsor representative on the CREC Council the last few years and Leonard is currently, so we know CREC has had a program that tries to address this issue, and other RESCs and a few school districts are following, in which minority staff is trained while being paid on the job. Although this has merit, we know this is just one way to address this issue. I know the State Department of Education has looked at broadening reciprocity with other states. We hope the you could look at other methods of increasing the minority teacher pool and can appreciate SB 273 that would look at teacher certification requirements.

3. Social Emotional Learning (SEL) and mental health. We applaud the initiatives regarding SEL and mental health of our students and staff. Jane and Bobby, thanks for being co-sponsors of HB 5001 that recognizes the need to address the mental health of children. We invite you to learn more about Windsor's SEL program on Tuesday, April 5th at 6:30 - in person at the Windsor Board of Education Office or via zoom.

We look forward to further discussions on education issues even after the legislative session. We hope that we can meet with you in future years in person at the capitol. Leonard and I always look forward to the CABA on the Hill event.

As we discussed the special education excess cost grant cap is a significant problem for Windsor and other towns. As you know the federal government created certain special education mandates, but has not provided needed funding. So, the responsibility has fallen to the state and local districts. The state formula requires local boards to fund an amount equal to 4.5 times the cost of regular education funding and the state is then to fund the balance. However, the state has capped the excess cost which again requires local districts to fund the balance. So, both the state and federal government are not providing their fair share. This problem has made budgeting at a local level a nightmare. We understand this problem won't be fixed overnight, but some phase in should start now.

Another issue we discussed was the large number of state mandates. A couple examples are the number of required professional development courses, the required courses that all students must take in high school and the requirements for teacher certification.

A special area of concern coming out of the pandemic has been the social emotional health of our students. I know Windsor has spent and will continue to spend federal funds in this area. Thank you and your colleagues for recognizing the importance of the mental health of our children.
