## **Coaching Requirements**

- LCSD Hiring Process must be completed by HR for all new hires or community coaches who have had a gap in coaching employment
- Pass LCSD Background check.
- Current CPR/First Aid Card (May be Red Cross Online for renewal)
- Safe Schools (either employee level or volunteer level)
- Passed all National Federation of State High School Association (NFHS)
   Courses

## **OSAA/Oregon Requirements**

**Required Certifications and Training Courses for Oregon High School Coaches**

- Interscholastic Coaching Course (One time)
- Concussion Recognition and Management (Annually)
- Heat Illness Prevention (Every 4 yrs. except football is annual)
- Anabolic Steroids & Performance-Enhancing Substances (Every 4 yrs.)
- Interrupting and Preventing Discriminatory Acts Training (One time)
- Racial Equity Training (Optional)
- Spirit Safety Training (Annual for cheerleading and dance coaches)
- OSAA Football Certification (Annual for football coaches)
- Sudden Cardiac Arrest (Annual for football coaches)
- NFHS Football Tackling (Annual for football coaches)
- First Aid (Provided by LCSD) every 2 years.
- CPR/AED (Provided by LCSD) every 2 years.

## **Sports Related Concussions**

- All coaches must pass the annual CDC Heads Up concussion certification training.
  - Annual Concussion Training
- For each suspected clavicle and above contact an LCSD Concussion Signs and Symptoms Checklist Process must be completed and attached to the Student Accident Report and kept on file.
  - Concussion Signs and Symptoms Checklist
- Wear the PACE Lanyard at all Games.
- District level concussion team meets 3 times per year
  - Reviews data, discusses arising issues, makes recommendations

## **Safety**

- At every practice and contest a coach is expected to have a fully stocked medical kit readily available.
- A coach is expected to perform a safety inspection of the playing field, facility and equipment before and after each use.

## **Student Accident Report**

If a student-athlete is injured to the point of requiring medical care beyond the scope of the coaching staff (an insurance claim could be filed), the Athletic Director must be notified within 24 hours. A Student Accident Report (Form PP-12) is to be submitted to the Health Assistant, Athletic Director, Building Administration and the LCSD Business Office. This should be completed no later than the next school day. In the case of a student athlete requiring hospital admittance, the superintendent must be notified.

#### **Student Accident Report**

#### **Medical Clearance**

When a student-athlete is referred to a medical professional for an injury that requires medical attention, the injured athlete will not be allowed to participate in that sport or any other sport until a written release from the student's medical provider is submitted to the Athletic Director, Building Administrator, and Health Assistant. Questions in regards to clearance should be directed to the parent, not the athlete.

## **Type 20 Certification**

Any coach wishing to transport students using the Type 20 bus must be certified by passing The Class 20 Driving Class conducted by First Student. When driving on school trips please drive slowly; stay within the speed limit or slower as road conditions warrant. Clean the vehicle after each trip.

#### Lincoln County School District Equity Team Land Acknowledgement Statement

We ask that you take a moment to stop what you are doing, to listen to these words as we recognize the land that we currently inhabit. No matter where each of us is physically located in Lincoln County, we must understand that we are on traditional homelands and unceded territories of indigenous peoples. Where we live in Lincoln County, these are the ancestral homelands for the Confederated Tribes of Siletz Indians.

Lincoln County School District acknowledges the Confederated Tribes of Siletz Indians that consists of over 30 bands originating from Northern California to Southern Washington. The Confederated Tribes of Siletz Indians currently occupy and manage 9,310 acres located here in Lincoln County but is a mere fraction of their original 1855 1.1 million-acre Siletz coastal reservation. We must remember the people of the Confederated Tribes of Siletz Indians are and will forever be the first stewards of this land, water, and fish.

We acknowledge and recognize the continued sovereignty of the Confederated Tribes of Siletz Indians and honor their ancestral homelands. We are committed to bringing awareness to their history and the existence of the Confederated Tribes of Siletz Indians since time immemorial.
