VHS Student Erik Vincent Selected for the 2026 United States Senate Youth Program

VALDEZ, ALASKA - Valdez High School senior Erik Vincent has been selected as one of two students representing the State of Alaska in the United States Senate Youth Program (USSYP).

The U.S. Senate Youth Program is an extremely competitive, merit-based program that brings together 104 top student leaders—two from each state, the District of Columbia, and the Department of Defense Education Activity—for an intensive, week-long study of the federal government. During Washington Week, delegates attend meetings and briefings with Senate leadership, U.S. Senators and Congressional staff, senior cabinet officials, national media leaders, a Justice of the Supreme Court, an Ambassador to the United States, and the President. Each delegate is also awarded a \$10,000 undergraduate college scholarship.

Created by Senate Resolution 324 in 1962, the program is sponsored by the U.S. Senate and fully funded by The Hearst Foundations. Its mission is to deepen students' understanding of the American political process and inspire a lifelong commitment to public service.

For Erik, the opportunity is closely tied to his upbringing and the values he associates with growing up in Valdez. "Valdez is built around the idea of community, as it stands for people being part of social structures larger than themselves and working to help and care for one another. Ideal governance should be built around these same tenets of community, and I believe that my background with such values has been seminal preparation for this opportunity."

His interest in government has grown through a passion for history and a developing focus on civic responsibility and public service. Erik recalls, "I've always taken a fascination in history, and government and politics initially developed in my mind as an offshoot of the former. As I learned more of our political processes, however, as well as policy issues and public service, I took up government as more of a distinct pursuit, one that I devote in my mind to making society better and people more prosperous."

Erik is the first student from Valdez ever to be selected for the U.S. Senate Youth Program, a distinction he views as both an honor and a responsibility. "No one else from Valdez has ever before been selected for this program, and it is important to me that I stand in our nation's capital as a representative for our school district, our city, and for all students of rural Alaskan communities."

Valdez City Schools congratulates Erik Vincent on this exceptional achievement and looks forward to following his experience as he represents our community at the national level.

Alaska Students Selected for United States Senate Youth Program ***Students Headed to Washington, D. C. and to Receive \$10,000 College Scholarship***

January 12, 2026, Washington, D.C. —The United States Senate Youth Program (USSYP) is pleased to announce that high school students Mr. Erik Norman Vincent and Mr. Andy Zhang will join Senator Lisa Murkowski and Senator Daniel Sullivan in representing Alaska during the 64th annual USSYP Washington Week, to be held March 7 — 14, 2026.

Erik Vincent of Valdez and Andy Zhang of Anchorage were selected from among the state's top student leaders. They will join the delegation of 104 outstanding high school students - two from each state, the District of Columbia and the Department of Defense Education Activity - for an intensive week-long study of the federal government and the people who lead it, meeting with Senators, the President, a Supreme Court Justice, and other high-level officials. Each delegate will also receive a \$10,000 undergraduate college scholarship with encouragement to continue coursework in government, history and public affairs.

About the 2026 USSYP Delegates:

Erik Vincent, a senior at Valdez High School, serves as President of the Student Body and has been a member of the Valdez High School Student Council since 2023. He was elected as the Regional Representative for the Alaska Association of Student Government, serves on the Valdez Youth Court and is able to make a difference in the juvenile justice system in granting restorative sentencing to those convicted of misdemeanors. He volunteers his time through the school music program, community fundraisers, and the National Honor Society. After college, Erik plans to attend law school, serve as an attorney for the state of Alaska or for a municipal government, and to eventually serve in elected public office.

Andy Zhang, a senior at Dimond High School, serves as the President of the National Honor Society. A lifelong Alaskan, he understands the vital connection between salmon, culture and community. Each summer, he participates in subsistence salmon fishing, helping share the catch with neighbors and local families. As Concertmaster of the Alaska All-State Orchestra and a violinist with Carnegie Hall's National Youth Orchestra 2, he has found a home in the ensembles he loves, and coaches beginners in his school's symphony orchestra, helping them gain confidence and find their rhythm. He is the Captain of the varsity swim team, a volunteer swim coach, Founder of a small swim-instruction business and finds his greatest reward watching children transform fear into pure joy when they float on their own for the first time. Additionally, he tutors students worldwide through Schoolhouse SAT. Andy's bond with Alaska's environment drives his research with the U.S. Geological Survey on "rusting rivers," caused by thawing permafrost. He has presented his study to both local and national scientific communities. He hopes to study environmental science in college.

Chosen as alternates to the 2026 program were Mr. Francis Myers, a resident of Sitka, who attends Sitka High School and Ms. Madison Sophia Arreola, a resident of Eagle River, who attends Eagle River High School.

Delegates and alternates are selected by the state departments of education, including the District of Columbia and the Department of Defense Education Activities, after nomination by teachers and principals. The chief state school officer for each jurisdiction confirms the final selection. This year's Alaska delegates and alternates were designated by Deena Bishop, Commissioner of Education and Early Development.

About The United States Senate Youth Program

The 2026 United States Senate Youth Program Co-Chairs are Senator Katie Britt of Alabama and Senator Edward J. Markey of Massachusetts. The full USSYP Senate Advisory Committee consists of the Vice President of the United States and the Senate Majority and Minority leaders who annually serve as the program's Honorary Co-Chairs; two senators, one from each party, serving as acting Co-Chairs who each have keynote speaking roles, and an eight-member bipartisan senate panel, four senators from each party, who lend their names in support. Serving on the Advisory Committee for the upcoming program are: Senator John Barrasso, M.D. of Wyoming, Senator Steve Daines of Montana, Senator Cindy Hyde-Smith of Mississippi, Senator Tim Scott of South Carolina, Senator Catherine Cortez Masto of Nevada, Senator Andy Kim of New Jersey, Senator Angus S. King, Jr. of Maine, and Senator Elissa Slotkin of Michigan.

The USSYP is a competitive, merit-based program created by Senate Resolution 324 in 1962 by the sons of William Randolph Hearst and the Senate leadership of the day - Senators Kuchel, Mansfield, Dirksen, and Humphrey. The USSYP is designed to encourage America's most talented young people to consider public service as an important, life-long, and noble pursuit. Senate Resolution 324 passed unanimously.

The Hearst Foundations have fully funded the program since inception, as stipulated in SR 324, no government funds are utilized.

USSYP alumni now number more than 6,300 and many go on to build legacies of public service. The distinguished alumni include Senator Susan Collins, the first USSYP delegate to be elected U.S. Senator; former Secretary of Transportation Pete Buttigieg, the first to be appointed as a Cabinet Secretary; Representative Sarah McBride, the second to be elected to the U.S. House of Representatives; former Senator Cory Gardner, the second alumnus to be elected U.S. Senator and the first to be elected to the U.S. House of Representatives, and former New Jersey Governor Chris Christie, the first to be elected Governor.

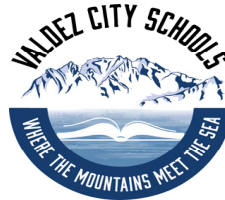

The items below are scheduled replacements for the student 1:1 device program. 9th grade laptops are purchased each year, and retired at four years of life (to be gifted upon the student's graduation). 3rd-5th grade ipads are on a 6-year lifecycle for replacement, and are scheduled for replacement in FY26. Please see attached enclosure to review the full replacement cycle projection.

Four years of AppleCare is added to each device, as the outright cash cost of repairs usually exceeds the cost of AppleCare over the course of a device's lifespan with VCS. This AppleCare plan will cover repairs for device hardware, device software, and iPad Magic Keyboard accessories for up to two incidents of accidental damage per year with no service fee.

Funds are budgeted for FY26 via targeted appropriation from the city and are currently available in technology-designated reserves; no additional funding is being requested. A budget amendment to move the funds into a spendable account will follow pending the board's approval of the purchase.

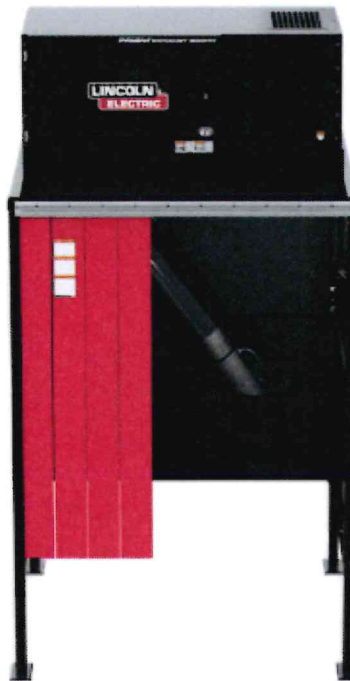

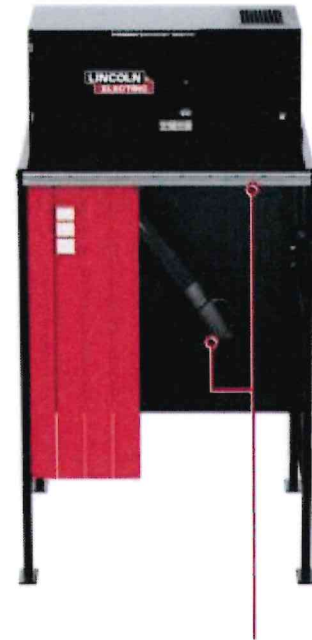

BP 3541.1 School-Related Trips

Trips By School Vehicles

Note: Federal safety regulations enacted in 2000 govern the number of students that may be transported in vans. These regulations are applicable to the purchase or lease of new vans by Alaska school districts. After 1 September 2000, new vehicles designed by the manufacturer to carry 11 or more persons (rated capacity if equipped with full seating) that are used for transporting students to or from school or school-related activities are required to meet all Federal Motor Vehicle Safety Standards for school buses. As a result, passenger vans are limited to transporting a total of ten passengers, including the driver, unless the passenger van or suburban meets the Federal Motor Vehicle Safety Standards applicable to school buses. The large majority of passenger vans do not meet and comply with Federal school bus safety standards. Although used vans are not covered under the federal regulations, for risk management purposes, districts may want to require the new van standards for the purchase of used vans. Besides taking students to and from school, the Board may approve transportation for field trips and school-sponsored activities. The Superintendent or designee shall regulate the use of the district transportation for approved school-related activities. Parent-teacher associations and any other organizations requesting transportation shall be fully responsible for the costs of the trip. To the extent that funding has been approved by the Board, such costs may be charged to the district.

Transportation by Private Automobile

Private automobiles shall not be used to transport students on any school-related trips.

Student Activity Travel

General Guidelines:

Student travel will first and foremost be based upon safety concerns for students. The superintendent or his/her designee has the authority to cancel or postpone departure to or return from any activity if in his/her judgment travel is unsafe for any reason.

The principal or designee shall establish routes, schedules, safety and conduct procedures, ensure adequate adult supervision, and ensure that means and methods of transportation are sufficiently covered by liability insurance. The maximum number of occupants in any non-school bus vehicle shall not exceed the number of functional seatbelts in that vehicle. Use of seatbelts is mandatory for all occupants.

Students may be transported to field trips and co-curricular activities upon authority of the building principal and the written permission of the parent or guardian.

Commercial carriers and district vehicles operated by school employees will be used whenever possible. Others who wish to drive for school trips must submit a copy of their driving record from the local Department of Motor Vehicle office to the Superintendent's Office for approval.

When ground transportation is used, the coach/sponsor must ensure a reliable communication device accompanies each traveling student group.

- . Drivers must possess a valid driver's license. A driver may not haul passengers unless he or she has possessed a valid driver's license for a period of no less than 8 years. For this section, "license" does not include a learner's permit.
- . Individuals with more than one driving/moving violation in the past 12 months; more than two (2) violations in the past three (3) years; or an alcohol or drug-related driving conviction at any time will not be eligible to drive district owned vehicles. District-approved drivers must notify the superintendent's office of any subsequent moving citation or conviction, or any suspension, revocation, or cancellation of the driver's license.
- . If the alcohol or drug-related driving conviction is more than five (5) years old, the Superintendent may, in his/her discretion, authorize the individual to drive after considering all relevant facts, including the current driving record.
- . Drivers must submit a current driving record every three (3) years.
- . At no time may a driver possess or be under the influence of any level of alcohol or drugs. A driver may not be under the influence of medication that may impair his/her ability to safely operate a vehicle. The driver may not smoke, use tobacco products, or permit smoking or the use of tobacco products in district-owned vehicles.
- . Drivers must report any damage or incidents to the activities director as soon as possible. Traffic accidents must be reported immediately.
- . No person or employee, including administration, shall authorize or permit a district owned vehicle to be driven by any other person who has not been authorized to do so under the procedures set forth above.

If there is the possibility of inclement weather on the return trip, the coach/sponsor is required to call State Troopers, Dept. of Transportation, or other appropriate authority to determine the safety of road and travel conditions. When a determination has been made to return, and an anticipated arrival time has been established, the coach/sponsor will call the Superintendent with the information.

The Superintendent will be responsible for disseminating that information to parents and other interested parties.

All student groups K-12 must be able to return to their school of origin by midnight (exceptions may be made for activities held in Glennallen with prior approval from the activities director.) If the driver determines this is not possible, then the groups are to spend the night in the school or community. The only exception to this is

when the ferry is needed, but once the group is on land this rule is again in effect. Also, when staying the night for an activity, the driver is not to travel before 6 am the following morning.

In Town Travel:

Any class or group desiring to travel in town must submit a plan for the travel to building administration for approval. Parents may transport their own child(ren) to any in town school activity.

In State Travel:

Any in state (out of town) travel for grades K-8 (except for scheduled athletic/co-curricular events) must be submitted on District forms and approved at the building, District and school board level.

Out of State/Country Travel:

All out of state/country travel for any activity must be submitted on District forms and approved at the building, District and School Board level.

Winter Travel Guidelines:

The identification of temperatures will be solely based upon the information received from the most reliable weather reporting service available at the time of travel, and must include not only the start and end points of the trip, but established points along the route.

Students traveling by ground transportation during the winter period must have the following in their possession: winter hat, winter coat, gloves, snow pants, boots, and winter sleeping bag.

The coach/sponsor is responsible to ensure students wear appropriate clothing during the activity travel.

Students are not to be transported by ground transportation outside the District when conditions along the proposed route of travel are predicted to include extreme winds, ice, severely reduced visibility, dangerously low temperatures, or a combination thereof deemed to have a risk outweighing the benefits of the proposed travel to students. At no point shall students be transported if the predicted temperatures at any point along the route are -40°F or colder. Questionable conditions shall be analyzed by the Superintendent, or the Superintendent's designee, for final determination.

SUBJECT: Fifth Grade Field Trip to Cordova

This is a request for the board to approve the fifth-grade field trip to Cordova in May.

The field trip will include attending the birding festival, along with other planned educational activities. Below us a synopsis of part of the activity.

“Four remote Alaskan schools, all nestled in the bounds of the Chugach National Forest yet scattered around the shore of Prince William Sound, will have the opportunity to meet in Cordova to witness the largest migration of shorebirds in the western hemisphere. Using the shorebird migration as a backdrop, students will explore the public lands that they rely on while gaining a deeper understanding of the connections between shared resources, ecosystem services, and their communities.

The Prince William Sound Science Center (PWSSC) will bring students from across the Sound to Cordova during the annual shorebird migration to witness the unique natural phenomenon and learn about the importance of the CNF. Students will spend two days meeting with their peers and engaging with PWSSC scientists, USFS personnel, and tribal representatives. Students will participate in research projects, complete stewardship activities, and have positive outdoor experiences. Before students travel, PWSSC will lead remote lessons on shorebird migration. During the trip, students will learn how to use binoculars, identify migrating shorebirds, and participate in a long-term shorebird research project. Students will observe banding and sampling procedures and engage with scientists. Students will meet with USFS wildlife technicians about the dusky Canada goose Nest Island Monitoring Program, participate in a mock nest search, and revegetate nest islands. Students will learn how indigenous knowledge contributes to our collective ecosystem knowledge through a cultural lesson and dance with the Chugach Regional Resources Commission. Students will also hike, play, and nature journal. Post-trip, students will reflect on the significance of CNF through writing. Poems and pages from their nature journals will be bound into a booklet shared amongst participating schools.”

The cost will be nominal due to student and parent fundraising. Amanda Tippetts has volunteered to be the school sponsor. Superintendent Jason Weber and I (Krista Howell) have met with the parents, and they understand that the trip will follow all school rules and standards. The school district will handle book payments, and fundraising monies are deposited in an appropriate school account.

Recommendation: As building principal, my recommendation is to approve this trip in accordance with BP 3541.1

This letter is in response to your request dated November 17, 2025 to waive the provisions in AS 14.03.030 that a school term include at least 170 student days and 180 total days in session. You are requesting to operate a four-day school week for grades 6-12 during the 2026-2027 school year. The request states that school will be in session Monday through Thursday for 6.5 hours, excluding intermissions, for a total of 140 days (913.3 hours). This meets the minimum hourly requirement of subsection (3) of AS 14.03.030 which is 900 hours per school year. School calendars for grades K-5 remain unchanged.
