Texas statute requires every district to publish a report on violent or criminal incidents at their schools. This report is available on the MVISD website for use and review by the public. The content of the report reflects the requirements in *Texas Education Code Chapter 39*. To the extent possible and as permitted under the Family Education Rights and Privacy Act of 1974 (20 U.S.C. Section 1232g), information was obtained from the PEIMS 2017-2018 Summer Collection resubmission report. Specific Disciplinary Reason Codes are defined by the Unsafe Schools Criteria from the *Safe and Drug-Free Schools and Communities Act (SDFSCA)* of 1994 (20 U.S.C. Section 7101 et seq.).

Castroville, LaCoste and Potranco Elementary campuses had no violent or criminal incidents.

Medina Valley Middle School and Medina Valley High School had no violent or criminal incidents.

Information concerning school violence prevention and violence intervention policies and procedures that the district is using to protect students are outline in the Student Code of Conduct and the Student Handbook. Additionally, during the Annual Parent District Meeting, the parents, faculty, staff and community have an opportunity to review the findings that result from evaluations conducted under the *Safe and Drug-Free Schools and Communities Act (SDFSCA)* of 1994 (20 U.S.C. Section 7101 et seq.). Moreover, MVISD's Safe and Drug-Free Schools and Communities District Program is reviewed annually at the Annual Parent District Meeting. All these documents are available to all constituents either in hardcopy or electronic format.

## **Report of 2015-2016 High School Graduates' Enrollment and Academic Performance in Texas Public Higher Education in FY 2017**

Texas statute requires every school district to include, with their performance report, information received under Texas Education Code §51.403(e). This information, provided to districts from the Texas Higher Education Coordinating Board (THECB), reports on student performance in postsecondary institutions during the first year enrolled after graduation from high school.

Student performance is measured by the Grade Point Average (GPA) earned by 2015-2016 high school graduates who attended public four-year and two-year higher education in FY 2017. The data is presented alphabetically for each county, school district and high school. The bookmarks can be used to select the first letter of a county. Then the user can scroll down to the desired county, school district and high school.

For each student, the grade points and college-level semester credit hours earned by a student in fall 2016, spring 2017, and summer 2017 are added together and averaged to determine the GPA. These GPAs are accumulated in a range of five categories from < 2.0 to > 3.5. If a GPA could not be calculated for some reason, that student is placed in the "Unknown" column. GPA data is only available for students attending public higher education institutions in Texas. If a high school has fewer than five students attending four-year or two-year public higher education institutions, the number of students is shown but no GPA breakout is given. If a student attended both a four-year and a two-year institution in FY 2017, the student's GPA is shown in the type of institution where the most semester credit hours were earned.

The number of students located at Texas independent institutions is presented. Also shown are "not trackable" graduates, those with non-standard ID numbers that cannot be used to match student identifiers at Texas higher education institutions. "Not found" graduates have standard ID numbers but were not located in FY 2017 at Texas higher education institutions. They might have enrolled in higher education outside of Texas.

No data is given for high schools with 25 or fewer graduates.

Because the statute calls for data on the first year enrolled after graduation, the level of the institution attended by students in this report may not match that given in THECB's high school to college report at <http://www.txhighereddata.org/Interactive/HSCollLink>. That report shows where students attended in the fall semester after their high school graduation year. This report attributes students to the level of institution where they earned the most semester credit hours during the whole academic year, not just the fall semester.

**Please note:** In May 2012 the 2006-2007, 2007-2008, and 2008-2009 versions of the *Report of High School Graduates' Enrollment and Academic Performance in Texas Public Higher Education* were updated to reflect a minor correction in how the GPA data are distributed across ranges.

Overall 19.69% increase of site traffic over the previous year. This includes both new and returning users. Visits made from the MVISD School network (Student & Staff Computers) is not included in this calculation.



9.85% of the 19.69% were new users to the site. Generally this means that more people are returning to our site after visiting once. This can be attributed to reliably updated information.



Mobile traffic has increased by 8.00% over the previous year. Currently, the majority of our site traffic comes from mobile devices 53.3% but a large amount of people are still accessing via desktop/laptop computer.

## Summary

The websites continue to see growth in both returning user traffic and time spent on each page. An increasing number individuals are accessing the website from their mobile devices. All campus subsites are now updated with the help of campus administration and/or a designee. The intention is to continue to increase traffic by providing consistently updated content.

The district Facebook page has 3,390 Likes and 3,532 follows. We had 7,504 post interactions over the past 90 days, thanks in large part to the Victory Lane Sign post. The VLS post reached over 9,000 people and received 4,000 clicks. This was our most popular Facebook post during this period.



The district Twitter account has 821 followers. Posts to the twitter account received 44,200 impressions over the previous 90 days. Twitter defines impressions as the combined number of times any user saw our post on twitter. The Victory Lane Sign post was the most popular post on twitter during this period with 1,240 impressions.



The district instagram account currently has 1,229 followers. Our top post on this platform was also the Victory Lane sign post with 788 impressions.



The district mobile app which was launched at the start of the 90 day period currently has 1,210 installs. This amounts to an average of 13 installs per day. The majority of the installs are on iOS (Apple Devices).

## Summary

MVISD continues to expand its mobile reach. It is important to keep in mind that although all three platforms saw the same top post during the last period, each platform reaches a different demographic. Generally speaking, Facebook reaches an older crowd, Twitter reaches a younger crowd and Instagram is a mix. Each campus now has a dedicated Facebook and Twitter account that is administered by the Webmaster/Social Media Specialist but updated by a campus designee. The ultimate goal is to provide more content for each platform to increase impressions and engagement.

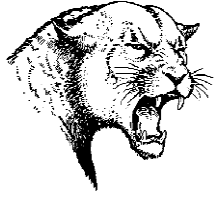

## **Services to Students with Autism**

Medina Valley ISD is currently part of a consortium of districts who have received a TEA grant referred to as the *Services to Students with Autism Grant*. The districts include: Northside ISD, Cotulla ISD, Dilley ISD, Fort Sam Houston ISD, Pearsall ISD, Randolph ISD and San Antonio ISD.

Currently, the *Services to Students with Autism* program serves students who are enrolled Early Childhood Classrooms (i.e. Preschool Program for Children with Disabilities- PPCD) through the Kindergarten grade level. The program is focused on aiding schools to implement research-based best practices for students with autism, including significant opportunities for inclusion and appropriate interaction with non-disabled peers.

The grant consortium intends to apply for renewal of this grant for the 2019-2020 school year, and to expand services to students with Autism ages 9 and under. The grant will fund professional development and material resources to provide intensive, research-based interventions to students with Autism ages 3-9. Family involvement will be a key factor in implementation, and incidental benefits would be seen by non-participating students served in the same classrooms as participating students.

The TEA requires the board to Authorize the Superintendent to sign a shared services agreement prior to the submission of the application. The purpose of the shared services agreement is to formalize and clarify the relationship among school districts participating in the TEA *Services to Students with Autism* Grant.

Northside ISD shall administer the *Services for Students with Autism*. Northside ISD will arrange for logistical support for *Services for Students with Autism* consortium activities.
