The OFSDP is a program, authorized under the Texas Education Code (TEC), §29.0822 and 19 Texas Administrative Code (TAC), §129.1027 that your school district (district) or open-enrollment charter school (charter school) may offer to provide flexible hours and days of attendance for students in any grade who meet one of the following criteria:

- the student is at risk of dropping out of school, as defined by the TEC, §29.081;
- the student, as a result of attendance requirements under the TEC, §25.092, will be denied credit for one or more classes in which the student has been enrolled;
- the student is attending a campus with an approved early college high school program designation;
- the student is attending a campus implementing an approved innovative campus plan; or
- the student is attending a community-based dropout recovery education program, as defined by TEC, §29.081 (e-1) or (e-2).

The goal of the program is to improve graduation rates for students who are in danger of dropping out of school, have dropped out, or who are behind in core subject courses.

- 4 employees – 1 Lead Teacher, 2 Classroom Teachers, and , 1 Support Staff,
- Curriculum – Blend of online through Edgenuity and teacher development materials

## Student Demographics

197 students enrolled during the 2019-2020 school term

- 50 actively enrolled
  - 16 Females (32%); 34 Males (68%) (For the first 2 years, - 79% Male and 21% Female)
- 34 students completed summer school and returned to LVHS in fall 2019
- 90 Graduates(+22)
- 19 drop-outs recovered (+ 3 from 2018-19)
- 28 enrolled in Optional Flexible School Day Program (OFSDP) (+ 16 from 2018-19)
- 2 currently enrolled in work program
- ❖ 96% (118) are identified at or below poverty line
  - Ethnic Diversity mirrors HS 24% Hispanic; 22% African American; 24% White; 2% Two or more
- 100% students are at-risk in two or more categories
  - 22% Parent or pregnant (+4%)
  - 96% lost 4 or more credits prior to enrolling at Success Academy (0 change)
  - 48% are overage or behind 9<sup>th</sup> Cohort (+4%)
  - 34% had previous Alternative Disciplinary placement (--4%)
  - 64% reported truant (+6%)
  - 38% Parole or probation (+8%)
  - 69% Did not meet End-of-Course standard (-6%)

## Curricular Expectations

- Students are expected to earn ½ credit for every 7-10 school days.
  - 441 one-half credits have been earned to date.
- Successful passing of End-of-Course exams (Algebra, Biology, English 1, English II, and US History)
  - 11 students passed exams in December of 2019.
  - 35 had significant gains in scores from July 2019 to Dec 2019
- Students participate in virtual labs, manipulatives, video tutorials, activities, to aid in retention of content.
