Background Information:

LVISD POLICY BED (LOCAL) -- Public Participation: At regular meetings the Board shall allot 30 minutes to hear persons who desire to make comments to the Board. Persons who wish to participate in this portion of the meeting shall sign up with the presiding officer or designee before the meeting begins and shall indicate the topic about which they wish to speak.

Limit on Participation: Audience participation is limited to the portion of the meeting designated for that purpose. At all other times during a Board meeting, the audience shall not enter into discussion or debate on matters being considered by the Board, unless recognized by the presiding officer. No presentation shall exceed five (5) minutes. Delegations of more than five persons shall appoint one person to present their views before the Board.

Board's Response—Specific factual information or recitation of existing policy may be furnished in response to inquiries, but the Board shall not deliberate or decide regarding any subject that is not included on the agenda posted with notice of the meeting.

Complaints and Concerns—Complaints and concerns for which other resolution channels are provided shall be directed through those channels. The presiding officer or designee shall determine whether a person who wishes to address the Board has attempted to solve a matter administratively. If not, the person shall be directed to the appropriate policy to seek resolution before bringing the matter to the Board at a subsequent meeting.

**RESOLUTION OF THE BOARD OF TRUSTEES OF
THE LA VEGA INDEPENDENT SCHOOL DISTRICT
TO PROVIDE RETENTION INCENTIVES**

WHEREAS, the educators and employees of the La Vega Independent School District (“the District”) have demonstrably gone above and beyond their duties and responsibilities in providing learning opportunities to students in a safe environment;

WHEREAS, the District is competing for the most talented and experienced educators and staff;

WHEREAS, there is a public purpose served and a benefit to the District to seek to retain employees and increase morale;

WHEREAS, the La Vega ISD Board of Trustees wishes to provide a one-time incentive and retention payment to employees employed by the District as outlined below, to thank them for their continued service and dedication to the students and school community, to enhance employee morale, and to encourage employees to stay with the District;

IT IS, THEREFORE, RESOLVED THAT:

1. The Board of Trustees finds that a public purpose and a benefit to La Vega ISD exists to make a one-time payment to qualified employees;
2. The Board finds that a public purpose and a benefit to La Vega ISD exists in the payment of this one-time incentive and retention payment, as set forth in this Resolution; and
3. The Board establishes the Criteria to Receive Payment as follows:
 - a. **\$650:** To receive the full amount of the stipend, you must be employed as a full-time employee by October 1st of the current school year and remain employed the first semester. Those that are employed as a full-time employee by October 1st of the current school year, complete the first semester, and **retire** at the end of the semester will receive half of the amount of the stipend. Those that **resign or are terminated from** their position at the conclusion of the first semester will forfeit their stipend. The amount of the stipend is determined by District Administration and the Board of Trustees. Part-time employee amounts are pro-rated based on their percentage of day/time employed.
 - b. **Additional \$350** will be added to each employee that was employed during the 2023-2024 as a retention component. Those employees whose employment date began after the beginning of the second semester (Jan 8, 2024) for 2023-2024 will be paid half. Part-time employee amounts are pro-rated based on their percentage of day/time employed.
 - c. **Employment after October 1st but before December 1st in a full-time role:** to be paid \$100 for each month employed through the end of the semester (*i.e.* – Employment began 10/04/2024, employee receives \$300, Employment began 11/10/2023, employee receives \$200, etc.).

3. Employees have no property right in the continuation of any such incentive and retention payment in future years. The incentive and retention payment is not Teacher Retirement System eligible compensation. Federal Income Tax and Medicare tax (if applicable) will be withheld from the gross amount. An individual employee is only eligible for one incentive payment.
