BACKGROUND INFORMATION

Ms. Katisha Dukes has filed a Level III Grievance on behalf of her PHS student, expressing disagreement with the Level II decision issued by Hearing Officer Lisa Patterson. The grievance concerns the request for the removal of a staff member from their position, which was not granted at Level II.

Following district policy, the Human Resources department conducted an investigation into the incident that involved the student and the staff member. The findings were reviewed by the hearing officer, who determined that the requested resolution was not warranted.

At the Level III grievance hearing, both the Student Affairs Department and Ms. Dukes will present their respective positions regarding the grievance and requested remedy. The district will continue to follow established grievance procedures to ensure a fair and thorough review process.
