3.B.3. TVEC Recognition

Jeff Elliott recognized the sophomore students in the TN Valley Early College. Dr. Deborah King, Vice President of Academic Affairs at Cleveland State Community College, attended the meeting. These second year students will attend Cleveland State next year. Autumn O'Bryan stated that these students have taken the ACT and have 12 college credits now. She thanked Anita Adkins and Caitlin DeLoach for their work on this project. Students Riya Patel, Jannat Saeed, and Zach Turner shared their experiences with TVEC.

3.B.4. Environmental Essay Contest Winners

Dr. Kristene Wood with Bradley Cleveland Keep America Beautiful recognized the Environmental Essay Contest winners from Cleveland High School Jared Berchfield, Analise Bilbao, and Lauren Proctor. Teacher Jeannie Cuervo thanked Keep America Beautiful for this opportunity. All three students chose to write about the importance of environmental education and interviewed local environmental educators.

3.C. *Organizational Review Report

Dr. Dyer introduced Byron Headrick of LEANFrog. They are doing an organizational study for CCS. Mr. Headrick shared an initial report:

They completed the initial phase of the Organizational Review which is the leadership portion. Job Analysis Questionnaires were completed by employees and analyzed by the company. The team compared CCS with other school systems. CCS ranked sixth out of eight in ratio of students per teacher and third out of eight on ratio of students per other employees which is good for school systems in our area.

Mr. Headrick discussed span of control analysis and the current linear organizational structure.

He proposes an organizational model which is program based with an academic, operational, and organizational tier. He recommends a Chief Academic Officer which will begin the transition to this program based model. He also proposes an Operations Supervisor to assist Hal Taylor in Operations.

Board members asked questions on the organization models. Mr. Headrick will make recommendations on positions and titles in the coming weeks. Working with the leadership team, he will create a road map for the next two years.

Dr. Dyer provided recommendations for updating the curent organizational structure. This includes changing Jeff Elliott's title to Chief Academic Officer/Assistant Director, changing Kelly Kiser's title to Secondary Education and Federal Funds Supervisor, promoting ESL Specialist to ESL Supervisor, changing Special Populations to Supervisor instead of Director. Jobs will be posted for Director of HR, Supervisor of School Nutrition, Operations Supervisor, Student Support Specialist, and Coordinated School Health. Positions are open due to resignations and retirements; the only new

position is Operations Supervisor which was funded with the 2018-2019 budget. Board members questioned positions and organizational structure.

3.D. *General Cleaning Services Contract

The lowest bid was \$947,292 by SMS, Southern Management Services headquartered in Nashville. The committee was Hal Taylor, Richelle Shelton, Leneda Laing, David Turner, Cindy Geren, Steve Morgan, and Dr. Dyer. They checked references for the companies, and SMS provided a presentation to the committee. Dr. Dyer said that the committee did their research and the RFP was thorough. He recommends accepting bid. Steve Morgan said that the presentation was professional and all their questions were answered. He was impressed. Josh Helton and David Hemelright with SMS answered questions.

3.E. *First Reading of Policy 3.500 Food Service Management

Dr. Dyer reported that the change in this policy addresses charging meals in the school cafeterias. CHS will not participate in the Community Eligibility Program next year; all elementary schools and middle school will still

participate in the CEP free lunch. The economy of Cleveland is better than when the CEP policy was approved three years ago. This policy allows for three meal charges. Susan Miller explained the options available for parents to track meals and make payments. She stated that procedures will be created for this policy. Board members asked questions on free/reduced lunch practices.

3.I. Site Committee

3.I.1. Reroofing Bid Update

Hal Taylor, Director of Operations, reported that the five year capital plan states reroofing the south wing of Arnold and remainder of Blythe-Bower. There was a problem with the decking at Arnold, so that has doubled the price of Arnold. Three contractors bid on the project. The lowest bid is C. M. Henley Company, LLC / dba Rackley Company East TN for \$201,080. This did not leave enough to do both projects from sales tax fund. We will do the Arnold roof at \$201,080 this summer. Brian Templeton emphasized the historical significance of the school when meeting with the roofer.

3.I.2. Candy's Creek Cherokee Elementary School Update

Hal Taylor provided an update:

Block work is winding down.

Brick has started on one end of the school.

Roof tresses have been set on half of building.

Decking is going up on first wing and starting on some other areas.

Gym roof is on and painting is starting.
