The Community Engagement Committee is a link between the Hastings School District and the ISD200 community. The committee focuses on identifying avenues to continuously improve the district's communication process for increased transparency. It also aims to more effectively articulate the district's goals with community stakeholders. The committee seeks opportunities for shared learning, knowledge, awareness, experience, and growth in order to create a stronger, more united community.
